That consideration is given to extending the eligibility criteria to include: <ol style="list-style-type: none"> i. young adults (up to the age of 24 years) with Education, Health and Care Plans (EHCPs); and ii. care leavers. 3. That further work be undertaken to ensure that the initiative aligns with the 'cost-of-living' workstream and neighbourhood agenda and ward priorities. 4. That as part of the planned Rothercard annual review, consideration be given to: <ol style="list-style-type: none"> i. the number of disabled people participating in the scheme and if extending the eligibility criteria could encourage more disabled people to apply; and ii. the feasibility of increasing the level of discount on garden waste collections.
