The removal of the maximum charge for non-residential care, while maintaining the minimum charge of £1. Recommended. 2. The introduction of an administrative charge for organising care for people who fund their own care. Recommended. 3. The inclusion of all disability benefits when carrying out non-residential financial assessments for services. Not Recommended.

Recommend to Council that the Council Plan 2025-30 be approved. 2. Agree the Year Ahead Delivery Plan for 2025-26. 3. Note that future progress reports will be presented to Cabinet in January and July 2026. <p>Further actions that arose from discussions were that:</p> <ul style="list-style-type: none"> • OSMB requested a schedule of when bins were emptied in each ward of the authority, including details of how many times those bins have been missed and why they've been missed. • OSMB requested that consideration be given to widening the consultation process for future significant projects: <ul style="list-style-type: none"> ○ A suggestion to consider utilising members in their ward capacity to support consultations. ○ Another suggestion to consider was the collection of consultees postcodes to give an indication of which area of the borough they were from.
