#### 3. WHO IS YOUR NEIGHBOUR? PROJECT

The Rotherham SACRE welcomed Regina Drabble, Development Worker for the "Who Is Your Neighbour?" project, who described the function and purpose of this project which began in January 2010 and operates in all four of the local authority areas of South Yorkshire.

The project works to help communities live more successfully with difference and be more resilient in dealing with divisions created by those who see a difference as a threat. Using 'divisive narratives', the stories which cause damage in communities by scapegoating or blaming particular groups of people, this project:-

- (i) holds safe space conversations about difficult things where people are able to be honest and say things that "you are not allowed to say"; conversations in which there is also space for reflection and challenge. These conversations can help people rethink their own opinions and be more open to the beliefs and opinions of others. They can provide a solid foundation on which to build relationships with people who are different and have different beliefs and values; and
- (ii) is also interested in how people can put forward 'alternative narratives', stories about difficult issues that don't scapegoat or target particular groups but which do recognise that the reality can be complicated.

The project has an administrative base in Sheffield and its Management Committee members are active in community and faith groups in different areas of South Yorkshire. The group of safe space dialogue facilitators are all experienced and skilled in facilitating difficult conversations. The project relies on receiving invitations to help with communities and has worked with churches, schools and with women-only groups.

The "Who Is Your Neighbour?" project receives funding from the Paul Hamlyn Foundation and from the Tudor Trust and is funded for a further two years. The project may apply for a REward grant in the future.

The Rotherham SACRE thanked Regina Drabble for her very informative report.

#### 4. COLLECTIVE WORSHIP AND DETERMINATION UPDATE

Further to Minute No. 44 of the meeting of the Rotherham SACRE held on 13th February, 2014, the following members reported on the Determinations in respect of the Collective Worship at the primary schools listed below:-

(1) Broom Valley Community Primary School – April 2014 (Gail Atkin)

The Head Teacher had presented the Assembly, which had drawn on a

range of faiths as well as utilising varied bible studies.

(2) Thornhill Primary School – June 2014 (Tricia Williams-Brown)

An impressive folder of information had been prepared in advance of the assessment. A whole school assembly had taken place, which was not overtly religious and had been led by the Deputy Head Teacher as the Head Teacher had accompanied a number of pupils on an out-of-school visit. Although there were some nerves apparent amongst pupils, the theme had been about values and pride in achievements. The future emphasis would be upon the development of social and moral values.

(3) St. Ann's Junior and Infant School – June 2014 (Charlie Wells)

The pupils had been extremely respectful in this primary school which has a fluctuating, sometimes transient pupil population. There are a variety of faiths represented amongst the whole school population. There had been a large attendance at the School Assembly. The theme had been "rights, respecting, school" based on the United Nations charter rights of the child. Every child who wished to speak during the Assembly had been given the opportunity and the theme of the Assembly had been continued in individual classrooms.

The Rotherham SACRE agreed that, at the beginning of the 2014/2015 academic year, all schools should be invited to apply for a Determination. The involvement of pupils and the expression of the 'students voices' was considered to be an essential aspect of the process.

Resolved:- That the applications for Determination from the requirement that Collective Worship be 'mainly, broadly Christian' in character, in respect of all three of the above primary schools, be approved.

The Assembly reflected an integral part of the ethos and the needs of the children in their overall development.

The children were involved throughout answering questions. A good cross-section of the children took part and gave an answer. Furthermore, the children's behaviour was impeccable.

The Rotherham SACRE are happy to accept your case for multi-faith Collective Worship and grant you a Determination from the requirement that Collective Worship be 'mainly, broadly Christian'.

The Determination does not take away the requirement for collective worship that should have a 'spiritual' character so that at least some of the assemblies should offer children the opportunity to pray, reflect or be silent for a little while according to their choice.

If still relevant for your School community, you will need to apply again for a Determination in 2017.

### Rotherham Standing Advisory Council for Religious Education - Collective Worship

Since the publication of the Rotherham Local Agreed Syllabus for Religious Education in 2011, one of Rotherham's Standing Advisory Council for Religious Education's (SACRE) priorities has been to focus on Collective Worship. SACRE have now produced a guidance document to accompany the Agreed Syllabus offering support with Collective Worship. Please find enclosed a copy of this document for your use.

The requirements of the Education Acts (1944; 1988; 1993) states that a daily act of Collective Worship should be followed that is 'wholly or mainly of a broadly Christian Character'.

If you wish to withdraw your School from the legal requirement to deliver Collective Worship of 'broadly a Christian character', you should write directly to Hannah Etheridge, Clerk of SACRE, (hannah.etheridge@rotherham.gov.uk) to request this and outlining the reasons why it is necessary for your School. SACRE will then consider your request and conduct a visit to decide whether a 'Determination' should be granted for your School.

A Determination does not take away the requirement for collective worship that should have a 'spiritual' character so that at least some assemblies should offer children the opportunity to pray, reflect or be silent for a little while according to their choice.
