4. MINUTES OF THE PREVIOUS MEETING HELD ON 3RD MARCH, 2014

Consideration was given to the minutes of the previous meeting held on 3rd March, 2014. The minutes were approved as a correct record.

6. TOWNSCAPE HERITAGE INITIATIVE GRANT

Further to Minute No. 4 of the meeting held on 29th October, 2012, Members considered an application for a grant under the Rotherham Townscape Heritage Initiative Scheme, for improvements to the Three Cranes building, a Listed Grade II* property at High Street, Rotherham.

The award of grant funding would enable the building to be repaired and made safe. In addition, the building's architectural features would be reinstated so that it could both be returned to a useable condition and become an historical asset to the Rotherham town centre. Members noted the probable future use of the building.

Members viewed drawings and plans of the proposed improvements to this building, as presented by the project's Architect.

Reference to this scheme had previously been made in a report to Cabinet (Minute No. 135 of the meeting held on 27th November 2013 refers).

Discussion took place on the benefits to the Rotherham town centre from the improvements being made to the appearance and structure of various buildings at High Street and the investment was welcomed. Reference was also made to the proposed public realm improvements scheduled to be made to High Street.
