



Summary

Following the Council's resolution in respect of Rotherham Fire Station on 24 January 2018, the Chair of the Overview and Scrutiny Management Board has invited the Chief Fire Officer, Mr. James Courtney, to attend this meeting to provide information in respect of the reasons supporting the decision taken by the Fire and Rescue Authority in 2013 to change the operational staffing of the second fire engine at Rotherham Fire Station.

Operation of Second Fire Engine at Rotherham Fire Station

1. Recommendations

- 1.1 That Overview and Scrutiny Management Board receive the Chief Fire Officer, Deputy Chief Fire Officer and Vice-Chair of the South Yorkshire Fire and Rescue Authority.
- 1.2 That consideration be given to any proposed recommendations to South Yorkshire Fire and Rescue Authority arising from the information and ensuing discussion in respect of the second fire engine at Rotherham Fire Station.

2. Background

- 2.1 This report is submitted to provide context to the issues to be discussed at the meeting and assist with the procedure for the meeting.
- 2.2 On 23 November 2013, South Yorkshire Fire and Rescue Authority approved the Integrated Risk Management Plan which proposed a change to the staffing of the second fire engine at Rotherham Fire Station. The effect of the change was that the second fire engine would remain permanently available in the day, but would become 'on call' at night by the end of March 2017. A copy of the report which recommended the decision is enclosed at Appendix 1. The minutes of the Council Seminar held during the consultation in 2013 is enclosed at Appendix 2.
- 2.3 South Yorkshire Fire and Rescue Service's (SYFRS) Operational Plan 2013-2017 states that integrated risk management planning plays a key role in identifying, assessing and mitigating risks. It defines its approach "integrated risk management planning" as "... a way of saying that we look at all the risks that we face, or may face, all together instead of one at a time."
- 2.4 On 31 March 2017, the decision taken by the Fire and Rescue Authority in 2013 was implemented. A press release giving notice of the change was published on 8 February 2017 and is enclosed at Appendix 3.
- 2.5 Following receipt of a motion that was debated on 24 January 2018, the Council resolved as follows:-

This Council notes:-

1. That the government has cut funding to South Yorkshire Fire and Rescue Service (SYFRS) by £12.5 million since 2010; a 29% reduction in government funding.
2. That SYFRS expects a further cut of £1.4 million by 2019/20, and that SYFRS is subject to the same unclear policy of business rate retention from 2020 as local councils.
3. That these reductions in funding have resulted in a number of fire stations across the region needing to rely on Close Proximity Crewing and overnight Retained Resilience crews, and that the decision to reduce the staffing on the second appliance at Rotherham Fire Station to 11 hours a day was taken in 2013 following consultation.

4. That the number of accidental house fires in South Yorkshire decreased by 35% between 2001 and 2015, whilst the number of home safety checks delivered by SYFRS between 2006 and 2015 increased nearly tenfold.

This Council believes:-

1. That continued cuts to Fire and Rescue Services across the country puts lives at risk.
2. That prevention is better than a cure, and we welcome the work that SYFRS continues to do to prevent fires and promote fire safety.
3. In order to provide the residents of Rotherham with a safe level of fire cover, fire fighters and equipment, overnight and, reduce the level of risk to fire fighters attending a fire related incident, this Council supports the need to re-instate the second pump together with the required number of fire fighters on the night shift at the fire station in Eastwood when resources allow.
4. That any and all changes to fire services must be based on a robust risk assessment, prioritising the most effective measures to both prevent fires and to save lives.

This Council resolves:-

1. To support SYFRS, the Association of Metropolitan Fire and Rescue Authorities and the Local Government Association in pressing for a fairer funding arrangement for all fire authorities.
- 2.6 The issue debated by the Council on 24 January 2018 has also been the subject of regular questions to Rotherham's designated spokesperson on the South Yorkshire Fire and Rescue Authority at recent Council meetings.
- 2.7 Given the resolution of the Council and the role of scrutiny in voicing issues of concern to the community, the Chair of the Overview and Scrutiny Management Board issued an invitation to the Chief Fire Officer, Mr. James Courtney, to explain the financial context and the approach to integrated risk management planning which informed the decision in 2013 to change the staffing arrangement for the second fire engine located at Rotherham Fire Station.

3. Key Issues

- 3.1 The Chief Fire Officer, Deputy Chief Fire Officer, Mr. Martin Blunden, and the Vice-Chair of the South Yorkshire Fire and Rescue Authority, Councillor Alan Atkin, will be in attendance at the meeting. The Chair will invite them to present information explaining the background to the decision and the impact of its implementation during 2017-18.
- 3.2 Following this, Members will have the opportunity to ask questions of the representatives of the SYFRS and Fire Authority.

- 3.3 Members of the public will not have the opportunity to ask questions during the consideration of this item. However, agenda item 3 provides an opportunity for members of the press or public to ask general questions of the Chair of the Overview and Scrutiny Management Board. If specific questions are submitted, the Chair will arrange for written responses to be provided where contact details of questioners are submitted.

4. Options considered and recommended proposal

- 4.1 The Board has the option to make recommendations to the Fire and Rescue Authority in respect of the matter before it. In doing so, any recommendations should be evidence based to be considered as credible.
- 4.2 The Overview and Scrutiny Management Board may also determine that it is satisfied with the information provided and that no further action should be taken or recommendations made.
- 4.3 The Chair of the Overview and Scrutiny Management Board will write to the Chair of the Fire and Rescue Authority and the Chief Fire Officer within 10 working days of the meeting to confirm the outcome of the Board's deliberations on the subject.

5. Consultation

- 5.1 As the decision was made by the Fire and Rescue Authority in 2013, there is no current consultation associated with the subject matter or this report. Information in respect of consultation in 2013 is included within Appendix 1.

6. Timetable and Accountability for Implementing this Decision

- 6.1 This report is submitted to facilitate Members' scrutiny of the issue and does not recommend any decisions. Members may determine to propose recommendations arising from their deliberations and the information provided.

7. Financial and Procurement Implications

SUMMARY

On 2 September 2013 the Authority decided to reopen formal consultation on its draft Strategic and Operational Plans. This report presents Members with feedback from the second phase of the consultation process and seeks Authority approval for the Plans.

BACKGROUND

1. The context behind the development of the Strategic and Operational Plans was summarised in a report to the Authority on 2 September 2013. The Operational Plan (or Integrated Risk Management Plan, or IRMP) is a statutory document which all Fire and Rescue Authorities are required to have in place. It should describe how the Authority will plan to have the right resources in the right place at the right time, to effectively resolve all the community risks it may be required to respond to. The current South Yorkshire IRMP expires at the end of 2013.
2. In March 2013, the Authority initiated a 13-week consultation period on the broad topics to be considered in these plans. Following receipt of that feedback, draft Plans were submitted to the Authority on 2 September. Members decided to hold an additional six-week consultation on the draft Plans. Subsequent to that decision, the consultation period was extended by a further three weeks to allow additional time for consultation in the Mosborough/Birley Moor area, due to proposed changes to the crewing system for the new Birley Moor fire station. Therefore, in total, 22 weeks' consultation has taken place in 2013 on the development of these Plans.
3. The main elements of the proposals put forward by the Service can be found in paragraph 12 of the 2 September report. Despite expected funding cuts of at least £13 million from 2010-17, these proposals stated an intention to make no further reductions to the number of fire stations or fire rescue pumps through the lifetime of these plans, to protect the initial response to emergency incidents.
4. Should these proposals not be adopted, alternative ways of reducing the Service's operational budget would need to be implemented instead. Due to the scale of the cuts in Government grant, these alternatives would undoubtedly involve closing fire stations, or removing fire appliances, or downgrading crewing arrangements.

CONSULTATION SECOND PHASE

5. During the second phase of consultation, from 2 September to 4 November, a number of different consultation methods were used:
 - Letters were posted to:
 - All South Yorkshire MPs and MEPs.
 - The Police and Crime Commissioner and Chief Constable.
 - Chief Fire Officers of neighbouring Fire and Rescue Services.
 - Yorkshire Ambulance Service.
 - South Yorkshire Local Authority Chief Executives.
 - South Yorkshire Chambers of Commerce.
 - All accredited South Yorkshire Fire and Rescue (SYFR) trade union representatives.
 - All elected officials and bodies in South Yorkshire, including Town and Parish Councils, were invited to feedback via the Section 41 Briefing.
 - Member Briefing sessions were offered to all four South Yorkshire Local Authorities. These took place as follows:
 - 30 September, Sheffield City Council, attended by the Chief Fire Officer.
 - 2 October, Barnsley Council, attended by the Chief Fire Officer.
 - 23 October, Rotherham Council, attended by the Deputy Chief Fire Officer.

- The Doncaster meeting was cancelled but Members received information in their October Section 41 Briefing, and an additional summary sheet later in October.
 - Information was sent to community organisations in South Yorkshire, and 120,000 recipients of the South Yorkshire Pensions Authority newsletter, with opportunities to provide feedback.
 - Additional consultation took place with one BEM group and two Parish Councils in rural areas, in accordance with the recommendations of the 2 September report.
 - Regular media and social media content, and the SYFR website – the relevant website stories were viewed 1,242 times. A selection of the published articles can be viewed in Appendix A.
6. During the second phase of consultation, the following feedback was received:
- Letters from Clive Betts MP, Police and Crime Commissioner, the Mayor of Doncaster and the Fire Brigades Union, and an e-mail from Unison. These can be found in Appendix B.
 - Written feedback from the additional BEM and rural community consultation. This can be found in Appendix C.
 - Responses from 31 people who used our online feedback form and one person who printed off the online form and posted it. These 31 people left 17 comments, which can be found in Appendix D.
7. The feedback received in the second phase of consultation has largely reflected concerns about the Government funding cuts being received by SYFR, and the level to which SYFR would be able to provide emergency cover in the future. However, in line with views previously expressed by Members, the feedback also indicated reluctant acceptance of the proposals being consulted upon, as being better than alternative means of making the necessary savings, such as downgrading fire station crewing, or removing fire appliances.
8. Given the feedback received through the two consultation periods, the need to make a decision before the Authority's existing IRMP expires in December 2013, and the more negative implications of alternative ways to reduce the operational budget, it is recommended that Members approve the Strategic and Operational Plans 2013-17.

CONTRIBUTION TO SERVICE PRIORITIES

- Community - Making people safer – working to prevent emergencies.
- Operations - Responding to emergencies – effectively and safely.
- People - Valuing people – those we serve and employ.
- Finance and Resources - Maximising efficiency – making our resources go further.

CORPORATE RISK ASSESSMENT & BUSINESS CONTINUITY IMPLICATIONS

9. The IRMP is the key document which shows how the Authority will manage, and mitigate community risk. It is a statutory document, and the Authority's existing IRMP expires at the end of December 2013. As this is the last Authority meeting before that expiry date, failure to adopt a new IRMP at this meeting will leave the Authority at risk of not having a current IRMP in place.

10. Additionally, the failure to adopt and begin swift implementation of the Strategic Plan would be likely to have a negative effect on the Authority's ability to keep within the budgets laid out in the Medium Term Financial Plan.
11. There is a risk of judicial review against any changes made by public sector bodies if due process has not been satisfactorily followed. The risks presented by judicial review are financial:
 - Additional costs of defending the case, and
 - Costs of repeating the consultation if the judicial review is lost
12. The risks outlined in paragraph 11 have been mitigated by the fact that the Authority's consultation processes in relation to these Plans satisfy all relevant IRMP guidance, The Gunning Principles, and The Consultation Institute Charter. The processes have also been given positive assurances by internal audit.

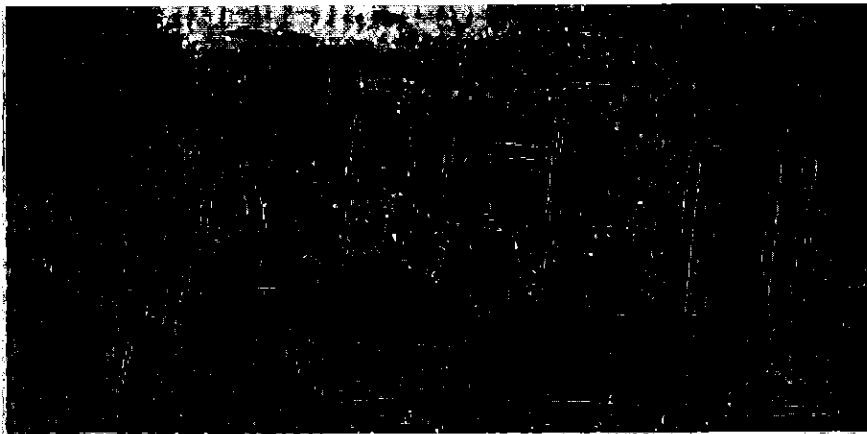

£17 million savings to be found

Fire crews could part time and controversial fire engines replaced under plans for the future of South Yorkshire fire service.

Proposals put forward by fire chiefs would see the second fire engines at Doncaster, Rotherham and Barnsley fire stations manned at night by fire-fighters working on an on-call basis.

And plans have also been revealed to get rid of so-called CARP - combined aerial rescue pumps - fire engines which have been unpopular with crews and originally had to be returned to their manufacturers after

they were brought in by fire chiefs, because they were too heavy for the roads.

South Yorkshire Fire and Rescue Service needs to save £12 million by 2017. The moves could spell the loss of firefighters jobs, but it is hoped job losses would be through staff taking redundancy before, rather than after, the cuts.

Chief fire officer James Courtney said proposed cuts protect the frontline. He said: "Losing 20m is 20 per cent of our funding. It forced us to reconsider our entire frontline provision, but we feel we can still now that we do not have to remove any further fire stations or rescue pumps in the future of this time, which is to the further and better of the service we want."

"We are committed to keeping as many stations

open as possible, to protect the speed of our initial response to incidents."

Bul Graham Wilkinsons, chairman of the Fire Brigades Union in South Yorkshire, said: "Taxpayers are going to be paying more council tax for a poorer service. My biggest concern is about the safety of the public."

It also proposed to replace South Yorkshire's CARP - combined aerial rescue pump - appliances with separate rescue pumps and dedicated aerial appliances.

Mr Courtney said the brigade will continue reporting performance against its response time target of six minutes, despite previously suggesting it could be amended to provide clear indicators to help govern. Many cuts are being targeted.

Fire station night staff set for cuts

THE number of staff working overnight at Barnsley fire station could be cut under proposals by the fire service.

The second fire engine at Barnsley could be manned part time at night to help reduce costs as an alternative to closing fire stations or removing appliances altogether.

The plans, by South Yorkshire Fire and Rescue services, will go before the Fire Authority on Monday.

There are also proposals to scrap the controversial combined aerial rescue pump (CARP) appliances, whose introduction were heavily criticised by the Fire Brigades Union.

The vehicles, which the service said saved £1.25m, were only introduced as an alternative to traditional fire engines in 2011. The move comes as fire chiefs face the likelihood of a further £3m in cuts

by 2017 based on the government's Comprehensive Spending Review, on top of the £8m reduction in budget up to 2015.

James Courtney, chief fire officer, said that a loss in funding had left them with little choice, although he reiterated there were no plans to close any more fire stations.

He said: "Losing £12m, or 20 per cent of our funding, has forced us to reconsider our entire frontline provision, but we feel we can state now that we do not plan to remove any further fire stations or rescue pumps in the lifetime of this plan, subject to the further cuts being of the levels we expect.

"We are committed to keeping as many fire stations open as possible, to protect the speed of our initial response to emergency incidents.

"To be able to achieve this, we are recommend-

ing changes to the way we crew the second pump at most of our two-pump stations.

"This reduces our costs without having to remove fire stations or fire engines."

Another proposal is to scrap the response time of six minutes.

The fire service has not come close to meeting this target since it was introduced in 2008.

But fire deaths and injuries have fallen in the last seven years - from 161 in 2006/07 to 43 in 2012/13.

The number of accidental house fires is also down - from the 2006/07 figure of 280 to 126 as reported last year.

James added: "The clear feedback from the public was that response time targets are irrelevant. People were clear they trust firefighters always to respond to emergencies as quickly as possible."

CUTS: COST-SAVING PLANS GO OUT FOR FURTHER PUBLIC CONSULTATION

Fire crews feel the heat

Fire chiefs have given members of the public another six weeks to have their say on plans to reduce the number of full-time firefighters in the county and to scrap response time targets.

South Yorkshire Fire Authority members discussed the cost-cutting plans yesterday at an extended period of public consultation before making a final response to government cuts.

The money-saving measures put forward by fire chiefs include not replacing retiring firefighters

and replacing some full-time evening calls with part-time firefighters.

A statement issued in response to the proposals would also be scrapped.

Chief Fire Officer James Courtney said: "Losing £12 million - or 20 per cent of our funding - has forced us to re-consider our entire frontline provision, but we feel we can state now that we do not plan to remove any further fire stations or rescue pumps in the lifetime of this plan, subject to the further cuts being of the levels we expect."

"We are committed to keeping as many fire stations open as possible to protect the lives of our community against a major fire incident. To be able to achieve this, we are recommending changes to the way we crew

the second pump at most of our fire stations. This reduces our costs without having to remove fire stations or fire engines."

"These plans have been developed following a 18-week public consultation period earlier this year. The Authority has decided to put these specific proposals out for a further six-week consultation before making final decisions in November."

The Fire Brigades Union said: "Firefighters are not happy."

EMERGENCY: MORE VIEWS SOUGHT ON FIRE SERVICE BUDGET CUT PROPOSALS

Fire deadline extended

A public consultation over plans to scrap current 999 response times and staff some fire stations part-time has been extended by the fire service.

South Yorkshire residents are being asked to have their say on plans drawn up by fire chiefs in response to government budget cuts.

The proposals include

staffing the county's main fire stations in Rotherham, Barnsley and Doncaster part-time at night.

They also include staffing the new station at Dinningley part-time and replacing Combined Aerial Rescue Pumps with separate rescue pumps and dedicated aerial appliances.

The service is also suggesting scrapping its current 999 response time of six minutes after it revealed it had never met its target of reaching 80 per cent of life-threatening incidents within

six minutes.

Chief fire officer James Courtney said: "We want to give people even longer to tell us what they think of the draft proposals their opinions have helped shape."


"People's clear initial feedback has been that we must protect the frontline as far as possible and, despite losing £12 million, that's what these plans seek to do."



The documents pledge not to remove any further fire stations or rescue pumps (fire engines), despite further Government funding cuts which are planned for the Service, up to 2017. Instead, senior officers are recommending an alternative way to reduce costs, by making changes to crewing arrangements instead of removing stations or pumps.



The further six-week consultation period runs from Monday 2nd September to Monday 14th October, with the officers' proposals having already been shaped by feedback from the initial 13-week consultation period earlier in 2013.

Operational Plan - changes to Birley Moor crewing

16 October 2013

The new station at Birley Moor, which was going to be crewed 24/7, will now be staffed by part-time firefighters.

We had originally planned for this station to be staffed using a system called 'Close Proximity Crewing', which would have enabled us to provide 24/7 cover at a much reduced cost and increase our fire cover in this area of Sheffield above what is currently provided by the retained station at Mosborough. Unfortunately we have been unable to progress with CPC, and cover in this area will be maintained as retained, or 'part-time', from the new Birley Moor station as a result.




Even accounting for this change, the new fire station at the junction of Moor Valley and Birley Lane will provide emergency cover to many more homes than the existing part-time fire station at Mosborough, which will close.

The table below shows how many homes will be covered by the new Birley station, versus the existing Mosborough fire station, for retained response times of six, eight and 10 minutes. It shows the new station will provide cover for more than double the number of homes.



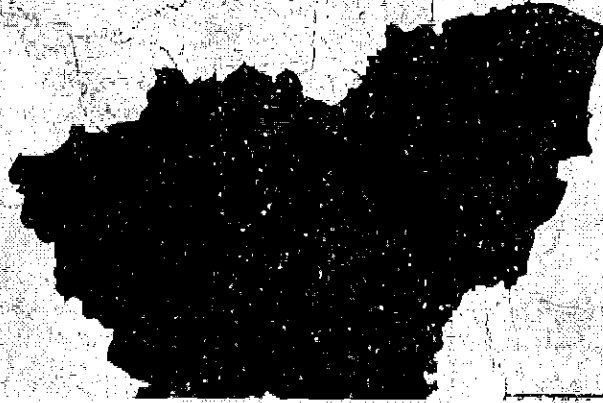



Consultation period extended

There are three more weeks for you to have your say on IRMP 2013/17 proposals, after the original consultation period had been due to end this week.

The plans pledge not to remove any more fire stations and appliances in spite of further Government funding cuts, but the consultation period has been extended to give you more time to give your views.

The draft documents, already shaped by a 13-week consultation period earlier this year, include changing crewing arrangements and replacing CARP vehicles with rescue pumps and dedicated aerial appliances.

The first round of Government cuts will have reduced the Service's budget from £60m in 2011 to under £51m in 2015. These cuts led to the Fire Authority deciding last year to remove five pumps and close stations at Royslon, Darnall, Mansfield Road and Mosborough, whilst opening new stations at the Parkway and Birley Moor.

But despite the likelihood of a further £3m in cuts by 2017, senior officers are recommending that the Authority makes no further removals of stations or pumps, in the draft plan for 2013-17.

Chief Fire Officer James Courtney said, "We have consulted extensively with staff and the public in the development of this plan, but we want to give people even longer to tell us what they think of the draft proposals their opinions have helped shape.

"People's clear initial feedback has been that we must protect the frontline as far as possible and, despite losing £12 million from our budget, that's what these plans seek to do."

The key frontline changes being proposed to the Authority are:

- The second rescue pumps based at Parkway, and the main fire stations in Barnsley, Rotherham and Doncaster, will at night-time revert to a part-time

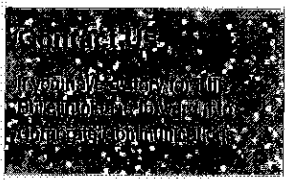

Dear Jamie

I am following up the report which you have recently produced on the review of Sheffield's emergency cover and in particular changes that are now proposed which make the report different from the original which you consulted on.

The fundamental change affecting my Constituency is that the new Birley station will now be a retained station not a station with close proximity crewing. I think that is a significant change and I would be grateful if you could spell out the implications for my constituents arising from that.

My understanding was, when I previously wrote to you, that with the amalgamation of Darnall and Mansfield Road for a new station on the Parkway and the move of the Mosborough station to a new station at Birley the response times to my constituents would be either the same or in different locations marginally better or marginally worse. In essence the arguments of your proposals was that you could continue to deliver appropriate response times with two stations rather than the current three.

Looking now, however, at your latest proposals and the intention that Birley should be a retained station that must have an impact on the previous information you gave me about response times. I simply do not believe now that the previous commitment to broadly maintaining existing response times can be achieved with only one full time station on the Parkway and a retained station at Birley. Could you therefore area by area provide for me now a break-down of the changes in response times that are likely as a result of the new proposed arrangements compared with the existing station arrangements.

The second point I want to make is that given that this is now a significant change from the original proposals in terms of the Birley station, could you advise me firstly why that has come about and secondly what arrangements have been made to consult the local community about it. My understanding is that the consultation will only last for six weeks and there are no proposals at all to have public meetings or an exhibition or display anywhere in the Mosborough and surrounding areas which now must be affected in a different way by these altered proposals. Given there was a public meeting and other attempts at public consultation on the original set of proposals, surely there should be more than a six week window where anyone can comment who might happen to become aware of the difference in the new proposed arrangements.

I look forward to an indication that the consultation window can be expanded and specifically what you intend to do to directly consult with people who are affected by the changes in arrangements for the new Birley station.

One further point that has been drawn to my attention is that given that there will be two pumps on the new station on the Parkway but at night only one of them will have a crew at the station and the others will have a crew that will be called in if the first pump is used, could you confirm that the pump that will be there with a crew at the station will be one of the new vehicles which are designed to tackle particularly onerous jobs and if that vehicle is called away to a specific incident requiring it outside the area will there be a formal backup arrangement to ensure that the very large area which the new station will cover will be properly provided for.

I look forward to your comments on these points as soon as possible.

SYFBU response to SYFR IRMP

Dear James,

We wholeheartedly agree with your view that South Yorkshire Fire and Rescue has already made drastic cuts that other Fire and Rescue Services have not. It is the opinion of the SYFBU we are now at that tipping point where we either need to attempt to secure additional funding or the service will be cut to a point that is beyond what is required to provide a safe service to the public of South Yorkshire.

With regard to SYFR's latest IRMP documents SYFBU have several concerns relating to all aspects, these are listed below.

IRMP Consultation

We believe this has not been carried out to a satisfactory standard and needs to be immediately addressed. A full and proper consultation period must be started with public forums before any decisions are implemented. All stakeholders should have the chance to feedback on these proposals.

Our concerns are as follows:

Public Forums

- None of the attendees at any of these meetings were aware of the intention of SYFR to remove wholetime second pump cover from Doncaster (Population 302,739), Rotherham (Population 258,352), Sheffield (Population 557,382) and Barnsley (Population 233,671) as well as the loss of aerial attributes and the downgrading of one of the remaining wholetime duty system aerials to retained status. They were therefore in no way consulted adequately on the most contentious IRMP proposals.
- Out of the four public meetings there are no records for any meetings at Rotherham, so Rotherham was not represented.
- Of the three remaining forums at Barnsley, Doncaster and Sheffield, only 39 actually attended out of a desired total of 67.

- There was poor representation of the under 35 group.
- There was poor representation of the Disabled Persons group.
- There was poor representation of the Black and Ethnic Minorities group.
- There was poor representation of the over 55 group.
- Evidence of 3 individuals being counted at least twice going to different forums. (This could be because some individuals chose to turn up just for the payment offered.)

Stakeholder Consultation

Below are three statements from an internal audit which reinforce our belief that consultation has not been adequate:

1. *The documentary evidence retained by the Head of Corporate communications & Administration and the Principal policy & External Relations Officer confirmed that in the main the stakeholder groups that the IRMP guidance would expect SYFR to have consulted have indeed been consulted as part of the process. **However, no documentary evidence exists to support the individuals that attended and/or the feedback received (if any) during the open public meetings.***
2. *There was no evidence of any other method of consultation being monitored to identify its effectiveness. For example, the numerous communication methods used to generate interest in the consultation which included press/media coverage, e newsletters, internet/intranet, e mail, social media sites, letters to partner organizations/community groups and up to 4000 A5 flyers and 400 A4 posters being distributed, only resulted in 11 postal feedback forms being received from members of the public.*
3. *Despite the Equality Impact assessment (EIA) recording that the purpose of the consultation was for SYFR to get representative views from all sections of the local community in the development of the IRMP plans, SYFR could have been more pro active in the use of Community Safety Advocates (CSAs). Indeed, the evidence was available to suggest that the consultation leaflets were not provided to the CSAs until 10th may 2013, some six weeks into the 13 week process. **This is not in line with the Consultation Strategy 2013-2018 which records that, Corporate Communications and the Joint Secretariat will provide the resources and coordination to ensure that frontline operational and non operational staff undertake consultation as part of their day to day activities.***

SYFBU is not aware of ANY operational crews being involved in the consultation process which contravenes SYFRA's own Consultation Strategy.

We also believe SYFR has not looked at the Gunning Principles in relation to consultation, brief explanations of these principles are below:-

Gunning Principles

The decision maker's discretion is not unbounded, however, as it is commonly accepted that certain fundamental propositions must be adhered to. These propositions are known as the Gunning (or Sedley) principles, having been propounded by Mr. Stephen Sedley QC and adopted by Mr. Justice Hodgson in Regina v Brent London Borough Council ex parte Gunning 1985. Subsequently approved by Simon Brown LJ in Regina v Devon County Council ex parte Baker 1995 and by the court of appeal in Regina v North and East Devon Health Authority ex parte Coughlan 2001.

The Gunning Principles state that consultation must:

- *be undertaken before a decision has been made;*
- *include enough information to allow any person to consider the proposal and potentially offer an alternative option;*
- *allow adequate time (usually 12 weeks) for responses;*
- *ensure that any consultation findings are reflected within the final proposals.*

Any consultation exercise needs to be clear about the impact of its proposals. A number of local authorities have been taken to Judicial Review in the recent past and deemed to have acted unlawfully in their Public Sector Equality Duty – usually because of a failure to undertake a sufficiently thorough information gathering exercise and analysis in their decision making process, or because there was insufficient information to enable those consulted to give intelligent consideration and a response to the proposals.

We believe that SYFRA consultation does not conform to the Gunning Principles in that people have not been given sufficient information and time to consider the issues in an informed manner, because the proposal with the most impact on the public was not even known during the consultation. (The downgrading of night cover and the downgrading/reduction of aerial attributes, as well as changing the whole time staffing of Birley to RDS)

This raises the question how could their views be conscientiously taken into account by the FRA.

There seems little point in consulting at a formative stage if the full proposals for consultation are not known beforehand.

Closures of Mosborough Fire station, Mansfield Road Fire Station and Darnall Road Fire Station.

If we look at SYFR Community Fire Risk Model it is plain to see that Mansfield Road and Darnall are at the heart of high risk, deprived communities which have already seen the removal of two fire appliances. It is therefore highly undesirable to then close these stations in favour of a new build (Parkway) away from such areas in favour of covering new build housing which will have far more robust fire precautions built in, and the occupiers will most likely not be in the “at risk” group. Darnall Road Station is in fact in the heart of a community which according to SYFR own Community Risk Model is over 6 times more likely to have an accidental dwelling fire (N63 Group) and although fires may be low, fire risk may be high.

The whole dynamics of fire cover in Sheffield was dependant on the new Birley Station being full time (Staffed 24/7 by wholetime crews), below is a section taken from SYFR Review of Sheffield Emergency Cover which the public were consulted on:

Review of Sheffield Emergency Cover

Section: - Why are these changes being proposed?

1.8 (page 5) - A new full-time station in the Birley area would:

- 1. Provide an improved service to communities in the Mosborough and Crystal Peaks areas, through being better located, and being full-time. The current retained provision at Mosborough is subject to a five-minute delay whilst retained firefighters travel to the station*

2. *Cover the communities in the current Mansfield Road station area which may otherwise have experienced a negative impact as a result of the Darnall/Mansfield Road merger*

Yet again we can see that SYFR promises of a better service to the public are not being fulfilled.

Point 1 reveals that Mosborough and Crystal Peaks will in no way receive a better service, as the Birley Station is not being staffed full time and as such will still be subject to at least a 5 minute delay by any Retained Duty System (RDS) crew. We have a ludicrous situation where potentially Mosborough RDS staff will travel past a boarded up Mosborough Station if it does close, to get to Birley, collect a fire appliance and then travel back to Mosborough to attend any incidents. How is this an improved service?

Point 2 acknowledges the negative impact to the public in the Mansfield Road station area as a result of the Parkway station being built. However this was deemed acceptable as the Birley Station was to be staffed wholtime and so not subject to a five minute delay.

Our calculations from past incident data supports the opinion that Mansfield Road and Darnall could reach the new development at Waverley, Orgeave in just over six minutes and just over 7 minutes respectively, whilst still maintaining good coverage of the areas that would suffer under the new proposals.

Now we know that the latest IRMP supports the downgrading of Birley to RDS, the Review of Sheffield Emergency Cover is no longer relevant, viable nor acceptable.

Alternative

The new builds at Parkway and Birley have a cost of £6.5 million, a significant increase from the original budget of £4.2 million and will be yet another reduction over a very short period in emergency cover around Sheffield.

SYFBU would propose the retention of Mansfield Road, Darnall Road and Mosborough in their current staffing models to keep emergency cover in Sheffield at an adequate level. This will result in a saving of £6.5 million of which part should be used to re furbish the existing stations, using local contractors, to a basic standard.

We would like to draw your attention to a failed merger within the Dearne Valley when Mexborough and Brampton Fire Stations were closed and merged at Dearne with the loss of one wholtime fire appliance. The very area this was supposed to provide an *“improved service”* for, according to SYFR’s plan namely Thurnscoe and Goldthorpe, have seen a considerable increase in the response time of two fire appliances (9 firefighters) to attend life threatening incidents as follows;

	Time taken for 2 pumps to attend prior to merger	Time taken for 2 pumps to attend after merger

We also note that in SYFR Community Risk Model that Thurnscoe, Goldthorpe and now Mexborough are classed as High Risk despite the significant cost and level of CFS activities in these areas over several years.

We are keen to ensure that the same mistakes are not made again.

Funding is of course the main issue to which we are all focused on. The Government does not wish to fund the Fire Service adequately from central funds but also put restrictions on raising money by council tax because of the referendum needed if rises are over 2%. The cost of a referendum closes this avenue of increasing funding and so we are left with an ever contracting service that has now reached breaking point.

We are also faced with the view that the Fire Service must take on extra roles such as flood response to which no funding is given, complex rescues such as from height and now co-responding seems to be on the agenda. SYFBU are of the opinion firefighters are "up for this challenge" but we need sufficient funding for our existing responsibilities first and then further funding for an expanding role including procurement of equipment and training. If we don't fight these drastic cuts together now, we risk a slow reversal of all the fantastic work that has been done in making South Yorkshire a safer place.

Summary

SYFBU strongly object to the proposals presented in the latest IRMP. We request that a new 13 week consultation period commences to enable the public of South Yorkshire to be fully consulted on the new aspects of the IRMP which were not explained in the first consultation.

We request regular meetings with SYFR and SYFA during this period to enable us to present our concerns and work on potential solutions.

The whole IRMP planning process was completed without SYFBU ever being involved. The National Framework document states that representative bodies should be involved at the development stage. We request that SYFBU are involved at the development stage of future IRMP's to ensure as much as possible that all aspects are considered and all national guidance is followed.

Finally, we would like to offer the assistance of SYFBU officials to SYFR management in lobbying government to provide proper funding for South Yorkshire in light of the fact that SYFR have already proved to be running at a level beyond which a safe and effective emergency response can be provided.

185/10/13 - SY Fire and Rescue Service – Consultation – Mr Steve Chu, Head of Strategy and Engagement, attended to 'explore the impact any changes to frontline services may have on rural communities'. He gave an overview of the background:- consultation exercise; current targets; response time performances; fire deaths and injuries; risk based model for fire protection; draft response time option 'remove the response time target, but will publish how quickly we are responding'. Mr Chu stressed 'they would carry on getting to emergencies as quickly as possible'. Members raised concerns - car parking blocking access for emergency vehicles – Mr Chu advised he would provide cards for placing on such parked vehicles; changes to procedures for fire service attendance at road traffic accidents. Mr Chu was thanked for his attendance.

198/10/13 – Consultation SY Fire – 'Integrated Risk Management and Service Plan'

The following comments were received after the presentation:

1. There should be no actual response time target, provided that the preventative work carries on.
2. Instead of measuring response time targets, put more resources into community safety work to prevent fires happening.
3. Targets can miss the point – get there as quickly as possible is more sensible.
4. Focus on high risk areas for prevention and education.
5. Work with private landlords to tackle overcrowding and unsafe properties, and look to charge landlords to issue safety certificates.
6. Use of SIU's – one member of the group said that they are not seen very often – could they be used more often in fire safety work rather than large pumps?
7. Consider a non- life threatening number for Fire as with Police 101 for anti-social behaviour.
8. Comment from a member of the Somali community about increased risk from use of incense and removal of smoke alarm batteries – further targeting to fit anti-tamper alarms?

I am concerned by some elements of the plan. Particularly night cover, Night time is one of the most dangerous times for fires because people are asleep and it takes longer to raise the alarm, reducing cover at night based on statistical anomalies will result in people dying. Fire coverage should not be about actual statistical occurrences, it should be about calculation of risk. There being a reduction in the quantity of fires does not ever equate to a reduction of risk, the fact is that reducing night time cover at stations covering residential areas increases risk because of the impact upon response times. It does I agree make sense to reduce night time cover in areas of industrial risk where there is genuinely less risk to life outside normal working hours. A logical risk approach may even mean some stations having lower cover during the day because its area of coverage has a higher risk to life overnight. I like the idea of 2nd crews not being on station during periods of low demand providing that adequate resourcing remains available for all first pumps across the county, however in reality, where that is combined with night time losses of first pumps elsewhere in the area this dramatically increases risk to life due to inability to mobilise resources quickly enough in the event of major OR multiple incidents.

Apologies for absence were received from Councillors Godfrey, Hoddinott and G. A. Russell.

FIRE AUTHORITY.

Councillor A. Buckley, Rotherham Metropolitan Borough Council representative to the South Yorkshire Fire and Rescue Authority welcomed Deputy Chief Fire Officer Mark Shaw to the Seminar. DCFO Shaw had prepared a presentation informing Elected Members on the areas under consultation for the Authority's revised Operational Plan.

Previous budget savings achieved: -

- Merger of Darnall and Mansfield Road Stations to the Sheffield Parkway;
- Replacement of Mosborough with Birley Moor Station;
- Small incident units;
- Closure of Royston and removal of Edlington on-call crew;
- Management of staffing reductions.

Currently undergoing a thirteen-week consultation period was: -

- Strategic and Operation Plans up to 2017;
 - The Plans maintained the aim to protect initial responses to emergency incidents and whole-time stations.
- Unless a significantly lowered budget was received: -
 - No loss of whole-time stations;
 - No further removal of rescue pumps;
 - No further changes to staffing deployment.
- Across the area, two whole-time pumps were operating on a 24/7 basis, it was proposed that this be reduced to one whole-time pump;
- Two pumps would be retained over-night on a resilience basis.
- It was predicted that the target of getting the first appliance to a dwelling fire within six-minutes would decrease by 4.6%;
- It was projected that a nine-minute response rate would be achieved within 80% of the time, in-line with current performance;
- The South Yorkshire Fire and Rescue Authority proposed to maintain efforts in education on prevention measures;
 - Fire alarms;
 - Fire retardant bedding for bed-bound smokers;
 - Sprinkler systems;
- Proposal to remove the response time target, and change to a risk-

based target, with a shorter time target for attendance in higher-risk areas;

- The Authority proposed to continue reporting and publishing the response time in-line with the six-minute timeframe.

Discussion ensued and the following issues were raised and discussed: -

- Deployment of part-time fire officers – this would be resisted by the South Yorkshire Fire and Rescue Service;
- How did the Authority signpost members of the public to prevention work? – Via each Safer Neighbourhood Team's community safety team;
- Strike arrangements;
- Highway access for pumps during rush hour periods;
- Fire Cadets – opportunity to win young hearts and minds;
- Earmarked and usable reserves of the Authority;
- Terms and conditions relating to night shifts, including access to beds and their replacement with chair beds.

Councillor Buckley thanked DCSO Shaw for his presentation and informative contribution to the discussion.

Resolved: - (1) That the information shared be noted.

(2) That information relating to the risk status of each of Rotherham's wards be distributed to all Elected Members.

Change to staffing of second fire engine at Rotherham confirmed

The staffing of the second fire engine at Rotherham fire station will change next month, as one of the final changes approved by councillors four years ago is implemented.

The second fire engine at the site on Fitzwilliam Road will remain permanently available in the day, but become 'on call' at night by the end of March.

The decision to make the change was approved by South Yorkshire Fire & Rescue's governing Fire Authority in 2013.

It was reaffirmed in an efficiency plan approved by the Government last year, where the service outlined proposals to make more of its fire engines available in the daytime when firefighters are busiest responding to emergencies, carrying out safety work or training.

Deputy Chief Fire Officer Martin Blunden, said: “We have faced big cuts to our funding, but have repeatedly committed to providing the best possible service to the people of South Yorkshire within the resources which are available to us.

“This change is one of the last changes agreed four years ago. The second fire engine is not being taken away, but will become ‘on call’ at night and, as with all our fire stations, our 999 response service will continue to be supported by crews from other, nearby stations.

“We will soon be talking to the public about how we plan to deliver our services beyond 2017 and will look forward to listening to their views on how we plan to develop our work to keep people safe.”

The fire service has lost £14 million in its Government funding since 2010 and is likely to lose a further £2 million between now and 2020.

Changes to the second fire engines at Barnsley, Rotherham and Doncaster fire stations were approved in something called an Integrated Risk Management Plan (2013-17), following consultation with the public and other stakeholders.

A similar, draft plan for how the fire service will deliver its service to local people beyond 2017 will be considered by Fire Authority members in February before members of the public are invited to share their views.

The plans to be presented will not propose any further reductions in fire station or fire engine numbers, but will consider changes to the fire service’s work to prevent emergencies and a new legal duty to collaborate with the police and ambulance services. The fire service will also commit to using its existing resources as effectively and as efficiently as possible.
