1. Purpose of Report

To consider an application for the review of a premises licence made under Section 51 of the Licensing Act 2003 in relation to the premises known as the Bungalow Community Centre, Bungalow, Tenter Street, Rotherham, S60 1LB

2. The Application

The applicant is Chris Burnett, Principal Licensing Officer on behalf of Rotherham Metropolitan Borough Council.

The application is attached to this report at Appendix A.

The application to review relates to three objectives under the Licensing Act 2003 namely the prevention of crime and disorder, public safety, the prevention of public nuisance and the protection of children from harm.

The grounds for review are that the Local Authority are not satisfied, having received a number of complaints, that the premises licence holder is promoting the four licensing objectives namely public safety, public nuisance, crime and disorder and protection of children from harm.

The response from Responsible Authorities and interested parties are attached at Appendix B.

3. Reasons for Referral

The Licensing Authority must refer any application for review to the Licensing Committee if they relate to one or more of the licensing objectives.

The applicant and the premises licence holder have been invited to attend the hearing.

4. Financial Implications

There are no specific financial implications arising from this application. However additional costs may be incurred should the matter go to appeal. In such a case it is not possible predict the outcome of any decision by the Courts in relation to costs.

5. The Legal Position

Section 4(1) of the Licensing Act 2003 requires the Licensing Authority to carry out its functions with a view to promoting the four licensing objectives namely:

- the prevention of crime and disorder;
- · public safety;
- · the prevention of public nuisance; and
- the protection of children from harm.

The Act also requires that the Licensing Authority has regard to its own 'Statement of Licensing Policy' and any guidance issued by the Secretary of State in carrying out its functions.

Section 52(3) of the Licensing Act 2003 requires that the Licensing Authority must, having had regard to the application for a review and any relevant representations, take such steps as it considers necessary for the promotion of the four licensing objectives.

Under section 52(4) the steps are:

- to modify the conditions of the licence;
- to exclude the licensable activity from the scope of the licence;
- to remove the designated premises supervisor;
- to suspend the licence for a period not exceeding three months; and
- to revoke the licence.

Once a determination has been made by Members of the Licensing Committee, section 52(11) of the Act states that the determination does not have effect until:

- the end of the period given for appealing against the decision; or
- if the decision is appealed, until the appeal is disposed of.

6. Hearing Regulations

Regulations governing hearings under the Licensing Act 2003 have been made by the Secretary of State. The Licensing Authority has provided all parties with the information required in the Regulations.

7. Options available to the Licensing Committee

Members of the Licensing Committee authorise officers to:

- · modify the conditions of the licence;
- exclude a licensable activity from the scope of the licence;
- remove the designated premises supervisor;
- suspend the licence for a period not exceeding three months;
- · revoke the licence; or
- reject the application for review.

The application is submitted under S51 Licensing Act 2003.

There are serious concerns that the premises Licence holders are not promoting the four licensing objectives, namely the prevention of crime and disorder, public nuisance, public safety and prevention of children from harm.

There is little understanding or knowledge in respect of age verification at the premises. It appears that customers serve and help themselves to drinks from the kitchen area during trading hours. The premises have been the subject of noise nuisance complaints and incidents of disorder. There is also evidence of repeated licensed activity beyond the permitted hours. At a recent visit to the premises, open and half full bottles of spirits were found left in the rear insecure and accessible garden.

Although there is a requirement to have CCTV at the premises, it has taken over 18 months and repeated visits to ensure any sort of compliance. There is little knowledge or desire to ensure the CCTV is operating properly and little confidence that the operators fully understand the requirement of staff training.

Please provide as much information as possible to support the application (please read guidance note 3)

- 1 This application is made under S51 Licensing Act 2003 in respect of premises known as the Bungalow Community Centre, Tenter Street, Rotherham S60 1LB.
- 2. The premise is a detached bungalow situated within a predominantly industrial location, adjacent to a children's play centre known as Camelot. There are domestic residencies a short distance away, but not in the immediate vicinity.
- 3. An application was made on 2nd September 2013 for the grant of a premises licence by Tabeth Munetsi. No representations were made at this time, and the premises licence was subsequently issued on 7th October 2013. The licence permits the following licensable activities:

Opening hours of premises Sunday to Thursday 1000-0000 Friday and Saturday 1000-0300

Sale of alcohol Sunday to Thursday 1000-0000 Friday and Saturday 1000-0300

Conditions

The licence holder shall ensure that all disorderly visitors are removed from the premises,

The licence holder shall ensure that CCTV is installed at the premises and maintained in working order at all times. Images shall be made available to authorised officers and Police Officers upon request.

The licence holder shall ensure a fire risk assessment is in place at the premises and that all firefighting equipment is maintained and certified at all times.

The licence holder shall display notices asking visitors to leave the premises quietly.

The licence holder shall operate the Challenge 25 proof of age scheme and a refusals register,

- 4. In June 2016, as a result of concerns raised, the Police Licensing Officer attended at the premises and discovered that there was no CCTV fitted. A request was made for CCTV to be fitted in accordance with the license conditions. This instruction was not carried out and a s a result, in October 2016, a further meeting was held at the premises with a number of agencies to identify and address a number of issues which had been raised.
- 5. There was still no compliance with CCTV over the next few months.
- 6. In May 2017, the premises were visited by food hygiene officers at Rotherham Council. The premises had been closed for a period of a few weeks to allow some refurbishment to take place.
- 7. The premises were further visited in July 2017 by Police Licensing Officers and Council Licensing Officers. A number of breaches of the premises licence were discovered, including the lack of CCTV and a S19 Closure Notice was issued requiring compliance.
- 8. Complaints continued to be made in respect of noise and nuisance issues throughout the next few weeks, and despite numerous visits by Licensing Enforcement Officers, a great deal of resistance was encountered in respect of the fitting of CCTV. Evidence of noise complaints and complaints of disorder will be disclosed prior to the hearing, including video footage. During this

period of time, resistance was also experienced by Police Officers and Licensing Enforcement Officers in gaining entry to the premises whilst they were conducting licensable activity. Evidence will also be submitted in disclosure demonstrating this.

- 9. The cameras were finally installed at the premises in early September 2017, but within a few weeks, a burglary was reported at the premises, in which the hard drive located in the attic was reported stolen. After several weeks and many requests, the hard drive was finally replaced with a new hard drive and the cameras were reconnected. A great deal of time was spent examining the installation of the cameras and it remains very clear that the DPS and her staff are very unsure how to operate the system and despite numerous requests for copies of footage, none has ever been produced.
- 10. The premises were recently visited on 24th November 2017 to check whether the CCTV had been installed. Initially there was no understanding as to how the system worked, but after making a few phone calls, the DPS was able to demonstrate that the system appeared to be in working order but we were only able to view the previous 5 days.
- 11. During the visit two half empty bottles of gin were located in the rear garden, accessible to any passing child. The DPS was unable to account for this.
- 12. As a result, the premises were revisited on Tuesday 21st November 2017, where the DPS was interviewed under caution in respect of the premises and the way they were conducting their business. Contemporaneous interview notes were made during the interview and they will be disclosed and referred to at the hearing. Footage from previous weekend showing customers in the kitchen area of the premises apparently serving other customers was recorded on a hand held device by enforcement officers and will be disclosed and presented at the hearing.
- 13. It is clear from events which span over a period in excess of 18 months that there is little confidence that the DPS Tabeth Munetsi is properly promoting all four of the Licensing Objectives. She is very rarely at the premises after 2100hrs to control licensable activity, there are no real measures in place to ensure the premises are managed properly, and there is a clear reluctance to co-operate with the enforcement agencies.
- 14. The application is for the revocation of the premises licence, however there are also other options available to the Licensing Committee, including removal of the DPS, reduction in operating hours, and also the inclusion of additional conditions at Annex 3 of the premises Licence which the committee may feel will address the problems.

Annex 1 Mandatory Conditions

Mandatory conditions where licence authorises supply of alcohol

- 1 No supply of alcohol may be made under the premises licence:
 - a at a time when there is no designated premises supervisor in respect of the premises licence.

or

- **b** at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- **2** Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- The responsible person will take all reasonable steps to ensure that that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children-

- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
- (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-
- (i) the outcome of a race, competition or other event or process, or
- (ii) the likelihood of anything occurring or not occurring;
- (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

- 4. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- 6. The premises licence holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

- 7. The responsible person shall ensure that-
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
 - (i) beer or cider: 1/2 pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml; and
 - (b) customers are made aware of the availability of these measures.

"film classification body" means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c.39) (authority to determine suitability of video works for classification).

Formal Representation in support of Review

The Bungalow - Tenter Street

On behalf of the Chief Constable of South Yorkshire, I wish to submit a Formal Representation in support of the Review of the Licence submitted by Rotherham Council community Protection Unit.

The grounds of Formal Representation are based on Prevention of Crime and Disorder.

I am Helen Cooper – Licensing Enforcement Officer. I can confirm that in this capacity I have had dealing with The Bungalow on Tenter Street since 27th April 2016.

We have concerns regarding the management and general control of this premise, the DPS Tabeth Munetsi is acting more as a paper DPS that active DPS due to her having a young family she is not very often taking Licensing control at the premise. Over the last 12 months there has been 6 Incidents reported in total to South Yorkshire Police 2x Burglary's 2 x Disturbance / Fighting, 1 x Assault, 1x Noise Complaint 1 x Report of drinking after hours.

From my dealing with the premise since 2016 they came back on South Yorkshire Police radar in July 2017, following an incident reported to the police on 21st July 2017 @ 23:14. The caller advised SYP that there was about 20 people being threatening on his driveway. They were shouting and swearing and reported to be smoking cannable by the caller. They reported them having bottles in their hands, SYP responded and a female was arrested.



I attended a meeting with RMBC on 28/07/2017 with Licensing Enforcement Officer Chris Burnett, we met with the DPS Tabeth and her partner Francis. I raised with them the incident reported to the police from the weekend where a female was arrested from the premises. Franics told me he was aware of this incident they had 3 white girls in and it one of these which was arrested later that evening, they were outside when this happened he told me as he had closed up. I reminded him he still needed to ensure his customers were not making a nuisance of their selves when leaving your premises. RMBC had also received a noise complaint as late as 5am which Chris raised with them, which Francis denied.

Myself and Chris carried out a premise walked and found a number of beds located in the bungalow, one in a back bedroom, a mattress in the loft and a camp bed in the out building which were all a cause for concern.

The premise on 28th July 2017 still did not have any CCTV fitted despite the premise being conditioned for CCTV on the premises licence.

Following this visit I had a number of concerns of how the premise was operating and discussed it with my command team.

On this date I was aware that RMBC issued a Sec 19 Closure notice for a number of breaches of premise licence.

On 27th August another caller reported drinking after hours at 06:49. Police responded at 08:00 and they found 6 males drinking from cans in the rear of the premise. They said they waiting for taxi's.

On 8th September I visited the Bungalow with RMBC LEO's Chris Burnett and Trevor McDonald. We went to check the CCTV was working and recording. Francis could not operate the system when asked to and when checked the CCTV was not recording.

On 8th December Police Officer visited the premise to carry out a Licensing Check. They reported Landlord allowed them in to look around and all was in order.

I am writing to you to express my objections to renewing the license at The Bungalow Community Centre Tenter Street, Rotherham, S60 1LB.

My name is Andrew Howarth and I am the owner of the residential property and business adjacent to the Bungalow, namely The Old Church and Camelot Play Castle.

My objections are as follows:

- 1. The business Camelot Play Castle is a children's indoor play and party venue established in 2006, since the Bungalow received its license there has been an instance of fighting in the street involving customers of the Bungalow on a Saturday afternoon which was witnessed by children attending a party at Camelot and by parents and staff. No one should have to witness that especially young children.
- 2. The residents of the Old Church have complained to me on numerous occasions about the exceedingly loud music emanating from the Bungalow until the very early hours of the morning, 7am on one occasion.
- 3. The residents have also complained about access to the Old Church being blocked by cars parked by customers of the Bungalow.
- 4. There are empty drinks bottles and cans left on my properties boundary walls and grounds on a regular occurrence. Also the front garden of the Bungalow is regularly strewn with empty drinks vessels and waste.
- 5. Groups of people congregate outside the front entrance and garden of the Bungalow drinking, which can be intimidating to my customers and predominantly female staff especially when they are locking up the premises.
- 6. Finally, I do not think having a licensed premises next to a well established children's play centre is apt. Children should not have to witness drinking and smoking whilst going to play and attend parties.

When the original license was originally granted I had no idea that one had been applied for. If the relevant parties had had the good grace to notify me, or indeed the council had contacted me then I would have voiced my concerns and formally opposed the application. I am glad that the license is being reviewed and I urge you to decline it, as I believe it is a detriment to the area, residents of The Old Church and my business.


