7/20	<p>Matters Arising from the Minutes of the last meeting held on the 28th January, 2020</p> <p>The minutes were accepted as a true record.</p>	
8/20	<p>Update</p> <p>JH gave an update from a Government perspective. LV outlined the work that has been carried out so far and confirmed that it was felt that Rotherham is “on the right track, subject to receiving full programme guidance”. The Board needs to agree how to release/activate the MyTown portal. JH to update on the portal.</p> <p>A brief consultation matrix had been compiled highlighting the consultation work carried out in the relevant areas over the past couple of years. RK said he felt it was important that members are invited to any consultation events to get a feel of what is said, rather than hearing it second-hand. This was agreed. The Consultant(s) appointed for the Investment Plans will lead on this.</p> <p>LV asked if the Board would like to be part of the procurement process. It was suggested a that a mini group be set up to feedback to the Board on consultation. PH said his organisation has a base in Eastwood and it is important how the questions are phrased and the language used.</p> <p>It was agreed that each Board member write a short paragraph on themselves outlining what they feel they can bring to the Board. This will then be compiled into one document and circulated to the Group.</p> <p>LV confirmed she is drafting a programme of work, including timescales, although this will be subject to change as we learn more about the process. It will also take into account impacts such as holidays and purdah (which starts 23/3/20). 9/20	<p>Recommendations</p> <p>It was agreed that the Consultants, when in place, commission a SWOT analysis for each of the areas.</p> <p>Consultant procurement to start in the next couple of weeks, to be appointed in May. LV asked for the Board’s approval to move ahead with the Investment Plan for Eastwood and Templeborough and for the Strategic Site Assessment? This was agreed.</p> <p>Officers to come back to the Board with a greater understanding on connectivity.</p> <p><u>Mainline Station</u>: It was agreed that a decision needs to be made as soon as possible on who is the lead body on this piece of work. It was agreed that the station would have an impact on the whole of the Borough not just the town centre. 10/20	<p>Vision</p> <p>The Board were asked to look at the 3 themes and use the post it notes to put their ideas/comments forward on the posters around the meeting room. These will be collated, circulated and discussed at the next Board meeting.</p>	
11/20	<p>Tour of Relevant Sites</p> <p>16 of the Board Members and relevant Council Officers took a tour of the relevant sites; Sheffield Road/Templeborough, Meadowbank Road, Bassingthorpe, Parkgate (Mainline Station site) and Eastwood.</p>	
12/20	<p>Debrief/Feedback</p> <p>Feedback from the tour:</p> <ul style="list-style-type: none"> - Members found the tour very helpful/useful - Places are relatively close together, but connectivity is not good - It is not just about the town centre - It was felt there was a good conversation on the tour around Magna, accessibility critical. Lots of excitement around train station. STRIJPS Phillips Complex Eindhoven –is a good example of what can be done with an old industrial site - Housing can help achieve what we want to in an area, but is it key? - The screening of “ugly” uses – hide or relocate for new housing. Planning controls – ugly looking areas/buildings – but vital employment. - Accessibility at Holmes Lock – level crossing down a lot. Close to Bessamer Way and could be linked, but would this damage a nice area around the Canal/Nature Rese? - Make Rotherham, a nice pleasant place to visit - Climate change and the Rotherham Climate Change Emergency Action Plan, need to be a cross-cutting theme of the finished Investment Plan. We need to use this Plan to futureproof the area. - TD got to be environmentally friendly: electric vehicles, green energy, etc. - Can we do anything about improving the private rented housing in Eastwood Village? - 2 nice gateways into Rotherham (Moorgate and Wickersley) but remainder are not attractive - Biomass plant – the future – not bad looking building - Refurbishment of terraced houses along Fitzwilliam Street would help improve the gateway into the town centre. - York Road redevelopment needed. - Some LAs have own PV company/payback – big issue
