LOCAL ADMISSIONS FORUM **THURSDAY 15 JUNE 2023**

Present:- Mrs. I. Hartley (in the Chair); Mrs. C. Cockayne, Mrs. A. Gyte and Peart.

Along with Mr. C. Stones, Ms. J. Unwin and Mrs. S. Whitby (Access to Education).

Apologies for absence were received from Mrs. S. Butterworth.

69. MINUTES OF THE PREVIOUS MEETING HELD ON 9 FEBRUARY 2023

Consideration was given to the minutes of the previous meeting held on 9th February, 2023.

It was noted since the last meeting Dean Fenton, Head of Service, had since retired.

Agreed:- That the minutes of the previous meeting held on 9th February, 2023, be approved as a correct record.

70. MATTERS ARISING FROM PREVIOUS MINUTES

Further to Minute No. 65 (Update Term Dates and Consultation 2024/25), it was noted the calendars had been updated accordingly.

71. THE LOCAL AUTHORITY REPORT TO THE SCHOOL ADJUDICATOR

Consideration was given to the draft Annual School Adjudicator Report for 2023, noting the earlier submission date of 31st October, 2023. This submission would be subject to approval by the Director of Children and Young People's Services and the final version would be provided to the Forum at the November, 2024 meeting.

Agreed:- (1) That the draft Annual School Adjudicator Report 2023 be received and noted.

(2) That a copy of the final version be presented to the November, 2023 meeting.

72. ACADEMIES UPDATE

The Forum noted the updated list of Rotherham schools which had converted/about to convert to academies as of June, 2023.

It was noted that since the last update West Melton Junior and Infant school had converted and was now known as Highfield Farm Primary School, along with Swallownest Primary in May, 2023.

LOCAL ADMISSIONS FORUM - 15/06/23

Whilst only a small number of primary schools remained maintained, the Local Authority was undertaking a piece of work about figure conversions. No formal decisions had as yet been made.

There was some direction from Government in terms of the School Bill going through Parliament which was causing some confusion.

Agreed:- That the information be received, and the contents noted.

73. ADMISSIONS UPDATE

Consideration was given to an update on the current position with regards to Admissions.

It was noted that secondary schools were heavily oversubscribed for the Year 6/7 cohort with large waiting lists and more secondary schools full. For some parents the next nearest offer had been further away from home this year. Whilst there would be some movement following the spring appeals, it still remained that some families would be travelling further to school.

In terms of the primary cohorts:-

- Waverley was still very over-subscribed and some "Catchment" category children had been refused places. Discussions were taking place on the triggers to vary the Section 106 Agreement to add another form entry to the school. No firm plans had yet been agreed.
- All the primary children submitting applications on time had received offers around the area they were located.
- There had been increased oversubscription for junior schools resulting in some Year 3 appeals.

As part of the Admissions Policy, academies were responsible for setting their own criteria and details of this should be clear on their own websites. The Access to Education Team were working with schools to ensure this as updated accordingly and training being provided to ensure compliance.

The Forum sought information on the admission of pupils and oversubscription and asked if schools could refuse places if their admission number had not been reached.

The Forum were advised that schools should comply with the Admissions Policy and could refuse places where it was demonstrated admission would not be appropriate. Full reasons must be provided.

The Council was still receiving a large number of applications for in-year transfers.

Agreed:- That the update be received and the contents noted.

74. SCHOOL ADMISSION APPEALS UPDATE

The Forum received information regarding the high volume of in-year transfer admission appeals planned well into the Summer along with those for Reception/Foundation Stage 2 and Year 2/3.

It was noted that there had been a rise in appeals for children with SEND issues with more mental health and anxiety patterns arising. This was causing some problems for schools as funds were not always available for those children needing support and more needed to be accessed to assist in this area.

The Council was moving forward at speed with the next phase of SEND Sufficiency which was focused on increasing capacity in mainstream for children with Education and Health Care Plans whilst managing parental expectations.

This was an ongoing situation that would take some time to resolve.

Agreed:- That the update be received and the contents noted.

75. FAIR ACCESS UPDATE

Consideration was given to the current position with regards to the Fair Access Protocol and the admission of hard to place children.

It was noted that there had been an increase in the number of SEND and primary children with forty-five children being identified in January. This had been impacted by the number of children moving into the borough with pressures in two particular areas.

There was an increasing number of children without any plans in place and more children with more complex needs. The primary age children were considered at the primarily locality and referred on if needed.

The Forum asked about the complexities with children with English as an additional language and were advised numbers were increasing. This had resulted in many appeal hearings requiring the use of interpreters following movement across local authorities.

Agreed:- That the update be received and the contents noted.

76. SCHOOL ORGANISATION UPDATE

Consideration was given to the latest position with regards to school organisation and it was confirmed the service were rather busy.

LOCAL ADMISSIONS FORUM - 15/06/23

The Annual SCAP Return had opened by the DfE on the 5th June, 2023

and would close on the 28th July. The return data would include projections for primary schools and have added sections for SEND numbers.

Agreed:- That the update be received and the contents noted.

77. UPDATE ON CONFIRMED TERM DATES FOR 2024/25

Consideration was given to the consultation on the school calendar for the 2024/25 academic year.

It was noted that over the last few years Rotherham had moved to a fixed calendar and was aligned with Doncaster and Sheffield. Barnsley were, however, still different and out of kilter with the rest of South Yorkshire.

Agreed:- That the update be received and the contents noted.

78. DATE OF NEXT MEETING

Consideration was given to the date and time of the next meeting.

Agreed:- (1) That the next meeting of the Local Admissions Forum take place on Thursday 16th November, 2023 at 10.00 a.m. via Microsoft Teams.

(2) That the meetings in 2024 would take place on Thursday, 1st February and 13th June, 2024 at 10.00 a.m.

ROTHERHAM LOCAL ADMISSION FORUM

TERMS OF REFERENCE

1. Role of the Forum

The Local Admission Forum provides a vehicle for admission authorities and other key interested parties to discuss, approve and monitor the effectiveness of local admission arrangements and to consider how to deal with difficult admission issues as well as advising admission authorities on ways in which their arrangements can be improved.

The Forum has a key role in ensuring a fair admissions system that promotes social equality and must, under Section 84 of the Schools Standards and Framework Act 1998, act in accordance with the School Admissions Code "the Code" issued by the Department for Education.

Admission authorities of all maintained schools and Academies when exercising their functions must have regard to any advice offered by the Forum.

The Forum shall receive, consider and share advice and recommendations upon:-

: the extent to which current admission arrangements in the area serve the interests of looked after children, children with disabilities and children with special educational needs;

: the effectiveness of the published fair access protocol in place in the area;

: the effectiveness of any scheme for co-ordinating admission arrangements where relevant with any adjoining local authority area;

: details of any other matters which affect the fair operation of admission arrangements for relevant schools in the area:

: to all Admission Authorities, Maintained Schools and Academies, City Technology Colleges or City Colleges of the arts within the area of the Local Authority ("the Authority"), and make available such advice and recommendation to any other person with an interest.

Specifically the Local Admissions Forum must:

(a) consider, approve and monitor the effectiveness of the Authority's proposed Admission arrangements and co-ordinated admission arrangements

(b) advise on whether they differ substantially from the previous year

(c) consider how well existing and proposed admission arrangements serve the interests of children and parents within the area of the Authority

(d) promote agreement on admission issues

(e) review the comprehensiveness, effectiveness within the local context, and accessibility of advice and guidance for parents by the authority through the published annual Admissions to Primary and Secondary School Booklets. The Forum must consider what if any action is needed to raise the standard to ensure it is the best that can possibly be achieved

(f) advise the Authority and governing bodies of all voluntary aided and foundation schools in the area by 30 November each year which persons or bodies in the area the Forum considers have an interest in proposed admission arrangements to ensure that the Local Authority includes them in the consultation process

(g) consider and advise on any proposed qualifying scheme for the co-ordination of admission arrangements referred to it by the Authority pursuant to regulation 5 of the School Admissions (Co-ordination of Admission Arrangements Regulations (obligation on Local Authority to refer qualifying scheme which they propose to be adopted to the Forum)

(h) consider the means by which admissions processes might be improved, and how actual admissions relate to the admission numbers published

(i) monitor the admission of children who arrive in the Authority's area outside a normal admission round with a view to promoting arrangements for the fair distribution of such children among local schools, taking account of any preference expressed in accordance with arrangements made under Section 86(1) of the School Standards and Framework Act 1998 and in accordance with the relevant Admissions Code

(j) promote the arrangements for children with special educational needs, children in care and children who have been excluded from school

(k) monitor the effectiveness of Local Authority Fair Access Protocols and together with the Local Authority ensure that no school including those with places is asked to take a disproportionate number of children who have been excluded from other schools or who have challenging behaviour or who are known to have a history of behavioural problems

(I) to receive reports from LA officers in relation to School Organisation, Admissions, Appeals, Fair Access protocol and Statutory Returns

(m) consider any other admissions issues that arise

In discharging the responsibility for ensuring fair access the Forum should:

(n) refer an objection to the Schools Adjudicator where it identifies admission policy, practice or oversubscription criteria of a school that may be unfair, unlawful or contravene the mandatory provisions of the Code or where Forum advice has been disregarded by admission authorities

(o) review the impact of local admission policies on achieving fair access

2. Declaration of Interests

Members of the Forum shall declare a personal interest in any proposal which directly affects them for example if the proposal concerns the school at which they are a Governor or which their children attend. If the personal interest is pecuniary or could be viewed as prejudicial the member should withdraw from the discussion and take no part in the decision. Where it is clear that a decision in which a member of the Forum has such an interest or it is likely to arise at a particular meeting, the member concerned may wish to invite an alternative member to attend that meeting.

3. Annual Report

Under Section 85A (1A) of the SSFA the Forum may publish an annual report for all maintained schools. Where the Forum chooses to do so, the report must include Academies. The report will be on such matters as the Forum consider appropriate and of local interest and provide input to the Authority's report to the School's Adjudicator.

4. Indemnification

The Authority shall indemnify members of the Forum against reasonable legal costs and expenses arising from decisions or recommendations of the Forum made in good faith.

5. Chair and Vice Chair

(a) The members of the Forum shall elect a Chair and Vice Chair at the first meeting of the Forum and at the next meeting which falls after the date which is a year after the meeting at which the Chair and Vice Chair was elected.

(b) The Chair and Vice Chair shall hold office until the next meeting which falls after the date which is a year after the meeting at which they were elected.

(c) The Chair or Vice Chair shall cease to hold office if they resign their office by giving written notice to the Secretary.

(d) On ceasing to hold office the former Chair and Vice Chair shall be eligible for reelection.

(e) In the event of a casual vacancy occurring in the office of Chair or Vice Chair the members shall at the next meeting elect one of their members to fill that vacancy and the member so elected shall hold office until the date of the meeting at which the Chair or Vice Chair would have held office had the vacancy not occurred.

6. Secretary to the Forum

Members of the Forum shall appoint a person, nominated by the Authority, who is not a member of the Forum to act as Secretary to the Forum. The Secretary to the Forum will keep a record of each meeting of the Forum

7. Sub Committees

The Authority is responsible for establishing the Forum sub-committees pursuant to Section 85A (2) of the School Standards and Framework Act 1998. The Forum shall be responsible for determining a sub-committee's:

- membership and constitution
- procedure for convening and holding meetings
- communication of advice and recommendations

8. Meetings of the Forum

The members of the Forum may regulate the procedure of the Forum subject to The School Admissions (Local Authority Reports and Admission Forms) (England) Regulations 2008 ("the Regulations")

9. Attendance at Forum

Non attendance at three (3) consecutive meetings may result in the termination of membership, at the discretion of Forum members

10. Venue and Times of Meetings

(a) The Secretary will convene a meeting of the Forum, by giving a minimum of seven(7) working days notice of the time and place of each meeting.

(b) The date of the meeting will be given to the Secretary by the Forum at a previous meting, or on the direction of the Chair or in their absence the Vice Chair.

(c) The Agenda shall be set by the previous meeting of the Forum, or if appropriate by the Secretary in consultation with the Chair, or in their absence, the Vice Chair.

(d) The Forum shall meet at least twice (2) each year.

(e) Proceedings and meetings of the Forum shall be open to the public, except in such limited circumstances as decided by the Forum as may be prejudicial to the Forum's work. The Secretary shall arrange for meetings to be advertised to the public.

(f) Members may invite interested parties to a meeting of the Forum if they consider it appropriate to do so having regard to the matters arising for discussion.

<u>11. Quorum</u>

The quorum for any meeting of the Forum shall be one third of the Forum's membership.

12. Minutes of the Meeting

The minutes of the meeting, after approval by the Chair or Vice Chair, may be made available for public inspection.

13. Voting Arrangements

Decisions on matters including the exercise of the Forum's power to refer an objection to the adjudicator shall be taken by a simple majority vote of all members present. In the case of equality of votes the Chair or in his/her absence the Vice Chair, shall have a second or casting vote.

14. Public Statements

Public Statements on behalf of the Forum may only be made by the Chair or Vice Chair either with the approval of the Forum, or without such approval having regard to the importance or expediency. Any such action taken by the Chair or Vice Chair shall be reported to the next meeting of the Forum.

Introduction

- 1. Section 88P of the School Standards and Framework Act 1998 (the Act) requires every local authority to make an annual report to the adjudicator. The Chief Adjudicator then includes a summary of these reports in her annual report to the Secretary of State for Education. The School Admissions Code (the Code) sets out the requirements for reports by local authorities in paragraph 6. Paragraph 3.30 specifies what must be included as a minimum in the report to the adjudicator and makes provision for the local authority to include any other matters. Paragraphs 6 and 3.30 of the Code require that each local authority publish its report locally.
- 2. This year's report must cover the 2022/2023 academic year and be submitted to the Office of the Schools Adjudicator (OSA) by 31 October 2023.
- 3. Please note that, in response to feedback on the draft template, changes have been made to section 2C of this template.
- 4. Please also note that the OSA and Department for Education are planning a small project to ensure that the report is as useful as possible to local authorities, the OSA, DfE and others. As a result of this, there are likely to be changes made to the template for the 2023/2024 academic year.

Guidance on completing the template

- 5. We have included all the guidance on completing specific parts of the template in this section. There is no requirement for local authorities to include the introduction and the guidance in their published reports, but they are free to do so if they wish.
- 6. We should be grateful if in completing questions which ask for information about primary and secondary schools and/or pupils, local authorities would follow the approach to classification of schools used in statutory provisions and in the Department for Education Statistical First Release¹ and the Education Middle School (England) Regulations 2002².
- 7. Guidance on specific questions and/or meaning of specific terms in this report:
 - a. "in-year admissions": This means admissions (that is children admitted to a school and not applications for places):
 - i. at the start of any school year to a year group which is not a normal point of entry for the school concerned (for example at the beginning of Year 2 for a five to eleven primary school); and

- ii. after the end of the statutory waiting list period (31 December) to a year group which is a normal year of admission for the schools concerned (such as Year R and Year 7).

Whether it is "normal points of admissions" or "in year admissions", placing children and young people with an EHCP is a challenging task as this requires consultation to settings who respond to say whether need can be met (or not). The difficulties facing us today is that more and more, needs are unable to be met at mainstream level and therefore more specialist provision is required, be that in an integrated resources, special school or Independent Special School. With the saturation of specialist provision across the country, it is proving harder to place children and young people in these type of settings.

We continue to see children moving into Borough with a significant level of SEN but without an EHCP either because they have just moved to the Country or have previously had a plan that was ceased due to leaving the country for a period of time. We have developed a collaborative pathway across SEND and admissions services to ensure needs are identified and assessed early in order that appropriate provision can be made for each child by the right team.

Schools within Borough respect the decision of the Strategic Fair Access Panel and work with the LA to admit children when requested.

For looked after children with EHCPs, requiring specialist provision, in year admissions are more challenging and delay is frequent and few admissions are within statutory timescales. The situation for out of authority is even more challenging with delays becoming significant.

iv. If you have seen a change in the number of children referred to your Fair Access Protocol between 1 August 2022 and 31 July 2023 compared to the previous academic year please indicate what you consider the key reasons for this change to be?

High volume of migration into specific areas of the Borough, with multiple transient families occupying a single property in some instances, creating a densely populated community. There has been a rise in the number of Elective Home Education cases where the education is unsuitable and where parents have declined to make preferences for school places. Also, there has been a rise in the number of students who have been permanently excluded and who require a mainstream school place.

Although the numbers above reflect the number of admissions, the actual number of cases presented was 83 in total. This is reflective of the movement of pupils in and out of the Borough.

Increased reluctance of some schools to admit in year due to staffing structures already being set and further admissions therefore prejudicing the efficient provision of education or use of resources. Higher number of oversubscribed schools leading to more children being refused through the usual in year application process.

vi. Please provide any comments you wish on the protocol not covered above:

Reflecting on the challenges we have faced this year, we are currently considering a review of our Protocol to ensure that the support provided to children through it is the most timely it can be and ensures a minimum amount of time is spent out of school.

The increased amount of fair access cases places pressure on school resources to meet the needs of these children. They often have significant additional needs, e.g. social emotional and mental health needs and these may be undiagnosed. In particular, we have cases of primary age children who have significant SEND needs but without EHCPs, who needed placements and we must try to ensure they have the right support. There have been a number of children who had EHCPs who moved overseas whose EHCP has been ceased and who have to be placed via the Admissions and Fair Access processes.

We have had students involved with the Youth Justice System, Social Care, Early Help, etc. whose complex cases require significant input to ensure these young people's needs are met.

Rotherham LA continues to coordinate in-year admissions for all but 3 schools (1 Primary and 2 Secondary) and this works extremely well.

A large migrant and transient population in Borough means that In Year admissions can be challenging in some areas. Largely the process works well for children because schools support and act quickly in the best interests of children.

Admissions Arrangements for Entry to Community and Voluntary Controlled School 2025/26

Rotherham Metropolitan Borough Council is the admission authority for all community and voluntary controlled schools within the Borough and as such is responsible for setting and applying the admission arrangements for them. Where a school is an Academy, the admission authority is the academy trust. For foundation and voluntary aided schools, the governing body of the school is the admission authority.

Composite Prospectus

The Local Authority is required each year to publish online by 12 September a composite prospectus. This document is a collation of all admission arrangements for schools within the Borough, including those where RMBC is not the admission authority. Information within this document is available to support applicants to understand the admission criteria and Published Admission Number for entry to each school in the Borough and therefore enable parents to make informed decisions about the schools their child may have higher priority for.

Co-ordinated Scheme

The Local Authority is required to co-ordinate all applications for children resident in the Borough in the normal admissions round and late applications for primary and secondary schools in their area. The normal admissions round is the period during which parents are invited to express 3 preferences for a place at any state funded school for entry to a relevant age group (the age group to which children are normally admitted - Reception year in an Infant, Junior & Infant or primary school and Year 3 in a Junior School. Details of the co-ordinated scheme must be published by 1 January in the determination year (this is the school year immediately preceding the offer year, so for entry to school in 2025/26, the determination year is 2023/24).

Details of RMBCs co-ordinated scheme can be found at <u>School Admissions Determination</u> <u>2024-2025 – Rotherham Metropolitan Borough Council</u>

In Year Applications

The Local Authority is not required to co-ordinate all applications for children requiring a school place outside of the normal admissions round, although in Rotherham most schools choose to be part of the co-ordinated scheme. This means that, if you require a school place for your child at any other point than the normal point of entry (an In Year application or transfer) you are advised to check on <u>Applying for a School during the School Year – Rotherham</u> <u>Metropolitan Borough Council</u> to ensure you make an application in the correct way.

Timeline for applications for a school place in the normal admissions round

Children do not automatically transfer from one phase of education to another and for all children requiring a place in reception, requiring a transfer from an infant only school to a junior school, and those transferring from primary to secondary an application must be made through RMBCs co-ordinated scheme. This includes children already in a school based nursery who require a place in the reception class.

Parents of children resident in Rotherham are asked to submit up to 3 different preferences for any state funded school they wish their child to be considered for admission to - this can be in Rotherham or any other local authority area. Even if you only wish your child to attend school outside of Rotherham you must still apply to RMBC if your child is a Rotherham resident. All applications for schools in other local authority areas will be transferred to that local authority in line with the co-ordinated scheme.

How places are allocated

As part of a school's admission arrangements, admission authorities are required to set a Published Admission Number (PAN), this is the number of school places that the admission authority must offer in each relevant age group of a school for which it is the admission authority.

All applicants must be offered a place where one is available. If there are more applicants than places available then these must be offered in accordance with the published oversubscription criteria, with children in the first criterion the most likely to get a place at the school. Places at LA maintained schools will be allocated using the admissions criteria given below for the relevant age group and will be co-ordinated by the Local Authority. Places will be offered by Rotherham Local Authority as the admissions authority for the school.

Distance Criterion

Where the published admission number for the school is likely to be reached mid category, places will be prioritised within that category by reference to the distance between the home address and the school. Highest priority will be given to those who, on the National Closing Date, live closest to the school measured in a straight line on a horizontal plane (commonly known as measurement, "as the crow flies"). Distance measurements are calculated (by the Local Authority Admissions Team) using a Geographical Information System which applies seed points as determined by Ordnance Survey. Measurements are taken from the seed point of the ordinary place of residence to the seed point of the school. Where the school has more than one seed point, the seed point closest to the geographical centre of the school site is used.

Tie Breaker

Where places are being allocated based on the distance criteria or as part of the distance tie breaker, and there are insufficient places within the admission number for two (or more) children living in the same building (e.g., flats) or otherwise equidistant from the school, then any final place will be allocated by the simple drawing of lots by a representative of the Local Authority independent of the School Admissions Team.

Where applications are received for twins, triplets, siblings born in the same academic year etc these will be treated equally as there is nothing within the admission criteria to distinguish between them.

Catchment area

All schools for which RMBC is the admission authority have a defined catchment area for the relevant age group, these are available to view at <u>RMBC Mapping</u>. Applicants do not have to apply for their catchment area school and living outside a catchment does not prevent an applicant from expressing a preference for a particular school. However, applicants are reminded that living in the catchment area will give higher priority, although does not guarantee a place at a particular school(s).

Admission outside the normal age group

Parents may seek a place for their child outside of their normal age group, for example, if the child is gifted and talented or has experienced problems such as ill health.

Parents of a summer born child may choose not to send that child to school until the September following their fifth birthday and may request that they are admitted out of their normal age group – to reception rather than year 1.

Parents considering requesting that their child is admitted outside of the normal age group must still make an application in the usual way by the specified closing date and should submit to RMBC alongside this a formal request for admission outside of the normal age group.

For community and voluntary controlled schools, for which RMBC is the admission authority, this request will be considered by officers from the local authority, taking account of the views of the head teacher. Information considered in making a decision will include parent's views; information about the child's academic, social, and emotional development; where relevant, their medical history and the views of a medical professional; whether they have previously been educated out of their normal age group; and whether they may naturally have fallen into a lower age group if it were not for being born prematurely.

Where RMBC is not the admission authority then parents should consult the admission arrangements in place for the school for further information about how requests for admissions outside of the normal age group are considered. Requests and accompanying information will be forwarded to the admissions authority for a final decision.

Parents are strongly recommended to discuss any requests with the head teacher of their preferred schools prior to submitting an application.

Admissions Criteria for entry to Reception in an Infant, Junior & Infant or Primary School maintained by the Local Authority

A) Children with Special Educational Needs:

- 7 Children who, on 15th January 2025, it is expected will have an older brother or sister on the roll of the preferred school in Years 1 - 6 or a younger sibling on roll in Reception, Year 1 or Year 2 at the associated Infant school at the start of the academic year 2025 (see note (c) below)
- 8 Children who, on 15th January 2025, live nearest to the preferred school measured by a straight line on a horizontal plane, (commonly known as measurement "as the crow flies").

NOTES – definitions and additional information in relation to the admissions criteria for entry to Reception and Year 3.

a) A 'relevant looked after child' is a child that is looked after by a local authority in accordance with Section 22 of the Children Act 1989 at the time an application for admission to a school is made, and who the local authority has confirmed will still be looked after at the time when he/she is admitted to the school.

Previously looked after children are children who were looked after but ceased to be so because they were adopted (or became subject to a child arrangements order or special guardianship order). All references to previously looked after children in the Code mean such children who were adopted (or subject to child arrangements orders or special guardianship orders) immediately following having been looked after and those children who appear (to the admission authority) to have been in state care outside of England and ceased to be in state care as a result of being adopted.

- b) Places will be allocated based on your residential address on 15 January 2025. Therefore, you must notify the Local Authority Admissions Team in writing if you change address before this date. You may be asked to provide proof of residence (e.g., utility/council tax bill). Documentary evidence of ownership or rental agreement may be required together with proof of actual permanent residency at the property concerned. The Local Authority reserves the right to request an affidavit where there is uncertainty regarding a child's ordinary place of residence or where multiple applications are received.
- c) For a child to be considered a sibling, one of the following conditions must exist: (you may be asked to provide proof e.g., Birth Certificate and proof of residence)
 - brother/sister to be permanently resident at the same address.
 - stepbrother/stepsister to be permanently resident at the same address.
 - half-brother/half-sister to be permanently resident at the same address.
 - brother/sister who do not live at the same residence but, who share the same parents.
 - child of the parent/carer's partner to be permanently resident at the same address.
 - adopted brother/sister permanently resident at the same address.
 - foster brother/sister resident at the same address.
- d) Children of UK service personnel (UK Armed Forces) For families of service personnel with a confirmed posting to their area, or crown servants returning from overseas to live in that area, admission authorities must allocate a place in advance of the family arriving in the area provided the application is accompanied by an official letter that declares a relocation date and a Unit postal address or quartering area address when considering the application against their oversubscription criteria. This must include accepting a Unit postal address or quartering area address for a service child. Admission authorities must not refuse a service child a place because the family does not currently live in the area, or reserve blocks of places for these children.
- e) Any applicant who wishes for information to be considered on the basis of Social or Medical criteria must provide the relevant information at the time of application. This could include a letter from a consultant and must evidence why the preferred school is the only school the child can attend. Applicants wishing to be considered under this category are strongly advised to make additional preferences for schools at which they have high priority in the admission arrangements. All evidence received will be considered by a panel of Local Authority Officers to determine whether attendance at the preferred school is essential.

Waiting Lists

On the National Offer Day of 16 April 2025, the Admissions Team will establish a waiting list for all Infant, J&I, Primary and Junior schools in Rotherham where the number of applications for those schools has exceeded the available places for entry into Reception or Year 3 for a separate Junior school.

The Local Authority Admissions Team will administer the waiting list on behalf of all schools which will operate until the 31 December 2025 when it will cease.

The child's name will automatically be put on the waiting list for a school where they have not been made an offer of a place and where that school is named as a higher preference than the school at which an offer has been made.

Children's positions on the waiting list will be determined solely in accordance with the oversubscription criteria, with no reference to the date of receipt of the application. The waiting list will be re-ordered in accordance with the oversubscription criteria whenever anyone is added to or leaves the waiting list. Should a place become available it will be allocated to the child whose name is at the top of the waiting list on the day that the Local Authority receives written confirmation of the vacancy.

Repeat applications

Repeat applications for the same school year will only be considered if there has been a significant and material change in circumstances that would likely affect the consideration of the application. Any repeat application on the basis of changed social and medical circumstances must be supported by appropriate medical evidence, for example a letter from a consultant.
