109. NO MINUTES OF THE PREVIOUS MEETING HELD ON 6 MARCH 2023 AND NO MATTERS ARISING**110. SOUTH YORKSHIRE PARTNERSHIP BOARD**

The Barnsley, Doncaster and Rotherham Joint Waste Manager submitted a report stating that one of the contractual documents entered into between the Barnsley, Doncaster and Rotherham Local Authorities at financial close of the BDR Waste PFI project was an Inter-Authority Agreement (IAA). This IAA creates the Joint Waste Board ("JWB") as a joint committee pursuant to Section 101(5) of the Local Government Act 1972, which is established as part of the joint working arrangements between the Local Authorities for the management and administration of what are termed Relevant Contracts under the IAA. At the date of today's meeting, the BDR Waste PFI Contract is the only Relevant Contract to which the IAA applies and is referred to as the "Principal Contract".

The submitted report detailed how the functions of this Joint Waste Board will be delegated down to the BDR Steering Committee and the BDR Manager in order to deal more efficiently with the day-to-day decisions that will be required under the Principal Contract. All decisions of the JWB, BDR Steering Committee and the BDR Manager will be made in accordance

with the provisions of the prevailing Inter-Authority Agreement.

In accordance with the IAA, the appointment of Chair and Vice-Chair of the Board rotated on an annual basis.

Resolved:

- 1) That Councillor Higginbottom of Barnsley Metropolitan Borough Council be appointed Chair of the Barnsley, Doncaster and Rotherham Joint Waste Board for the 2023/24 Municipal Year and Councillor Houlbrook of Doncaster City Council be appointed as Vice-Chair for the 2023/24 Municipal Year: and
- 2) The Rotherham Metropolitan Borough Council Steering Committee Representative becomes Chair of the Steering Committee for the 2023/24 Municipal Year and the Doncaster City Borough Council Steering Committee Representative becomes Vice-Chair of the Steering Committee for the 2023/24 Municipal Year.
- 3) That the JWB note that:
 - a. With the exception of the decisions reserved to the Authorities for a unanimous decision under the IAA3, all other decisions in respect of the Principal Contract are delegated by the JWB to the chair of the BDR Steering Committee (the “Authorised BDR Steering Committee Member”).
 - b. The Authorised BDR Steering Committee Member may elect to delegate certain decisions to the BDR Manager.
 - c. The BDR Manager may delegate any decisions delegated to them to a member of the Joint Waste Team (if the right to delegate is granted by the Authorised BDR Steering Committee Member).
 - d. That Rotherham Borough Council’s representative officer on the BDR Steering Committee will be the Authorised BDR Steering Committee Member for 2023-2024.

The new Chair, Councillor Higginbottom wished to place on record his thanks to Councillor Beck for chairing the meetings for the previous year.

Councillor Higginbottom then took over as Chair for the remainder of the meeting.

	TITLE:	South Yorkshire Municipal Waste Strategy (SYMWS) Review

1. Background

- 1.1** In 2016 the four South Yorkshire authorities worked together to develop a South Yorkshire Municipal Waste Management Strategy that was based on the ambitions of a circular economy. Table 1 below provides a high-level summary of the Key Strategic Priorities (KSP) the actions taken and performance. The baseline performance year of the SYMWS was set as the financial year April 2017 to March 2018.

2. Key Issues

2.1 Pandemic

On 23rd March 2020 the UK Government put the country into lockdown due to the Coronavirus pandemic. UK Citizens were told to work from home where possible, only leave home for essential journeys for example for food, exercise or to collect medicines. Social distancing requirements impacted on the delivery of waste services with some such as garden waste being suspended at various points between March 2020 and 24 February 2022.

The requirement for children to be home schooled and the increase in people working from home resulted in a greater level of waste being generated in the home.

Resource and Waste Strategy for England 2018

The focus on health during this period impacted on the progress of the Resource and Waste Strategy for England. This resulted in uncertainty of what materials would be required to be collected by law, how the introduction of Extended Producer Responsibility (EPR) and Deposit Return Schemes (DRS) would interact and what the resulting impact on collections would be.

Environment Act 2021

The Environment Bill 2019-21 was considered during 22 sittings of the Public Bill Committee between 10 March and 26 November 2020. There was a pause in the Committee's sittings during this period due to Coronavirus pandemic related restrictions. Delays to the progress of the Bill had an adverse impact on the ability to deliver the SYMWS outcomes.

Climate Emergency

In Autumn 2019 all of the South Yorkshire Councils declared Climate emergencies, delivering waste services that prioritise the waste hierarchy will contribute towards the carbon reduction targets across the region.

Service changes

Improvement to services were put on hold until the pandemic restrictions were lifted and there was a better understanding of the legislative requirements that would be mandated and funding sources were described. This impacted on the ability of the South Yorkshire Councils to deliver the outcomes as described in the SYMWS.

Governance

The development and progress of the SYMWS was governed through a Memorandum of Understanding (MOU) and there were regular meetings of the South Yorkshire Waste Program Board (SYWPB), South Yorkshire Waste Steering Group (SYWSG) and working groups of officers.
