68. MINUTES OF THE PREVIOUS MEETING

Resolved: - That the Minutes of the meeting of the Improving Lives Select Commission, held on 4 March 2025, be approved as a correct record of proceedings.

69. DECLARATIONS OF INTEREST

There were no declarations of interest.

70. EXCLUSION OF THE PRESS AND PUBLIC

There were no items of business on the agenda that required the exclusion of the press and public from the meeting.

71. QUESTIONS FROM MEMBERS OF THE PUBLIC AND THE PRESS

There were no questions from members of the public or press.

72. DOMESTIC ABUSE STRATEGY 2022-2027 PROGRESS UPDATE

The item provided an update on the progress towards the Rotherham Domestic Abuse Strategy 2022-2027, following the previous update presented to the Commission in 2023.

The Chair welcomed to the meeting Councillor Cusworth, the Cabinet Member for Children's and Young People's Services who attended the meeting to introduce the report in absence of the Cabinet Member for Finance and Safe and Clean Communities, Emma Ellis, Head of Service for Community Safety and Regulatory Services, Andrew Wells, Head of Safeguarding, Kayleigh Charlton, Community Safety Officer and Kelly

White, LINK Officer for the Commission and Assistant Director for Early Help.

The Chair invited Councillor Cusworth to introduce the report, during which the following was noted:

- The strategy was a working document that was amended frequently to highlight any emerging challenges.
- There had been good progress against the strategy, examples were provided of the targeted campaigns completed towards older populations and seasonal awareness relating to Christmas and football tournaments, which had been running for several years.
- Prevention and education were key parts of the strategy, as well as ensuring a trauma informed approach to services.

The Chair invited the relevant officers to provide the presentation, during which the following was noted:

- Part of the Strategy included the commissioning of domestic abuse services and in October 2022 this process was changed. Rotherham Rise now named Hopian, were commissioned to manage the front door services and high-risk cases, alongside the refuge provision. The in-house service known as the Domestic Abuse Outreach Service (DAAOS), was located in the Safeguarding Service.
- Since the development of the strategy in 2022 and by the end of 2024, 81% of actions were complete.

Drive Change Together-

- The DASH was reformed, to provide better direction around completion and make it more user friendly, and better guidance on how to use it to manage the risk of a victim.
- Eight Steps to Homicide training was commissioned to enhance practitioners' knowledge when assessing risk to a victim, the training also looked at perpetrator's behaviours around key triggers and indicators of escalation.
- There was strengthened data collection, to identify any gaps for campaigns and projects. Key campaigns such as the Domestic Abuse Summer Campaign and Domestic Abuse Older People's

- Campaign, were created to challenge unconscious bias around stereotypical victims.
- Non-fatal strangulation training and targeted Health professional training was completed with over 500 GPs and health practitioner. The training was in-line with the Domestic Abuse Act 2021 by recognising that non-fatal strangulation was a standalone crime. Non-fatal strangulation training was delivered to front line practitioners to ensure they would have the tools to spot the signs and refer for support.

Prevention and Early Intervention-

- The 'Do More' Campaign was launched, which followed on from the 'No More' Campaign. The campaign called for all male bystanders to stop abusive and misogynistic behaviours towards women and girls.
- The Walk Safe App was launched across South Yorkshire to ensure people, in-particular women would feel safer. The app had a tracking feature so trusted friends and family could ensure that a person had got to their intended location safety. It also plotted registered safe places, so routes could be planned with those places in mind.
- An Unpicking Cultural Narratives Workshop was developed alongside Sheffield Hallam University to focus on prevention and early invention. The university delivered the workshop based on what could be perceived as a victim, focusing on the word 'vulnerable' and changing the narrative that vulnerability was a sign of courage and strength rather than a weakness.
- A new training plan for 2024-2025 had been developed with a fourtiered approach. This would ensure that domestic abuse awareness training would be delivered to all who required it, at the right level. Training would include 'asking the question' and 'risk assessing' and would be delivered at various times across the year.

Minimising Harm Via the Provision of Early Help Support for Children, Young People and Families-

- The Domestic Abuse Act 2021 stated that children were victims in their own right. A wide scope of support was offered to children experiencing domestic abuse.
- Operation Encompass in conjunction with South Yorkshire Police

led to 100% of schools being signed up within the borough, plus 53 nurseries. South Yorkshire Police advised there would be a national review of Operation Encompass, to look how processes could be enhanced.

 High Risk incidents were increasing due to better reporting and better professional understanding of risk. However, in order to ensure safety, the Multi-Agency Risk Assessment Conference (MARAC) had increased from two meetings per month to three. This had reduced a back log of nine weeks to four weeks.

Responding to Changing Need and Demand-

- There were thirteen specialist domestic abuse properties, which were fully furnished and equipped with target hardening essentials.
 The properties had supported thirty-five adults and thirty-nine children this year to date, including those still in residence.
- There were ten commissioned refuge units and ten commissioned safer options properties.
- The Homelessness Prevention Fund helped to provide essential funds to 153 families in 2024-2025. Examples were provided of how the fund had purchased essential household items, helped with moving costs and had paid rent arrears to prevent homelessness again.
- Target hardening was provided for 142 properties, to enable survivors to remain safely in their own home.

The Next Steps-

- The partnership would aim to develop a better understanding of the family court process and continue to work in partnership to identify the need for direct support for children.
- Work would continue to develop a Survivor Liaison Network, alongside the continuation of training monitoring, and ensuring that a wide range of domestic abuse training would be available to all partners.
- Work would continue to implement and monitor performance and interrogate data to inform any gaps in knowledge or provision.
- Work would continue with Commissioning, to complete the

Domestic Abuse Pathway Review.

The Chair thanked the relevant officer for the presentation and opened up to questions, during which the following discussions took place:

- Members raised concerns around potential online cultures linked to misogyny and asked officers whether this could form part of any future revised strategy. Re-assurance was provided that this was an area where work was delivered in school settings during PHSE lessons. The Safer Rotherham Partnership Priorities had a specific focus on online crime and included areas such as domestic abuse, knife crime, Prevent and healthy relationships. An example was provided of the Do More Campaign and how the campaign encouraged people not to be a bystander and to challenge certain behaviours.
- The Cranstoun Level Up Programme had received a high number of referrals from one particular school, which had led the data on referrals to peak. This was attributed to targeted work that the service had completed and it was advised that it was common for referrals to increase when strong intervention work was completed. The service saw this as a positive impact of the outreach and engagement completed with schools and communities.
- In relation to the 81% of actions that were completed by the end of 2024, the remaining actions were future actions, which focused on the survivor voice and ensuring that it would be captured better in future.
- A Domestic Homicide Review was a statutory function that was completed in any case where an individual had lost their life as a result of a domestic incident. The review sat alongside Safeguarding Adults Reviews and a near-miss process. The service continually learned from reviews and changed practises and processes to ensure improvements.
- The legislation relating to domestic abuse used the term homicide, however work was being completed to change this to domestic abuse related deaths. This would cover all domestic abuse and suicides where domestic abuse had been present.
- Member's raised concerns that the PowerPoint presented to the Commission only included one visual promotion of a male, which was a poster of a perpetrator. Members advised that they would welcome more promotional posters which highlighted the message

that men were also victims of domestic abuse.

- All data relating to domestic abuse, including the relevant dashboard and action plan, was presented to the Domestic and Sexual Abuse Priority Group, which was a sub-group of the Safer Rotherham Partnership. The group was chaired by the Head of Community and Safety Regulatory Services.
- In relation to the 20% of referrals for domestic abuse support that did not engage with support services, it was clarified that this only measured the non-engagement with Hopian and not wider services. Hopian would attempt three phone calls, send a follow up text and a letter if safe to do so. The national average was that it could take up to fifty incidents for victims of domestic abuse to engage in support.
- There was a designated Community Safety Officer who was responsible for promoting the Walk Safe App, this included promotion with schools.
- The data on referral numbers into the Inspire to Change Course had decreased; this was attributed to the service previously receiving a lot of inappropriate referrals, such as referrals of individuals who did not want to complete the course, or who were not ready to join. The course was 26 weeks in total and required engagement from attendee's, therefore the screening processes were updated to ensure the right referrals were received and included individuals who had the desire and motivation to change. It was advised that the success of the course could not be measured solely on how many people completed the course, success also included what individuals had learned from the course even if they hadn't fully completed it.

Resolved: - That the Improving Lives Select Commission:

1. Background

- In October 2024, the Government issued statutory guidance on 'Kinship Care', which included a definition (now enshrined in the draft Children's Wellbeing and Schools bill before Parliament) of kinship care: 'any situation in which a child is being raised in the care of a friend or family member who is not their parent. The arrangement may be temporary or longer term'. This covers a wide span from informal arrangements and private fostering, to Children in Care fostered by family or friends, and children subject to Court orders proving their family or friends with parental responsibility.
- The October 2024 statutory guidance requires that each local authority publishes a Kinship Local Offer. It also extends the role of the Virtual School Head to champion the attainment, attendance and progress of children in kinship care, and extends the role of the Virtual School to provide advice and information to kinship carers. Within the Children's Wellbeing and Schools bill, both the expectation of the local offer and the role of the Virtual School Head are included. A senior manager must be nominated to ensure the kinship local offer meets statutory requirements and that it is responsive to the needs of kinship children and their carers.
- 1.3 The priority for kinship care sits firmly in Government's *Stable Homes Built on Love* and the Children's Social Care National Framework which expects that children are supported by their family network. The Families First Partnership programme guide similarly highlights the critical role of family group decision-making at all stages of a child's journey through the service.
- 1.4 There is a firm legal foundation through Children Act 1989 and subsequent regulations, statutory guidance and case law that children should be raised within their families wherever it is consistent with their welfare to do so, and that it is incumbent on the Council to do what it can to make this possible.
- 1.5 Supporting extended family and friends to care for children and young people when their parents are unable to do so has been a consistent pillar of the Council's successful long-term strategy to reduce the numbers of children who come into care and the Council is committed to continually improve on this offer.

2. Key Issues

- **2.1** The statutory guidance sets out that the Kinship Local Offer must:
 - Set out services available to each kinship arrangement.

- Provide support based on the needs of kinship children rather than legal status.
- Be developed in collaboration with partner agencies.
- Be well-publicised.
- Mitigate against potential barriers to accessing support.
- 2.2 The Kinship Local Offer is expected to address:
 - Support groups and training.
 - Financial support.
 - Help to stay in work.
 - Accommodation.
 - Education.
 - · Supporting family time.
 - Family group decision making.
 - Legal support.
 - Therapeutic support.
- **2.3** Each area in the statutory guidance is addressed within the Kinship Local Offer.
- Research shows that kinship carers find it difficult to navigate services and some benefit from a direct relationship with a professional with specific expertise in the needs of kinship families. There is also evidence that kinship carers can become excluded from mainstream and community services.
- 2.5 As part of the revised offer, a Virtual Kinship Hub will be established within the Integrated Front Door, with Family Help Navigators who will act as the first point of contact for kinship carers. The Navigators will be specialised in the Kinship Local Offer and provide advice and guidance to kinship carers and professionals working with kinship carers. The Navigators will facilitate support groups and peer networks for kinship carers and their kinship children. Signposting and referrals to other agencies will be provided, with a direct route into the Family Group Conferencing service in order that all kinship families can request a Family Group Conference.
- Where kinship families need targeted help, this will be led by a lead professional from a partner agency or from Family Help, with the continued support of the Family Help Navigators who are specialised in kinship care.
- 2.7 Where kinship families need help to meet complex emotional needs for a kinship child, the Empower service will have a dedicated offer to kinship families to either work directly with them or assess eligibility for an application for the Adoption and Special Guardianship Support Fund, with the aim of providing help and intervention to stabilise circumstances at home and support an attuned carer-child relationship.

3. Key Actions and Timelines

- The Council is expected to publish the Kinship Local Offer within two months of the Children's Wellbeing and Schools bill becoming law.
- **3.2** Cabinet will be asked to approve the Kinship Local Offer on 07.07.25.
- Once the Kinship Local Offer has had formal approval, it will be published online as a document and as an interactive website, with a lead-in time of four weeks for the website to be built. It is the responsibility of the named senior manager for kinship to ensure it is accurate and regularly updated.

- 3.4 The Kinship Local Offer will be dynamic and be updated, at least annually but more frequently during this transitional period for service provision.
- The statutory guidance for Kinship Care and the Council's obligations in the Kinship Local Offer were considered at Improving Lives Select Commission in March 2025. CYPS was asked to return to Improving Lives Select Commission in June 2025 with a draft of the Kinship Local Offer for pre-decision scrutiny.

4. Recommendations

- **4.1** Improving Lives Select Commission is asked to:
 - (i) Consider the content of the draft Kinship Local Offer and associated presentation and acknowledge the updates to practice.
 - (ii) Consider the content of the Kinship Local Offer and advise on the accessibility of the language in the offer.

The external advice, activities and support in the Local Offer have not been commissioned by the Council. Advice and information are the responsibility of those organisations. No safety or quality checks have been undertaken by the Council regarding the activities. It is the responsibility of kinship carers to ensure that any activity and location meets your requirements of suitability, safety and accessibility as the Council cannot provide assurances to that effect.

The Kinship Local Offer will be reviewed annually and subject to updates in line with changes in legislation, policy or service delivery.

1. Introducing Kinship Care

Kinship care is defined as 'any situation in which a child is being raised in the care of a friend or family member who is not their parent. The arrangement may be temporary or longer term'.

This could happen due to worries about a child's safety or welfare, and there may be social workers involved. In other circumstances, parents make informal agreements with family or friends about who will look after the child. These different circumstances can also change what support is available and it can change the legal status of the children.

Rotherham's Kinship Local Offer is here to help any kinship carer find help and support.

Where to start

Our support to kinship carers and their children is provided through our Post-Special Guardianship (SGO) Order Service. Our practitioners can be contacted on 01709 82268 inside working hours, or through the online form on the website:

We are changing our services to be responsive to all kinship carers, and we recognise that kinship carers need a single point of contact to help them navigate the local offer and all the help and support available. We plan to reorganise so that Family Help Navigators, specialising in kinship, based in our Front Door will be the first point of contact for kinship carers who need help and advice. This will replace the Post-SGO Service as the primary point of contact. We will update the Kinship Local Offer in due course.

We know that it can be a rewarding but challenging experience being a kinship carer or special guardian.

Kinship carers can get support at any point through their kinship journey. Please get in touch with our team, either through the Post-SGO Service or our Family Help teams if you feel you need support, advice or just someone to talk to.

Kinship is a charity that support kinship carers. Their guide to preparing to be a kinship carer is here: How to prepare for becoming a kinship carer - Kinship.

2. Types of kinship care

There are different forms of kinship care. The type of Kinship Care you offer depends on how the child came to live with you, whether they are a 'child in care', and whether you have parental responsibility or not.

Parental responsibility is what allows a parent or carer to make important decisions for children. *Kinship* has an explainer on parental responsibility: <u>How do I obtain parental responsibility for the child I am caring for? - Kinship</u>

Kinship carers may be caring for children through:

- Informal arrangements or private fostering
- Testamentary guardianship
- Child Arrangements Order
- Special Guardianship Order
- Fostering as a connected person

3. Assessments

Informal kinship care

If you are caring for a kinship child with their parents' agreement and you are a close relative, you do not need to inform us. This does not mean you can't come to us for advice and support. If you contact us, we can help to signpost you to any of the services in this Local Offer.

If you need an assessment of need, we may complete a Family Assessment of Need through our Family Help teams.

Private fostering

Private fostering occurs when a parent makes arrangements for their child to be cared for by someone other than themselves for more than 28 days. This includes extended family (for example a cousin, a great aunt or great uncle, a great grandparent) or a family friend. It does not include close blood relatives such as a grandparent, brother, sister, uncle or aunt (whether full blood or half blood or by marriage or civil partnership) or a step-parent.

A child is considered to be anyone under the age of 16, or a disabled young person under 18.

We would complete a private fostering assessment through our Fostering Service. To start this process, please contact us at Private Fostering | Fostering Rotherham

Kinship foster care

If you wish to care for a child who is a Child in Care, you will likely need to be approved and assessed as a temporary foster carer. The child's social worker would undertake an assessment known as a viability assessment of you.

In Rotherham, our fostering service will undertake all fostering assessments of kinship carers. You will have a dedicated social worker allocated to you from our Fostering team.

Child Arrangements Order

To care for a kinship child through a Child Arrangements Order, an application must be made to Court.

Only a Court can make Child Arrangements Orders, and it may require a report explaining more about you and your kinship child before it does so.

Special Guardianship Order

To become a Special Guardian, you must be first assessed by a social worker from Rotherham Council, if the child currently lives in Rotherham. You may be approached by the Council for assessment in some circumstances, but you can also contact us to ask to be assessed through approaching the child's social worker, or through the MASH (Multi-Agency Safeguarding Hub) if you think the child does not have a social worker.

Only a Court can make Special Guardianship Orders and it can only make them once it has a copy of the assessment. *Kinship* have produced a guide to Special Guardianship Orders which is available here:

There can be differences in the statutory support for Special Guardians depending on whether your kinship child was a Child in Care previously.

Annual summer picnic

This is a family friendly event the Council runs every year to try and get as many kinship carers and their blended families together.

It is held at Clifton Park as this is central for everyone to get to. Guests bring their own picnics and their own games if they want to. There are also games and treats available for the kids. An alternative venue is available to provide shelter in case of bad weather.

7. Help for kinship carers

There is a range of dedicated support for kinship carers and families available.

8. Training and support

Empower Service

The Empower Service offer training to all kinship carers, through a 5 week introductory Kinship Training and Support Group. These are 5 two hour, face to face workshops with a focus on caring for children with complex emotional needs. The course will explore trauma stabilisation, attachment, challenging behaviours and how to help, psycho-education and self-care. Booking onto the course will be made via the kinship family's lead professional.

The Empower service will provide help and support to kinship carers based on an assessed need for a specialist stability intervention. This will include assessments and applications for the therapeutic support via the Adoption and Special Guardianship Support Fund.

Fostering

For kinship carers who are temporarily approved (under Regulation 24) as a foster carer or who have been fully approved at Fostering Panel, there is a training offer for all foster carers which kinship foster carers can also access. This changes regularly but the prospectus can be found at: <u>Local Resources</u>.

This includes new arrival celebration sessions, baby massage, baby first aid, treasure basket sessions, reach, talking tots, toddler yoga, stay and play groups, baby weigh sessions, the PEEP Learning Together Programme and reach, roll and play sessions.

Family Help

The Council's Family Help teams support children, young people and families in Rotherham who need more help than universal services such as GPs or school can provide. The Family Help Service can offer

- longer term support for increasingly complex issues

Family Help staff will work with you at difficult times so that small problems don't get bigger. They work with children, young people and families to offer support and advice when it's most needed. This includes kinship families.

We can work with you in your local area at one of our centres or even in your home.

Kinship carers may start to look after their kinship child with little warning or notice, and there can be a need to take time off work to help their kinship child settle.

There is no statutory kinship leave but some employers are now offering paid kinship leave.

All children are entitled to a full time school place in the September following their fourth birthday, should the parents/ carers preference be for school based education at this point.

Applications for school places can be made at <u>on the school admissions webpages</u>, and you can also find information here about all mainstream schools in Rotherham and their admission arrangements.

All Looked After and previously Looked After Children must be given priority in school admission arrangements and the <u>School Admission Code</u> explains this in more detail.

We know that choosing and applying for a school place can be a stressful time, support and advice is available from specialist admissions staff and they can be contacted using our online form.

Part-time timetables

All children of compulsory school age should receive a full-time education.

In very exceptional circumstances there may be a need for a temporary part-time timetable. This must be to meet the individual needs of a pupil and not because a school does not have enough resources, such as the availability of one-to-one support. Everybody involved with the pupil should agree that attending school on a part-time basis is in their best interest.

If a parent does not agree to a part-time timetable, it must not be put in place, or this may be viewed as an unlawful exclusion.

If you believe your child has been unlawfully excluded from school, you should refer to

14. Legal support

Kinship arrangements have legal implications. Sometimes parental responsibility is held by the kinship carer, sometimes solely by the parents, and sometimes by the local authority. It is important to understand the legal implications of your kinship arrangement.

Rotherham's Kinship Care Policy commits that for prospective Special Guardians where the child is subject to care proceedings, or was looked after and Rotherham Council have completed a Special Guardianship assessment recommending them as Special Guardians,

As part of Rotherham's Kinship Care Policy, Rotherham Council will fund up to three hours legal advice at legal aid agency hourly rates for prospective Special Guardians where:

- The child is subject to care proceedings,
- The child was a Child in Care and Rotherham Council have completed a Special Guardianship assessment which recommends them as Special Guardians

This is available only where the prospective Special Guardian is not in receipt of legal aid funded legal representation already.

Testamentary Guardianship

Some kinship carers will be able to appoint a Testamentary Guardian, or person named in a will to care for their kinship child upon their death.

Kinship has a guide to testamentary guardianship and who can make these arrangements.

Rotherham's Kinship Care Policy commits that for Special Guardians, where the child was subject to care proceedings or was looked after prior to the making of the SGO, Rotherham Council will fund up to £175 contribution for the making of a Testamentary Guardianship arrangement for the children.

17. <u>Neurodiversity</u>

Support is available for children and young people with autism (ASD) and Attention Deficit Hyperactivity Disorder (ADHD), as well as for their carers. Although it is possible to get support without a diagnosis, you may want your child or young person to be assessed for Autism, ADHD or both. The child or young person themselves may feel that this would be helpful.

Children and young people between 5 years and 17 years

Rotherham's child and adolescent mental health services (CAMHS) assess for Autism and ADHD as part of their neurodevelopmental pathway.

Referrals are received through the child or young person's school or educational setting (unless the child/young person is electively home educated). Referrals include detailed information from families.

The child or young person's educational setting must provide evidence of at least two terms of intervention to support the child or young person. The information submitted is considered by a multi-agency panel and, if it is felt that there is sufficient evidence of a neurodevelopmental difference, the referral will be accepted.

Regardless of the outcome of this screening, the panel will always aim to make recommendations to support the young person and their family.

18. <u>Family time</u>

We know that making family time a success, and knowing how to help children with understanding that they do not live with a parent if this was a decision made in the Courts, can be a challenge. Our practitioners can offer advice and guidance.

Young people who have lived in a kinship arrangement through a Special Guardianship Order and were a Child in Care before this may be a qualifying care leaver.

Rotherham has a Leaving Care Local Offer which explains the full details of support available.

Qualifying young people are:

- Aged at least 16 but under 21 and were a looked after young person prior to the making of a Special Guardianship Order, or if at any time after reaching the age of 16, were looked after for a period of less than 13 weeks and have not returned home, or;
- At age 16/17 were an eligible child but were living with a parent for more than six months before reaching the age of 18 (unless you were there under a care order)

Access to Records

Sometimes kinship children reaching adulthood might want to make sense of their journey, what happened, why decisions were made, and who helped make them.

A request can be made to view the files we hold using this link: Subject Access Requests.

Sometimes, it can take a long time for the files to arrive, and they might be bundled in an a few envelopes depending how much there is.

There can be a lot of information that might be difficult to understand. It may contain information that has been redacted because they relate to another person. Data protection prevents us from sharing that information.

We will provide a copy of all the information stored, and we will help the young person to understand what happened in their life, and why.

They will help you work with schools and practitioners to improve your child's achievement.

The services they offer are:

- trained staff and volunteers offering confidential and impartial information, advice and support
- information about education, health and social care, voluntary organisations and support groups
- a range of information leaflets on special educational needs and disability related topics
- access to special educational needs and disability information such as books, CDs and video
- training for parents and practitioners

National context

DfE definition of kinship care:

'any situation in which a child is being raised in the care of a friend or family member who is not their parent. The arrangement may be temporary or longer term'.

DfE's Oct 2024 'Kinship Care: Statutory Guidance' requires that we:

- Nominate senior officer as lead for kinship.
- Publish and regularly review our Kinship Local Offer.
- Offer family group decision making to all families before care proceedings.
- Virtual School to nominate officer for educational outcomes for children in kinship care arrangements.

Local context – Our progress

- Updated RMBC Kinship Care Policy published in 2024.
- Nominated officer for kinship identified.
- Role of Virtual School Head providing advice and guidance regarding children in kinship care and children with a social worker is already established.
- Uplift to kinship allowances following change to means testing model effective from Jan 2025.

Decisions and scrutiny

An update on the Kinship Local Offer was presented to ILSC in March 2025.

The draft Kinship Local Offer is presented to ILSC for scrutiny ahead of a Cabinet decision on 07.07.25.

	TITLE:	Health, Safety and Welfare Panel Representation

1. Role of the Health, Safety & Welfare Panel

The Health, Welfare and Safety Panel provides a regular forum for the Council and its employees to consider matters relating to health, welfare and safety and to provide advice, guidance and recommendations to appropriate Committees or other Council bodies.

Objectives of the Panel include:-

- To promote a healthy and safe working environment for all members of staff employed by the Council and to protect the public from any risk of danger that may arise as a result of the Council's activities.
- To monitor the welfare arrangements (facilities for eating, drinking, first aid and toilets, etc) provided for employees.
- To provide a forum for consultation on proposals put forward by management and by the trades unions.
- To recommend changes to the way in which work is performed by the introduction of safe systems of work, procedures and arrangements, including those for the training of staff.
- To monitor statistics on accidents, incidents and illness and to recommend action to address key issues which may arise from that information.
- To promote greater awareness of health, welfare and safety policies to assist in facilitating improvement in Council performance.

2. Membership and Request for Member Representation from the Member & Democratic Panel

The Panel comprises six Elected Members of the Council to be appointed annually, including Member(s) from:

- Cabinet Member with responsibility for Health, Welfare and Safety.
- A member from the Overview and Scrutiny Management Board.
- One member from each of the Select Commissions (Scrutiny).
- A member from the Members' Training and Development Panel.

3. Membership and Request for Member Representation from the Member & Democratic Panel

The Panel also has representation from the Employees' Side and includes:

At least three teacher representatives (NASUWT and NEU Trades Unions).

• A maximum of seven representatives from all other areas of Council work e.g. UNISON, UNITE the Union, GMB.

4. Frequency of Meetings / Visits

The Panel shall normally meet four times per year. Additional meetings may be held if the business to be transacted is sufficiently urgent. The meetings scheduled for 2025/26 are:-
