Licensing Act 2003 - Hearing Procedure - Grant of a Premises Licence

- 1. The Chairperson of the Licensing Sub Committee will introduce the Committee members and ask officers to introduce themselves.

 - a. the applicant, any person representing them and any witnesses they wish to call.
 - b. any person who has made representations, any person representing them and any witnesses they wish to call.
- 3. The Chairperson will then ask the Licensing Officer to introduce the report and provide any updates.
 - a. Questions to the Licensing Officer may be asked, solely concerning the report, by Members, the applicant and by persons making representations.
- 4. The Chairperson will then invite:
 - a. <u>any person who has made representations</u> to present their representations and call any witnesses they may have.

Note: Members of the Sub Committee, followed by the applicant may ask questions of all persons who have make representations to the hearing and their witnesses.

b. **the applicant** to present their application, respond to the representations, and call any witnesses they may have.

Note: Members of the Sub Committee, followed by any person who has made representations at the hearing may ask questions of the applicant and their witnesses.

- 5. The applicant will then be given the opportunity to sum up
- 6. The public hearing will then be concluded, and Members of the Sub Committee will go into Closed session, together with the Councils Solicitor and the Clerk to the meeting.
- 7. The decision of the Licensing Committee will be given in accordance with the requirements of the Licensing Act 2003 and regulations made thereunder.

Report Summary

On the 10th July 2025 an application for the grant of a Premises Licence was made by Mrs Helen Clayton in respect of the premises known Wigtox Lounge situated at 33 South Street, Rawmarsh, Rotherham S62 5RF.

The applicant, is seeking authorisation to allow the:

- Sale of alcohol (for consumption on & off the premises) on:
 - Sunday to Thursday between 12:00 hours and 23:00 hours;
 - Friday & Saturday between 12:00 hours and 00:30 hours on the day following; and
 - New Year's Eve between 12:00 hours and 02:00 hours on the day following.
- Provision of live & recorded music and the performance of dance (inside only) on:
 - Sunday to Thursday between 12:00 hours and 23:00 hours;
 - Friday & Saturday between 12:00 hours and 00:30 hours on the day following; and
 - New Year's Eve (live & recorded music only) between 12:00 hours and 02:00 hours on the day following.
- Exhibition of films (inside only) on:
 - Sunday to Thursday between 10:00 hours and 23:00 hours; and
 - Friday & Saturday between 10:00 hours and 00:30 hours on the day following.

- Provision of late-night refreshment, for consumption inside the premises, on:
 - Friday & Saturday between 23:00 hours and 00:30 hours on the day following; and
 - New Year's Eve between 23:00 hours and 02:00 hours on the day following.

Representations, both for and against, the application have been received.

Further detail of the application, and representations to it, are provided within the main body of the report.

Consideration of an application (made in accordance with s.17 of the Licensing Act 2003 by Mrs Helen Clayton for the grant of a Premises Licence in respect of the premises known as Wigtox Lounge situated at 33 South Street, Rawmarsh, Rotherham S62 5RF.

1. Background

- 1.1 The premises are not currently licensed under the Licensing Act 2003.
- 1.2 Previously the premises operated under a Club Premises Certificate issued to Ryecroft & Rawmarsh Working Men's Club. This Certificate was transitioned over to the Council from the Magistrates Court in 2005. The Certificate was surrendered in 2012. A Premises Licence was then granted in 2013 to Ryecroft Club Limited. The application Company went into liquidation and was dissolved in January 2019, at which time the Premises Licence lapsed.
- 1.2 A location plan identifying the premises is attached at Appendix 1.

2. Key Issues

The Application

- 2.1 On the 26th June 2025 an application for the grant of a Premises Licence was made by Mrs Helen Clayton for the Wigtox Lounge situated at 33 South Street, Rawmarsh, Rotherham S62 5RF. The application, as amended, and accompanying premises layout plan, is attached at Appendix 2.
- 2.2 The amendment to the application was the deletion of reference to the use of the roof top terrace in Section J.
- 2.3 The application replaces an earlier withdrawn application, which had attracted opposition. Mrs Clayton was aware of this, and at the time of making the application, submitted a letter explaining the changes in the application she had made and a leaflet about proposed use of the premises. A copy of both are attached at Appendix 3.
- 2.4 The application seeks to allow the:
 - Sale of alcohol (for consumption on & off the premises) on:
 - o Sunday to Thursday between 12:00 hours and 23:00 hours;
 - Friday & Saturday between 12:00 hours and 00:30 hours on the day following; and
 - New Year's Eve between 12:00 hours and 02:00 hours on the day following.

Provision of live & recorded music and the performance of dance (inside only) on:

- Sunday to Thursday between 12:00 hours and 23:00 hours;
- Friday & Saturday between 12:00 hours and 00:30 hours on the day following; and
- New Years Eve (live & recorded music only) between 12:00 hours and 02:00 hours on the day following.

• Exhibition of films (inside only) on:

- Sunday to Thursday between 10:00 hours and 23:00 hours; and
- Friday & Saturday between 10:00 hours and 00:30 hours on the day following.

• Provision of late-night refreshment, for consumption inside the premises, on:

- Friday & Saturday between 23:00 hours and 00:30 hours on the day following; and
- New Years Eve between 23:00 hours and 02:00 hours on the day following.
- 2.5 The description of the premises, as provided in the application, is:

"The premises comprises of part of what used to be the Rycroft Club. Rycroft Club was situated in two next door buildings, a converted church and the ground floor of a two storey house. This application is in respect of the converted church only. The next door two storey house is now solely residential and forms no part of this application.

The applicant solely relates to the converted church, which will have a three way function.

- I. Part of the premises will be used as treatment/therapy rooms. However, whilst these room are not part of the application, they are accessed via a doors located within the licensed area. People using the treatments rooms will also share the same toilets as the licensed area. The treatment/therapy rooms will be open between 09:00 hours and 19:00 hours on Monday to Friday, between 09:00 hours and 12:30 hours on Saturday and closed on Sunday.
- II. The rear of the premises is used as residential accommodation, with their own entrance/exit, which comprises of:
 - three ensuite rooms, with a shared kitchen. These room will be used as emergency short stay accommodations;
 - a two bedroom flat' and
 - a studio flat.

- III. The front of the premises will form the licensed area, which will have two fixed bars, one serving alcohol and the other alcohol, together with a range of non-alcoholic beverages and food e.g. coffees, milkshakes, ice creams and a selection of hot and cold snacks. There is also a mezzanine level within in the licensed area, which forms part of the licensed area".
- 2.6 The stated opening hours of the premises for the provision of licensable activities are:
 - Sunday to Thursday between 10:00 hours and 23:30 hours;
 - Friday & Saturday between 10:00 hours and 01:00 hours on the day following; and
 - New Year's Eve 10:00 hours and 02:30 hours on the day following.
- 2.7 The application states that the outdoor consumption of alcohol, food and non-alcoholic drinks will be only allowed on a patio area to the front of the premises until 23:00 on every day. However, customers will be permitted to use this patio to smoke until the premises closes; and that no music, even at a background level, will be provided on the front patio.
- 2.8 The management controls offered in the application, all of which would be made a condition of Annex 2 of any licence granted, are set out below:
 - 1) The CCTV system installed at the premises, shall:
 - a. be maintained fully operational and in use at all times that the
 - b. premises are open;
 - c. make and retain clear images;
 - d. show an accurate date and time that the images were made; and
 - e. cover the inside the premises the externa front patio.
 - 2) CCTV systems installed after 2021 should be a full digital systems with wide dynamic range IP cameras (WDR).
 - 3) All CCTV images shall be retained for a period of not less than 31 days.
 - 4) The CCTV footage shall be controlled and kept in a secure environment to prevent tampering or unauthorised viewing. A record will be kept of any person who accesses the system, the reason why and when.
 - 5) A member of staff who is trained to operate the CCTV system, review images and supply footage will be present at the premises at all times when licensable activities are taking place.
 - 6) CCTV images shall be immediately made available for review upon request of the Police or an authorised officer of the Licensing Authority for purposes in connection with the prevention and detection of crime and disorder, in line with GDPR guidance.

- 7) A copy of a CCTV image shall be provided within 24 hours upon request of the Police or an authorised officer of the Licensing Authority.
- 8) Suitable signage informing customers that CCTV is in operation shall be displayed in prominent positions inside and outside of the premises.
- 9) A record shall be kept of each member of staff who is authorised to sell alcohol and shall include the staff members full name, address, and date of birth. This record shall be retained on the premises and made available for viewing on request of the Police or an authorised officer of the Licensing Authority.
- 10) A Challenge 25 Policy shall be in operated. This Policy shall require that any person who appears to be under the age of 25 must provide ID prior to being served alcohol. Acceptable forms of ID are a:
 - a. passport;
 - b. UK photo driving licence; or
 - c. military ID card.
- 11) All refusals made under the Challenge 25 Policy shall be logged in a bound book. This log must show:
 - a. date of refusal made;
 - b. member of staff who made the refusal; and
 - c. if refused, whether fake ID was seized.
- 12) Signs notifying customers of the operation of the Challenge 25 scheme shall be displayed at the entrance to the premises and at each point of sale.
- 13)A bound incident book shall be maintained, in which the following shall be recorded:
 - a. incidents of crime and disorder occurring at the premises (both inside & outside), which shall include the date and time of the incident; and
 - b. any action taken, including if the police were called.
- 14) The Challenge 25 log and the incident book shall be kept on the premises and shall be available for inspection upon request of the Police or an authorised officer of the Licensing Authority.
- 15) The DPS, or their nominated deputy, shall check the Challenge 25 log and the incident book at least once a week, and sign and date each check.
- 16) There shall be a zero-drug tolerance policy in operation at the premises, which shall include the requirement that regular checks are carried out by management to prevent the use of drugs by patrons; and that such checks are recorded.
- 17)A copy of the premises drugs policy, and associated records, shall kept at the premises and made available to the Police or an authorised officer of the Licensing Authority upon request.

- 18) The premises shall operate in accordance with the "ask Angela scheme" and notices to this effect shall be displayed.
- 19) It is considered that, for the nature of the operation of the premises, door supervisors will not be ordinarily required. However, the use of door supervisors shall be risk assessed on an event-by-event basis. A written record of this risk assessment shall be kept on the premises, for a minimum of 6 month, and made available to the Police or an Officer of the Licensing Authority upon request.
- 20) Where engaged, door staff shall be licensed by the SIA.
- 21)It is considered that, for the nature of the operation of the premises, plastic/polycarbonate drinking vessels will not ordinarily be required however, a risk assessment will be undertaken should unusual events takes place and management deem it necessary.
- 22) The consumption of alcohol, food and non-alcoholic drinks will not be permitted on the front patio after 23:00 on every day. However, customers will be permitted to use this patio to smoke until the premises closes.
- 23) Customers shall not be permitted to use the roof top terrace or the area to rear of the premises (car park) for the outdoor consumption of alcohol, food and non-alcoholic drinks at any time, nor will they be permitted to smoke in these areas.
- 24) Children 12 years and under must accompanied and supervised by a responsible adult at all times, both inside & outside of the premises.
- 25)No children, that is any person under 18 years of age, will be permitted to remain on the premises (both inside or outside) after 22:30 hours unless accompanied and supervised by a responsible adult and attending a pre booked family function or similar event.
- 26) The premises will display a proxy notice in a prominent position explaining that it is an offence for adults to purchase alcohol and then supply it to persons under 18.
- 27) No signage or advertising for any special treatment provided in the adjoining treatment/therapy rooms shall be on display within the licensed area of the premises.
- 28) No adult entertainment or services shall be provided at the premises.

- 29) The DPS shall routinely attend meetings of the local Pubwatch scheme.
- 30) Notices asking people to leave the premises quietly shall be displayed at the premises main exit.
- 31)All staff shall receive training on induction and year thereafter, on the terms and conditions and restriction of this Licence, together with:
 - a. operation of 'Challenge 25';
 - b. types of acceptable ID;
 - c. method of recording refusals;
 - d. refusing sales of alcohol to persons who appear to be drunk;
 - e. preventing proxy sales:
 - f. incident recording and when to call the Police
 - g. Drugs Policy;
 - h. Safeguarding children & vulnerable adults; and
 - i. operation of the "ask Angela Scheme".
- 32) Staff training shall be recorded, records shall be kept of the premises and shall, on request, be made available for inspection by the Police or an authorised officer of the Licensing Authority.

Consultation

- 2.9 Consultation on the application has been carried out in accordance with all statutory requirements and the Council's procedure. There is a prescribed period of 28 days following the submission of an application during which time representations in relation to the application may be submitted.
- 2.10 At the end of the consultation period representations, both for and against, the application have been received.

Representations Opposed to the Application

2.11 Two Responsible Authorities have made representations against the grant of the application, namely the Licensing Authority and the Community Protection Unit. In addition, representations opposing the application have been received from two Ward Councillors and nine "Other Persons". A copy of the representations opposed to the application is attached at Appendix 4.

Representations Supporting the Application

2.12 Fifty-seven representations in support of the application have been received from "Other Persons", a copy of which are attached at Appendix 5.

The Hearing

- 2.13 The applicant, representatives of the Responsible Authorities and "Other Persons" have all been invited to the hearing today. All parties attending, will be given the opportunity to address the Sub-Committee in relation to the matters raised in the application and the representations they have made to it.
- 2.14 Members of the Sub-Committee should give full consideration of application submitted and the and representations to it, together any supporting evidence provided by any party prior to the date of the hearing. Documentary evidence provided on the day of the hearing should only be considered with the consent

3. Options available to the Licensing Sub-Committee

- 3.1 A licensing authority must carry out its functions under the Licensing Act with a view to promoting the licensing objectives:
 - the prevention of crime and disorder
 - public safety
 - the prevention of public nuisance
 - the protection of children from harm
- 3.2 In considering this matter, the Sub-Committee should take into account any representations or objections that have been received from responsible authorities or other persons, and representations made by the applicant or premises user as the case may be. In reaching the decision, regard must also be had to relevant provisions of the national guidance and the Council's licensing policy statement. In relation to this application, the options available to the Sub-Committee are:
 - To grant the licence subject to the conditions consistent with the operating schedule accompanying the application, which the Sub-Committee may modify to such extent as they consider appropriate; or
 - To reject the whole or part of the application (which may include the omission of certain licensable activities from the licence and / or the refusal to specify a particular individual as the Designated Premises Supervisor).

- 3.3 The statutory guidance makes it clear that Licensing Authorities are best placed to determine what actions are appropriate for the promotion of the licensing objectives in their areas. All licensing determinations should be considered on a case-by-case basis. They should take into account any representations or objections that have been received from responsible authorities or other persons, and representations made by the applicant or premises user as the case may be.
- 3.4 The Sub-Committee's determination should be evidence-based, justified as being appropriate for the promotion of the licensing objectives and proportionate to what it is intended to achieve.
- 3.5 Determination of whether an action or step is appropriate for the promotion of the licensing objectives requires an assessment of what action or step would be suitable to achieve that end. While this does not therefore require the Sub-Committee to decide that no lesser step will achieve the aim, the Sub-Committee should aim to consider the potential burden that the condition would impose on the applicant/premises licence holder (such as the financial burden due to restrictions on licensable activities) as well as the potential benefit in terms of the promotion of the licensing objectives. However, it is imperative that the Sub-Committee ensures that the factors which form the basis of its determination are limited to consideration of the promotion of the licensing objectives and nothing outside those parameters. The Sub-Committee may consider wider issues such as other conditions already in place to mitigate potential negative impact on the promotion of the licensing objectives and the track record of the business (if appropriate).
- 3.6 The Sub-Committee is expected to come to its determination based on an assessment of the evidence on both the risks and benefits either for or against making the determination. Conditions may be placed on the licence (if granted) and further information in relation to conditions is provided later in this report.
- 3.7 All licensing determinations should be considered on the individual merits of the application. The Sub-Committee's determination should be evidence-based, justified as being appropriate for the promotion of the licensing objectives and proportionate to what it is intended to achieve. Findings on any issues of fact should be on the balance of probability.
- 3.8 It is important that the Sub-Committee give comprehensive reasons for its decisions in anticipation of any appeals. Failure to give adequate reasons could itself give rise to grounds for an appeal.

Conditions

- 3.9 Conditions include any limitations or restrictions attached to a licence or certificate and essentially are the steps or actions that the holder of the premises licence or the club premises certificate will be required to take or refrain from taking in relation to the carrying on of licensable activities at the premises in question. Failure to comply with any condition attached to a licence or certificate is a criminal offence, which on conviction is punishable by an unlimited fine or up to six months' imprisonment. The courts have made clear that it is particularly important that conditions which are imprecise or difficult for a licence holder to observe should be avoided.
- 3.10 There are three types of condition that may be attached to a licence or certificate: proposed, imposed and mandatory. Each of these categories is described in more detail below.

Proposed conditions

- 3.11 The conditions that are appropriate for the promotion of the licensing objectives should emerge initially from the risk assessment carried out by a prospective licence holder, which they should carry out before making their application for a premises licence. This would be translated into the steps recorded in the operating schedule, which must also set out the proposed hours during which licensable activities will be conducted and any other hours during which the premises will be open to the public.
- 3.12 It is not acceptable for licensing authorities to simply replicate the wording from an applicant's operating schedule. A condition should be interpreted in accordance with the applicant's intention.

Consistency with steps described in operating schedule

- 3.13 The 2003 Act provides that where an operating schedule has been submitted with an application and there have been no relevant representations made by responsible authorities or any other person, the licence must be granted subject only to such conditions as are consistent with the schedule accompanying the application and any mandatory conditions required under the 2003 Act.
- 3.14 Consistency means that the effect of the condition should be substantially the same as that intended by the terms of the operating schedule. If conditions are broken, this may lead to a criminal prosecution or an application for a review and it is extremely important therefore that they should be expressed on the licence in unequivocal and unambiguous terms. The duty imposed by conditions on the licence holder must be clear to the licence holder, enforcement officers and the courts.

Imposed conditions

- 3.15 The Sub-Committee may not impose any conditions unless its discretion has been exercised following receipt of relevant representations and it is satisfied as a result of a hearing (unless all parties agree a hearing is not necessary) that it is appropriate to impose conditions to promote one or more of the four licensing objectives. In order to promote the crime prevention licensing objective conditions may be included that are aimed at preventing illegal working in licensed premises.
- 3.16 It is possible that in some cases no additional conditions will be appropriate to promote the licensing objectives.

Proportionality

3.17 The 2003 Act requires that licensing conditions should be tailored to the size, type, location and characteristics and activities taking place at the premises concerned. Conditions should be determined on a case-by-case basis and standardised conditions which ignore these individual aspects should be avoided. Conditions that are considered appropriate for the prevention of illegal working in premises licensed to sell alcohol or late night refreshment might include requiring a premises licence holder to undertake right to work checks on all staff employed at the licensed premises or requiring that a copy of any document checked as part of a right to work check is retained at the licensed premises. Licensing authorities and other responsible authorities should be alive to the indirect costs that can arise because of conditions. Licensing authorities should therefore ensure that any conditions they impose are only those which are appropriate for the promotion of the licensing objectives.

4. Timetable and Accountability for Implementing this Decision

- 4.1 Any decision made by the Licensing Sub-Committee does not have effect until:
 - the end of the period given for appealing against the decision; or
 - if the decision is appealed, until the appeal is disposed of.
- 4.2 An appeal may be lodged by either the applicant or a party to the hearing that has made a relevant representation.
- 4.3 Parties to the hearing must be informed of the decision within 5 working days of the hearing (or within 5 working days from the last day of the hearing if it takes place over multiple days).

5. Financial Implications

- 5.1 There are no specific financial implications arising from this application.
- 5.2 However, additional costs may be incurred should the matter go to appeal. In such an eventuality it may not be possible to recover all of the costs incurred. The impact of these additional costs (if any) will therefore need to be met from within existing revenue budgets.

6. Legal Advice and Implications

- 6.1 A Council Solicitor will be in attendance at the hearing to provide appropriate legal advice to the Licensing Sub-Committee in relation to specific aspects of the application / hearing, however the advice below is generally applicable to all applications.
- 6.2 Hearings under the Licensing Act 2003 operate under the Licensing Act 2003 (Hearings) Regulations 2005.
- 6.3 In accordance with Regulation 18 of the Licensing Act 2003 (Hearings) Regulations 2005, the authority may take into account documentary or other information produced by a party in support of their application, representations or notice either before the hearing or, with the consent of all parties, at the hearing.
- 6.4 The Sub-Committee may accept hearsay evidence, and it will be a matter for the Sub-Committee to attach what weight to it that they consider appropriate. Hearsay evidence is evidence of something that a witness neither saw nor heard but has heard or read about.
- 6.5 The Secretary of State's guidance to the Licensing Act 2003 is provided to licensing authorities in relation to the carrying out of their functions under the 2003 Act. It also provides information to magistrates' courts hearing appeals against licensing decisions and has been made widely available for the benefit of those who run licensed premises, their legal advisers and the general public. It is a key medium for promoting best practice, ensuring consistent application of licensing powers across England and Wales and for promoting fairness, equal treatment, and proportionality.
- 6.6 Section 4 of the 2003 Act provides that, in carrying out its functions, a licensing authority must 'have regard to' guidance issued by the Secretary of State under section 182. The guidance is therefore binding on all licensing authorities to that extent. However, the guidance cannot anticipate every possible scenario or set of circumstances that may arise and, as long as licensing authorities have properly understood this guidance, they may depart from it if they have good reason to do so and can provide full reasons.

- 6.7 In addition to the above, members are reminded that all decisions must be taken in accordance with the Council's Statement of Licensing Policy (adopted 3rd June 2020).
- 6.8 Departure from the guidance and / or Statement of Licensing Policy could give rise to an appeal or judicial review, and the reasons given will then be a key consideration for the courts when considering the lawfulness and merits of any decision taken.


7. Risks and Mitigation

- 7.1 The statutory requirements in relation to the consideration of this application are detailed in this report. It is essential that the Sub-Committee act in accordance with these statutory provisions and take account of statutory guidance.
- 7.2 Failure to do this exposes the Council to significant risk of legal challenge, the consequences of which could result in financial and / or reputational damage to the Council.
- 7.3 Members are therefore urged to fully consider the information in this report when making a decision regarding this application, and to ensure that any decision made is justifiable, proportionate and based on the promotion of one or more of the Licensing Objectives.
- 7.4 Council officers are present at the meeting today and can provide additional advice to members of the Sub-Committee should this be required. In addition, a copy of the statutory guidance and Statement of Licensing Policy is available for members to review should they wish to do so.





The premises comprises of part of what used to be the Rycroft Club. Rycroft Club was situated in two next door buildings, a converted church and the ground floor of a two storey house.

This application is in respect of the converted church only. The next door two storey house is now solely residential and forms no part of this application.

The applicant solely relates to the converted church, which will have a three way function.

- I. Part of the premises will be used as treatment/therapy rooms. However, whilst these room are not part of the application, they are accessed via a doors located within the licensed area. People using the treatments rooms will also share the same toilets as the licensed area. The treatment/therapy rooms will be open between 09:00 hours and 19:00 hours on Monday to Friday, between 09:00 hours and 12:30 hours on Saturday and closed on Sunday.
- II. The rear of the premises is used as residential accommodation, with their own entrance/exit, which comprises of:
 - three ensuite rooms, with a shared kitchen. These room will be used as emergency short stay accommodations;
 - a two bedroom flat' and
 - a studio flat.
- III. The front of the premises will form the licensed area, which will have two fixed bars, one serving alcohol and the other alcohol, together with a range of non-alcoholic beverages and food e.g. coffees, milkshakes, ice creams and a selection of hot and cold snacks. There is also a mezzanine level within in the licensed area, which forms part of the licensed area.

The outdoor consumption of alcohol, food and non-alcoholic drinks will be only allowed on a patio area to the front of the premises until 23:00 on every day. However, customers will be permitted to use this patio to smoke until the premises closes. No music, even at a background level, will be provided on the front patio.





We have decided that, as I will be in day-to-day management as well as being the licensee of the Wigtox Lounge, it should be me that holds any Licence that may be granted. This decision has been made to prevent any confusion amongst staff, customers, local residents and the Responsible Authorities as to the line of management.

In accordance with this decision I have today made a new application for the grant of a Premises Licence. However, in making this new application I have done my best to have regard to the concerns that local residents raised to the earlier application my husband made.

The latest hour sought in the new application is reduced to 11pm on Sunday, Monday Tuesday, Wednesday and Thursday. Also, a decision has been made not to allow the roof top terrace to be used.

I hope the changes made to my application demonstrates the intention to be a good neighbour to those around us; and that I have had proper regard to the concerns that have been raised. I genuinely want to run a family friendly venue that will be an asset to the whole community. The plan is for the venue to be a local facility for local people.

I write on behalf of Rotherham MBC acting in the role of a Responsible Authority and with reference to the application for the grant of a Premises Licence in respect of the above premises.

The application seeks consent to allow the:

- Sale of alcohol (for consumption on & off the premises) on:
 - Sunay to Thursday between 12:00 hours and 23:00 hours;
 - Friday & Saturday between 12:00 hours and 00:30 hours on the day following
- Provision of live & recorded music and the performance of dance (all inside only) on:
 - Sunsy to Thursday between 12:00 hours and 23:00 hours;
 - Friday & Saturday between 12:00 hours and 00:30 hours on the day following
- Exhibition of films (inside only) on;
 - Sunay to Thursday between 10:00 hours and 23:00 hours;

- Provision of late-night refreshment, for consumption inside the premises, on;

Having reviewed the Operating Schedule provided as part of the application, the Licensing Authority is opposed the grant of this application as it considers that the applicant has not sufficiently demonstrated that the steps they are proposing will sufficiently promote the following licensing objectives:

- Preventing Crime & Disorder
- Protection of Children from Harm
- Public Nuisance

Public Safety

The Licensing Authority is of this view for the following reasons:

- The premises are seeking consent for the retail sale of alcohol until 0030 hours and yet they have stated that door supervision is not considered necessary.
- Outdoor areas are provided for use by patrons, with a number of restrictions in place
 regarding the activities that can take place in these areas after certain times (e.g. no
 consumption of food / drink on the patio area after 11pm). There is no information in
 the operating schedule regarding the arrangements that will be put in place for the
 monitoring and enforcement of this requirements.
- The terminal hour for the sale of alcohol is 0030 hrs it is considered likely that this
 will attract patrons that have attended at other premises earlier in the evening that
 have chosen to attend the venue due to the later opening time.
- There is insufficient information within the operating schedule that outlines the steps that will be taken to minimise the impact of noise on the nearby residential properties and other noise sensitive locations.

The Licensing Authority is open to further discussion with the applicant with regard to these matters and will consider withdrawing the representation if agreement can be reached with regard to additional licence conditions. In order to assist, the Licensing Authority would like to propose the following:

- Subject to condition 3 below, a minimum of two SIA door supervisors will be employed at the premises from 8pm on a Friday and Saturday until premises close.
- 2. Subject to condition 3 below, a minimum of 2 SIA Door Staff should also be employed at the premises on days when higher risk activities are taking place at or in the vicinity of the premises (a high risk activity would be one that is likely to see a significant increase in the number of people attending the venue and / or a change in the nature or behaviour of the people that attend the venue when compared with what would be expected had the activity not been taking place).
- 3. Conditions 2 and 3 will not apply if the both the licensing authority and South Yorkshire Police accept the findings of a satisfactory risk assessment carried out by the licence holder where those finding indicate that the use of SIA door supervisors is not required. The risk assessment must be accepted by the Licensing Authority and South Yorkshire Police prior to the withdrawal of SIA door staff from the premises.
- 4. When carrying out the risk assessment referred to in condition 3, the licence holder should have regard to any information provided to the licence holder by the Licensing Authority, South Yorkshire Police or any other reliable source of information.
- A written copy of the risk assessment referred to in condition 3 must be available for inspection at the premises by any authorised officer.

- If the Licensing Authority or South Yorkshire Police consider that risk assessment referred to in Condition 3 is no longer acceptable or sufficient then conditions will apply until such time as both authorities accept a revised risk assessment.
- Subject to condition 8, no person shall be admitted to the premises after 23:00hrs.
- Condition 7 will not apply to persons that were present in the premises at any point between 22:45hrs and 23:00hrs

As measures relating to the prevention of noise are venue dependant, I have not made any suggestions here regarding appropriate conditions. I would however direct the applicant to the Rotherham MBC Licensing Act 2003 Statement of Policy that provides examples of actions that premises may wish to take to reduce the impact of noise on nearby sensitive properties.

I am prepared to expand upon these matters further during a hearing before the Council's Licensing Sub-Committee, but in the meantime please feel free to contact me if you require anything further.

In reply to your recent email I understand that Carl Clayton has withdrawn his application for an alcohol license for the above premises and Helen Clayton has now applied for a license.

May I mention that I have been in touch with Councillor David Sheppard and it appears that planning permission has not been applied for these premises and the planning team are looking into this.

The new opening hours for Friday, Saturday and New Years Eve are far too late. It will mean that every weekend and Bank holiday customers will be drinking all day and residents will be unable to enjoy their gardens. Although only the patio is to be used as an outdoor drinking area they will gradually overspill and go round the back of the building unless it is securely gated. Even though there are to be notices up when customers come out and are walking home because they have been drinking they will be loud and argumentative. There will also be taxis flying about. Most of the surrounding residents are elderly and won't be happy about being disturbed in the early hours. Although Helen Clayton says the roof terrace will not be used, on section 'J of the application she states that alcohol will not be permitted after 22.30 on every day. If they are open later than the other licenced premises in the area customer who have already been drinking will be coming along and imbibing more alcohol.

This application is not appropriate for these premises. The Lounge is on a narrow back street consisting mostly of terraced houses. It is not an affluent area (lots of people are on benefits) and will not be able to afford fancy cocktails etc. and it will encourage people to spend money which should be going on families and bills.

Outdoor drinking will be on a very narrow patio (6ft/8ft wide) and will spill onto the pavement. Children will be going past at home time which isn't suitable and they will be pestering their parents to go in and buy milk shakes, ice creams etc. again too much temptation. Children over 12yrs will be able to go in unaccompanied and will see customers drinking all day which then they will think is the norm. The building abuts an infant school and isn't appropriate for them to be passing or hearing any uncouth language.

Parking is already a problem on narrow streets and residents already have problems getting in and out and the traffic will spread to other streets. Opposite the premises was a car park

but has now been built on. On the plans there are several studio flats for temporary accommodation so where will they park and also they will be encouraged to use the lounge for drinking and they will also be affected by the noise. Although the music is only being planned for indoors, the front door will be opened frequently for the customers on the patio and it will be a nuisance for residents.

The applicants Mr & Mrs Clayton have only been in the area for a short while and will be unaware of the problems caused at Ryecroft Club when police were called frequently for disturbances and fighting. Although Wigtox is spending lots on converting the building (seemingly without planning permission) I don't think they are being realistic about 'building a community' as you don't need alcohol to do this. They should just have had a coffee shop and cafe alongside their treatment rooms.

As owner/occupiers we alcohol license been granted. It is not in the interest of public safety and preventing crime and disorder, not protecting children and young people. Please consider our objections.

Please see below my appeal against the planning application and reasons why it should be seriously considered to be declined.

Seating - I understand they wish to have a rooftop terrace overlooking south street and main street open everyday from 10:00am until 10:30pm.

This arises major concerns for me when it comes to privacy. Guests would be able to directly see into people honestly, gardens and bedroom windows including mine. This is absurd especially if there are children's bedrooms. And given Rotherham councils appealing past with children, this should be a quick decision to reject this permission for a rooftop seating area altogether.

I understand they also want seating to the front of the property on south street open everyday from 10:00am to 11:00pm with smoking permitted.

This will cause anti social behaviour issues as it did when Ryecroft WMC was there. 

This is in relation to:

Sale of alcohol (for consumption on & off the premises) between 12:00 hours and 00:30 hours Friday and Saturday and 12:00 hours until 23:00 Sunday to Thursday. Provision of late-night refreshment, for consumption inside the premises, on every day of the week.

My concerns are related to the following issues:

- Prevention of crime and disorder
- Safeguarding of children
- Public nuisance
- Public safety

Prevention of Crime and Disorder

Granting a license to serve alcohol until 12:30 a.m. on a residential street is inappropriate, even at a weekend. Historically, when alcohol was previously sold on these premises, there were numerous incidents requiring police intervention. These included anti-social behaviour, vandalism, and damage to vehicles. Reintroducing late-night alcohol and music on this site risks exacerbating these issues and would significantly disrupt the safety of local residents. Despite there being an 11 pm closing time at the previous premises there were numerous occasions that residents had to phone the police past midnight to deal with the antisocial behaviour happening on our street. This will only be further exacerbated by longer hours.

As detailed above, the previous address has been used as a working mens club in the the past. At this time, alongside the crime and disorder detailed above there was also open drug use around the site. This included the clear selling of drugs outside the premises and drug paraphernalia being left around the public bins and in residents bins. This also poses a serious risk to children (please see section below). Even since the closing of Ryecroft Working Mens Club, drug concerns continue to exist on our street and residents consistently witness drug dealing taking place on bisby road. Of late this seems to be increasing within the local area with numerous none residents now waiting on bisby or outside the school late at night. I have already requested south

yorkshire police increase their presence in the area and am aware the councillor Dave Sheppard has asked the same.

Public Nuisance

1. Sound pollution

This is a residential area with terraced houses and relatively narrow streets. Sound travels freely up and down the road and the houses are quite close together. Previously, when the pub was open we could hear the conversations happening outside the pub while people were smoking in our home.

Since the closing of the working mens club our street has become a quiet residential street, numerous families have moved in and it has been a real change for the better.

Sound from the pub disrupts local residents, most of whom are working age or have young families. An opening time until 1am is not acceptable and would cause unnecessary disruption to residents alongside sleepless nights for adults and children. Most families have a room on the front of their houses. It is not acceptable to have residents disturbed by the sounds of this venue. The use of the front for seating also makes it impossible for residents not to be disturbed. The previous site used the back and side of the club for seating which did alleviate some of the noise on south street however I cannot attest to what this looked like for residents on main street.

2. Parking.

It has always been difficult to park near our homes on south street. Previously, the working mens club had an area used as a car park. This has now been repurposed into housing causing more of a challenge parking both in the day and at night for all local residents. There is not the infrastructure on and around south street to cope with the additional hmo flats (for whom parking is not provided), new houses built, the school and traffic visiting this proposed venue. This impacts on safety, especially where there are such a large number of children around and is a nuisance for residents.

3. Additional footfall

The additional footfall in and around the venue and the ability to take alcohol off site encourages anti social behaviour and causes an increase in noise. It also encourages an increase in litter, we currently are contacting the council on a weekly basis for the emptying of rubbish from bins. There is a large amount of litter left on the green areas of Bisby Road.

Protection of Children from Harm

The proposed site is immediately adjacent to a school. During my time living here, I have witnessed children having to pass individuals who were visibly intoxicated near the premises of Ryecroft Working Mens Club. This is not an acceptable environment for young people and raises serious safeguarding concerns. This will only be exacerbated by patrons being able to drink on the front of the site, next door to the school.

Without adequate measures to disrupt noise, sound will travel and inappropriate conversations may be over heard by children.

Noise from outdoor areas would also potentially disrupt children's learning.

APPENDIX 4

Finally when the ryecroft working mens club was open there was drug paraphernalia, glass bottles, broken glass and alcohol left on the streets. This is a significant risk to keeping children safe. The schools is also an infant only school meaning that children are often not able to adequately protect themselves from harm.

Public Safety

There are longstanding public safety concerns associated with this site. In the past, there have been instances of physical altercations, windows being put through, cars being hit by those leaving the pub intoxicated, drug dealing on the street and cars being set on fire. When Ryecroft Working Mens club was open we did not feel safe walking past the club at night. We finally are in a place where residents feel safe in their own homes and are not worrying about every sound. It is wholly unreasonable to put residents back in that situation until late at night.

I also have significant concerns about the multi use of this site and that there may be needles and scalpels for aesthetic treatments kept a door away from where people are drinking. I am concerned that one kicked down door could lead to a patron being armed with a weapon which could have an unspeakable impact on the safety of patrons and residents.

Emergency vehicle access has always been a problem due to excessive, poorly regulated street parking and a lack of available spaces as a result of the development of need houses on the street. Previously, the premises included a car park, but this space has now been repurposed for housing as approved by Rotherham Council, further reducing available parking. Additionally, the conversion of the site into flats has added further pressure on local infrastructure. Combined with the proximity to a school, these changes create real risks to public safety and require serious consideration. If there was a serious incident parking in this area currently prevents access for emergency vehicles and this is only likely to get worse. I also have a number of concerns around the safety of children at the end of the day due to the number of vehicles and again this will be exacerbated.

Addressing Concerns

As redress to my concerns I believe the following should be put in place to ensure that the community is kept safe.

1. Addressing the times of the alcohol licence.

It is unreasonable for a venue on a residential street to be open until 1am and serve alcohol until 12:30am. My suggestion would be that alcohol can be served until 10:00 pm (with a 10:30 closing time) Sunday - Thursday and 10:30 pm Friday and Saturday with a closing time of 11:00pm. This would be in line with similar local amenities such as rawmarsh tap which closes at 10pm week nights and 10:30pm weekends and local

off licences which have a latest closing time of 11pm. I would also note that all these local amenities are on a main road not in the middle of a residential street.

There is also an application for an opening time until 2:00am on new year's eve. While I appreciate this is a night where the venue may need to be open later, it is unnecessary for it

to be open until this time. I would suggest that alcohol is served until 12:30am on this night only with a closing time of 1am in line with public houses.

2. Use of outdoor areas.

This is a residential street with the majority of residents of working age or families with young children. All houses have bedrooms on the front of our houses. I would suggest that outdoor areas close at 9pm Sunday - Thursday to prevent disruption to children and 10pm Friday and Saturday to ensure that residents who shift work are not disturbed. I would also request that consideration is given to either move the outdoor seating to the back of the venue or objects put at the front of the venue to redirect noise such as sound panels within a fenced area.

3. Parking.

There is a clear issue with safe parking on the street exacerbated by the repurposing of land previously used as parking for housing and the additional vehicles which will be generated by hmo housing. I would suggest that there is consideration to the front of the building being used for parking for the hmo housing with beer gardens on the back and a permit system being introduced for residents of south street so that they are able to park safely and within a reasonable distance of their homes. There could also be consideration of how the green spaces on bisby could be repurposed by the council for additional parking. This could also be a conversation with the school as there is not enough parking within the school grounds for staff to park.

4. Security.

First there needs to be installation of security cameras outside the venue and on south street to capture any antisocial behaviour to support the appropriate legal redress should any incidents occur. Secondly there needs to be a clear plan to move patrons on at closing time and prevent anti social behaviour, for example sri security being in place at the venue.

5. Litter.

There needs to be a commitment to ensuring litter is reduced on the street. Therefore I would request twice a week emptying of public bins and weekly litter picking on the street.

6. Potential drug use around the site

There needs to be agreement from Mrs Clayton about her response to incidents of drug use in the area and in his venue and an understand of how Mrs Clayton will work with South Yorkshire police to reduce and respond to drug use in and around the venue.

7. Access to dangerous objects

There needs to be clear safety planning to ensure that dangerous objects used in cosmetic treatment cannot be accessed by patrons. This needs to go further than being behind a locked door. There needs to be a clear risk assessment in place and clear plans about steps that should someone gain access to equipment and the order of these e.g. contacting the school to trigger lockdown procedures, contacting south Yorkshire police etc. While I am aware that this may seem extreme to those who have not lived in the area I have seen the

extent of anti social behaviour in this venue in the past so am more than aware that a locked door can be quite easily kicked down.

8. Safeguarding of children

The use of the outdoor terrace, the risk of antisocial behaviour, the risk of drug use and other risks to children have serious safeguarding implications which need to be taken seriously in line with the law. I would suggest that any mitigation of this area invites the school and local authority safeguarding representatives into the discussion to ensure the adequate safeguarding of children. This area needs to be mitigated with suitably qualified professionals.

Finally I would like to express my concerns about the licensees information to given to local residents. It is proposed as a family friendly venue to give something back to the community. However information sent out does not make clear that the venue is planning to stay open until 1am. I do not understand any eventuality where a family friendly venue needs to be open till 1am and I would assume local residents would identify the same if they were aware. This is the second time information has been circulated by the proprietors about the plans and the opening times have not been made clear which I perceive to be an attempt to hoodwink the local community and doesn't inspire confidence that they are creating a venue to support the community.

I want to make it clear that for years then residents of South Street have had to put up with sleepless nights, anti social behaviour and not feeling safe outside their own homes (and this was with an 11pm closing time). Over the last few years, since the closing of the club, our street has become a quiet, calm, neighbourly place and a pleasure to live on. It is everyone's duty to ensure that this continues and the area and community continue to develop so that Rawmarsh is seen as a good and safe place to live. The the only way to ensure that the community continues to thrive is through the area being a desirable place to live rather than the opening of businesses which force people from the community and our street. None of the community would be opposed to a business repurposing the club in a positive way however this has to be done transparently to support the local community not in a way that increases risks in the local area and negatively impacts local residents.

We wish to make a strong objection to the above licensing application in respect of 33 South Street, Rawmarsh and would make the following points:

- i) The venue is in the middle of a residential area and at the side of an Infants School. There are a great many houses close by. When the original Ryecroft WMC was opened in the early 1900's there were very few houses close by.
- ii) There is no car park for the venue. There was one directly opposite but 3 town houses are being built on the site. Parking on South Street is already a big problem for residents particularly at night and this venue will only make the situation far worse. Residents already suffer from haphazard parking by parents of school children in the mornings and afternoon. Many parents keeping their engines running for long periods.
- iii) Over the years residents have regularly been disturbed by noise from the club during and after licensing hours. Customers who sat outside drinking and smoking made a great deal of noise and were constantly shouting and swearing. Residents were unable to keep windows open or even sit in their gardens undisturbed particularly during the Summer months. A license issued to the club stated that there should be no drinking outside but this was never adhered to. The application states that there will be a seating area outside the entrance to the building and therefore the residents will be subject to noise and disturbance yet again.
- iv) The application states that the rooftop terrace will not be used. However the door is already in place and who is going to stop it being used if the licence is granted.
- v) The application states that children under 12 must be accompanied by an adult at all times and that no one under 18 can be on the premises after 10.30 pm. Does this mean that children aged 12 to 17 can be on licensed premises unaccompanied up to 10.30 pm?
- vi) There is no separation between the so called coffee lounge, ice cream parlour, beauty parlour and drinking area.
- vii)The licensing hours applied for are totally ridiculous and irrespective of the claim that noise will be kept to a minimum. How will they ensure that this will happen and what is classed as a minimum amount?
- viii) A leaflet distributed by Wigtox says that this is what the community needs. Who did they canvas to reach that conclusion? Certainly not residents! The applicant has not lived in the area very long and has no idea of the previous problems caused by the former club.

I am writing as homeowner on South Street to formally object to the premises licence application submitted for "Wigtox Lounge" at 33 South Street,

Rawmarsh, S62 5RF. While I think local business is important, I fear that the disruption this could cause has to be considered.

33 South Street is now flats and a building that is (according to WigTox posters) to be multipurposed. I would ask that all planning applications are investigated to ensure the proper planning and building regulations are upheld as the building has changed it's purpose from a pub to flats and a pub/function room/coffee shop/ ice cream parlour/aesthetics centre. Planning applications should be split purposes and reflect the properties purpose both current and historic.

I object to this application on the grounds that it undermines the following four licensing objectives set out in the Licensing Act 2003:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

1. Prevention of Crime and Disorder

This premises is located in a quiet, residential street not suited to late-night commercial use. The proposed licensable hours—alcohol until 00:30, closing at 01:00—are inconsistent with local precedent. For comparison:

- The Horse & Jockey closes at 11:00 PM (10:00 PM Sundays)
- The Marquis closes at 11:00 PM daily
- The Earl Grey closes at 11:00 PM (8:00 PM Sundays)
- Rawmarsh Tap 10PM Sundays Thursday and 10:30PM Fridays Saturdays

All of these establishments are on main roads away from local residents. Late-night trading in a residential setting will attract patrons from other venues seeking extended drinking hours, increasing the likelihood of antisocial behaviour and noise. I fear that the noise of patrons walking to the venue and leaving the venue at night, no matter how well managed, by its very nature will increase noise, for example the use of the street facing seating area, people chatting, shouting goodbye or coming outside to smoke after having a drink. The only way to manage this is to have an earlier closing time (see below). The premises also plans to sell alcohol both on and off-site, which raises serious concerns about street drinking and disorder after closing which has happened historically.

Notably, the former pub on this site (The Rycroft WMC) was regularly attended by police due to alcohol-related violence, residents property and car damage, drug activity and disorder. These problems had a lasting impact on the community, and there is understandable fear that history will repeat itself.

There is currently no provision for door staff in the application or the advertisement sent by Wigtox to residents. This is deeply inappropriate given the proposed late-night hours.

We request, at a minimum, that SIA-registered security staff be required on Friday, Saturday and Sunday evenings until close. This can ensure a safe and swift disbanding of patrons.

2. Public Safety

Parking on South Street is already severely limited. The application proposes no parking provisions, despite plans to increase footfall and introduce residential units. There is no capacity for safe parking for patrons, delivery drivers, or staff. Cars already park on pavements due to lack of space, blocking prams and emergency access routes. The venue also has no defined taxi pick-up point, meaning patrons will gather at the roadside after 1:00 AM, obstructing the road at a T-junction and increasing the risk of accidents.

Litter is already a major concern, the addition of alcohol consumption and outdoor seating will only increase this hazard, especially without a clear waste management strategy.

I request:

- A designated parking and traffic dispersal plan
- Daily litter pick-ups and additional street bins maintained by the premises
- No outdoor seating allowed on the front of the property (there is a back area that could be used and better contained)
- Limiting rooftop terrace hours (see below)
- To be closed on New Years Eve by 1:00AM and sale of alcohol to stop at 00:30AM.

3. Prevention of Public Nuisance

This development is wholly inappropriate for a residential street. Late-night music, intoxicated behaviour, outdoor smoking, taxi noise and bottle disposal will all erode community peace. This will affect not just sleep patterns, but residents' mental health and ability to work from home, especially those with caring responsibilities, disabilities or children.

The building sits at a T-junction, amplifying and echoing voices and music into the street. Conversations from customers will project into homes, many of which have bedrooms facing the street. The permission of a music and alcohol license, especially to such a late time, will only aggravate this.

Furthermore, there is no acoustic barrier, no seating plan, and no meaningful sound control proposed. Most homes in this area have families, shift workers, and retired residents. They are entitled to peace in their own homes.

Reasonable conditions must include:

- Alcohol sales to end by 9:30PM on weekdays and 10:00PM on weekends.
- Venue closed by 10:00PM weekdays and 10:30PM weekends.
- No front-of-property street seating
- Nightly bin-emptying and litter clear-up
- No amplified music audible from the property boundary

4. Protection of Children from Harm

Perhaps the most ethically serious issue is the location of this venue: directly next to an infant school (Rawmarsh Ryecroft Infant School). The school serves 5–7-year-olds. The proposed hours would overlap with school start and finish times during event setups, deliveries, and early-day alcohol service.

Children will be exposed to:

Public drinking

- Loud music and crowds
- Possible arguments, smoking and foul language from outdoor patrons

Alcohol off-sales until 00:30 risk street drinking within view of the school, undermining Rotherham's duty to protect minors. The risk of underage proxy sales is heightened given the location and lack of permanent supervision. Previous the venue had lots of issues with people smoking cigarettes, cannabis and loud conversations on the front of the property that would echo down the street. The only prevention for this is to have the seating area not on the front of the property that pours into the street. There is no clear differentiation between the front of property and the street.

I would also like to note that this re-application has been done during the school holidays not giving school the correct time to make comment if they wish. I would ask that someone reach out to the school to ask if they wish to make representation on this matter.

I request:

- A condition that no children under 18 may be on premises after 9:00 PM unless for a private family booking
- Full safeguarding training for staff
- Alcohol off-sales to end by 9:00 PM
- Outdoor areas not to be used during school hours (8:00 AM-3:30 PM)
- Outdoor area to be moved to the back of the property.

5. The Reapplication to Hide the Applicant's Potential Criminal Background

This is a reapplication that has been done changing from the husband to the wife. I feel like this a strategic in order to not allow the police to make representation on the matter.

It came to light during the first application from people within the neighbourhood that the applicant is potentially locally known for having a drug related criminal record. I asked that South Yorkshire Police make representation regarding this in order to have a clearer and factual understanding. This application was then revoked and put in another name. While some grateful amendments were made it does appear to be a deliberate evasive manoeuvre given that this is a family run business according to

Wigtown media and there will still be involvement from the previous applicant as he is the sole business owner according to companies house.

Emotional and Ethical Impact

This application represents not just a planning error but an ethical failure. It prioritises commercial interest over the wellbeing of families, children, elderly neighbours and vulnerable people. South Street is not a commercial zone—it is a close-knit, quiet community.

Local residents are already reporting anxiety, stress and fear and I share this with them. If this licence is granted in its current form, many will lose sleep, property value, and peace. Children attending the infant school next door will be forced to walk past smoking patrons and littered pavements. Local women have expressed fear of walking home in the evening if intoxicated crowds gather outside their homes.

A business with this ethos—no bins for tenants, illegal curb parking and disregard for public lighting of the applicant has shown insufficient community values to be trusted with a latenight licence. I also think, as someone who works at 8:30am on New Years Day, that allowing the venue to open until 2:00AM is unreasonable.

The communication shared by Wigtox to local residents is also misleading and states that they do not want 'late night noise or disruption' and does not mention the outdoor elements. With all the will in the world, allowing a license so late noise disruption is inevitable and will negatively impact my quality of life. You can not expect to own a music and alcohol license for such late hours and uphold those assurances. I feel that the business itself is unclear and in allowing these licences, opens scope to abuse that will impact me as a local resident.

While I do not want the application to be upheld at all, I do require the following as a minimum:

Topic Requested Condition

Alcohol Hours Sales to cease at 10:00 PM weekends and 9:30PM weekdays.

Closing Time Premises to close by 10:30PM weekends and 10:00PM weekdays.

Security SIA-registered door staff required on Friday and Saturday evenings.

Clear distinction between the main road and the property using a clear

dividing boundary such as a fence.

Outdoor No seating at the front of the property onto the street.

Restrictions

Waste & Litter Bins provided inside and outside; nightly waste clean-up required.

Noise Control Soundproofing installed; no amplified outdoor music; enforce "quiet

dispersal."

Parking No customer parking on-street; designated taxi drop-off/pick-up point.

Children's Safety No under-18s on premises after 9:00 PM; safeguarding policy required.

Off-Sales Off-premises alcohol sales to cease by 9:00 PM.

New Years Eve To be closed on New Years Eve by 1:00AM and sale of alcohol to stop at

00:30AM.

I am writing on behalf of my household, as neighbour of the premises on South Street, to formally object to the licence application submitted by Mrs Helen Clayton for "Wigtox Lounge" at 33 South Street, Rawmarsh, S62 5RF.

We object to this application on the grounds that it undermines the following four licensing objectives set out in the Licensing Act 2003:

- The prevention of crime and disorder.
- Public safety.
- The prevention of public nuisance.
- The protection of children from harm.

The premises are located in a quiet, residential street not suited to late-night commercial use. The proposed licensable hours (Sale of alcohol (for consumption on and off the premises) on Sunday to Thursday between 12:00 hours and 23:00 hours, Friday and Saturday between 12:00 hours and 00:30 hours on the day following)

are inconsistent with local precedent. Late-night trading in a residential setting will attract patrons from other areas seeking extended drinking hours, increasing the likelihood of antisocial behaviour. The premises plan to sell alcohol both on and off-site, which raises serious concerns about street drinking and disorder after closing. Notably, the former pub on this site -The Ryecroft WMC, later renamed as South Street Social Club- was regularly attended by police due to alcohol-related violence, drug activity and disorder. These problems have had a lasting impact on the community, and there is understandable fear that history will repeat itself. There is currently no provision for door staff in the application. This is deeply inappropriate given the late-night hours. We request, at a minimum, that if plans go ahead, SIA-registered security staff be required on Friday, Saturday and Sunday nights until closure.

2. Public safety

Parking on South Street is already severely limited. The application proposes no parking provisions, despite plans to increase footfall and introduce residential units. 1:00 AM, obstructing the road at the T-junction and increasing the risk of accidents. Vehicles are already parked on grass verges, and Bisby Road is now being used as a car park; this is only expected to increase and worsen when the venue opens. Litter is already a major concern; the applicants' tenants were left without bins for a long period of time, and refuse regularly accumulated on the pavements and grassy areas as community bins were used. The addition of alcohol consumption and outdoor seating will only increase this hazard, especially without a clear waste management strategy. As a close resident, I have experienced first-hand verbal abuse from patrons of the previous establishment when I have asked patrons not to block my driveway or to remove their litter, some of which was frequently thrown onto my garden where my children play. History will repeat itself, placing such a venue in a residential area and breaching the peace.

3. Prevention of Public Nuisance

This development is wholly inappropriate for a residential street. Late-night music, intoxicated behaviour, outdoor smoking area, car and taxi noise and bottle disposal will all erode the community peace. This will affect not just sleep patterns, but residents' mental health and ability to work from home, especially those with caring responsibilities, disabilities or children. The building sits at a T-junction, amplifying and echoing voices and music into the street. Conversations from the venue will project into homes, many of which have bedrooms facing the street. For the 2 years my family lived here before the Ryecroft closed, we were unable to have our windows open during the summer due to the disruptions from patrons. Our children will have to once again endure hot summers without having proper ventilation due to the noise.

Furthermore, a front patio area with outdoor smoking and drinking areas will generate unacceptable levels of sound and disruption. There is no acoustic barrier, seating plan, or meaningful sound control proposed. Most homes in the area have families, shift workers, and retired residents. They are entitled to peace in their own homes. Equally, opening until 2:30 AM for New Year's celebration is unacceptable when there are working families in such proximity. A lounge has no reason to be open New Year's so late in a residential area. Since the closure of The Ryecroft WMC, the community have

benefited from a quieter residential area, improving community spirit and mental health. Theft and damage to properties have also decreased in the last five years, since the closure of the Ryecroft. Reopening an establishment that encourages disorder will only cause harm to the wider community.

4. Protection of Children from Harm

Perhaps the most serious ethical issue is the location of this venue, directly next to a primary school, Rawmarsh Ryecroft Infant School. The school accommodates children aged 4-7 years old. The proposed hours of the venue would overlap with school start and finish times during event set-ups, deliveries, and early-day alcohol service. Children will be exposed to;

- · Public drinking
- Loud music
- arguments, smoking and foul language from outdoor patrons

All the above points have been witnessed numerous times when the previous establishment was open, also parents drinking in the street before then entering the school to collect their children. As you can understand, the encouragement of this poses a safeguarding risk to the

children. I have also witnessed loud music when the school is open, potentially impacting the learning environment for young children. Rotherham council should be doing their utmost to safeguard all children from these environments, as it claims to be the children's capital of culture. Psychologically, these encounters have a lasting impression; indirectly encouraging a lifestyle centred around alcohol. As a community in partnership with the council, events like this should be learnt from and prevented for future generations. Alcohol off-sales until 00:30 creates the potential risk of street drinking within view of the school, which undermines Rotherham Metropolitan Council's duty to protect minors and protect residents from disruption within their homes. There are also other risks of underage proxy sales, heightened by the location and lack of permanent supervision.

5. Emotional and Ethical Impact

This application represents not just a planning error but an ethical failure. It prioritises commercial interest over the well-being of families, children, elderly neighbours and vulnerable people. South Street is not a commercial zone; it is a quiet community on a small, narrow street with no footfall other than residents. Local residents are already reporting stress, anxiety and fear over the prospect of a licensed establishment being opened. If the license is granted, many residents, myself included, will be at risk of mental health issues worsening, lack of sleep, peace and for many, a devaluation of their property.

Primary-aged children will be forced to listen to and walk by intoxicated patrons and littered pavements, including drug paraphernalia. Footfall and an increase in vehicles also impact the safety of children crossing roads. Women have expressed their fear of walking past the establishment in the evening when large crowds of intoxicated men are present outside. Previously, crowds would shout profanity at women, including me, as we walked past the establishment. I suffered numerous panic attacks in the short time of living near the old establishment before it was closed. The current applicant's

business ethos (no bins for tenants, illegal curb parking, disregard for public lighting and community feedback) has shown insufficient community values to be trusted with a latenight licence. The term 'Lounge' is misleading; this venue and the capacity within the licence permit have the potential to cause serious harm to local residents who have experienced calm and peace since the closure of the previous establishment. The application for such a late-night venue in a residential area is also not in line with other licenses held nearby in less residential areas. It is highly unreasonable to expect local residents to endure late hours of chaos and disruption. I urge the council to take action, visit the site, speak to residents, and support local residents.

I would also like to direct your attention to the Environmental Protection Act of 1990. Within the legislation, it states that councils have a duty to protect residents,

- unreasonably and substantially interfere with the use or enjoyment of a home or other premises
- injure health or be likely to injure health

Granting a licence permit would go against the legislation, and evidence of this has been highlighted several times throughout the email. Residents will be limited to the enjoyment they can have in their homes and gardens due to the invasion of privacy from patrons of the establishment. Injury to health includes mental health; unruly and disruptive behaviour late-

night, especially, and disruption to sleep patterns, heckling of residents in their gardens or walking past are all factors that would damage the psychological well-being of residents.

A social media campaign to gain votes in support of the license is now underway; my concern is that these residents do not live in direct line of any issues that would arise from the opening of a late-night venue, therefore, their support, unless in close vicinity, should not be counted. A license to serve alcohol is not needed to open what the owners claim to be a community space. Enjoyment can be had and profit made without the sale of alcohol or late-night opening hours. As the council supports making Rotherham the children's capital of culture, the encouragement of alcohol sales in an area that also looks to serve children is not in line with promoting the psychological well-being of the children of Rotherham.

Also, in terms of it being a community space, there has been no attempt made to speak with local residents and address the issues. Flyers have been posted only to select residents, giving the impression that the current owners do not understand how far of an impact the late-night hours have on residents; it is not just those on South Street who are affected.

In summary, the objections made are against a late night venue and an alcohol license. the objection is made as it does not fit with the current environment.

As residents, we appreciate your consideration and urge the Licensing Authority to protect our residential amenity, uphold its policies. Please do not allow this application to set a precedent that fundamentally changes the character of South Street, the surrounding streets and would undoubtedly place the community at risk. I also object to the plans to have an outdoor seating area alongside the public footpath (without any fencing/gating) to prevent it being misused outside of opening hours.

The outdoor seating area will cause an increase of noise outside the venue, causing disruption to residents and potentially to the school right next door.

It also opens up the possibility of misuse by patrons/locals before or after closing.

The applicant has been very vocal with leaflets, posters and social media posts regarding their desire to be a family friendly venue and a place for the community whilst omitting information that may create objections and asking people from the wider area to email their support without being fully informed as to the applications details and requests being made.

I do not agree such opening times and outdoor drinking will contribute to such a family friendly environment, especially when it will cause so many potential disruptions to the families that live close by.

Whilst I appreciate my next comments are not directly related to this licence application I feel it necessary to mention, the venue in it's former existence was a know hotspot for antisocial behaviour, crime and drug related incidents, all of which are documented by the police. I have concerns (especially after posts on social media) that it will attract the same former clientelle especially with late evening drinking hours, and cause further problems for local residents.

My personal preference would be that the venue not be allowed to open for alcohol sales past 10:30/11pm in line with other local venues and that due to venues history the owners/managers hire security/door staff particularly on Friday and Saturday nights to ensure client behaviour is maintained and residents are not overly impacted.

I would also like to see the applicants implement a cut off time for minors to be on the premises (in line with almost all other child friendly alcohol venues).

WRITTEN SUBMISSION ON BEHALF OF THE APPLICANT

- This is an application for a new Premises Licence pursuant to Section 17 Licensing Act 2003. However, a premises has traded on this location for many years and has been a public house and previously a Working Men's Club (WMC).
- 2. The premises historically traded as a large WMC with an occupancy of 1000 or so persons. Following the demise of the WMC, the premises operated as a separate venue. Both venues focused upon the provision of live and recorded music, large scale events, even pantomimes and was very popular. Since the cessation of trading, the premises has been empty and was becoming derelict. The premises has been purchased by Mr & Mrs Clayton.
- 3. Mr & Mrs Clayton have undertaken significant capital investment into the premises. However, they were aware that the operation of a 1000 occupancy premises in a residential area was not appropriate and potentially not commercially viable. They have therefore diversified the nature of the premises. Please see item 1. of the Bundle colour coded plan.
 - Edged blue this is now residential accommodation comprising of three bedsits along with two separate lets taking over 50% of the previous licensed
 - Edged orange Beauty and treatment rooms sunbeds and therapies.
 Approximately 20%.
 - Remainder approximately 25% to 30% allocated to back of house, mutual toilet facilities and licensed area including bar and coffee bar servery, with ice cream parlour offer.

- 4. The Committee are also referred to the Bundle submitted by the Applicant and in particular photographs of the interior and exterior of the partially refurbished premises.
- 5. During the drafting of the application, the Applicant worked closely with the Licensing Authority and took recommendations from South Yorkshire Police and it should be noted that there is no representation from South Yorkshire Police as to the application.
- 6. During consultation representations were received from Licensing and Environmental Health. Representations from many residents were received, some of which should be noted to be direct duplications of each other and raising matters relating to other jurisdictions, in particular Planning and Highways' matters.
- 7. The Licensing Sub Committee is asked in their deliberations to consider the weight of such representations and only take note of matters under the Licensing Act 2003.
- 8. Prior to the refurbishment the premise had no kitchen function. One of the principal offers of the property going forward will be the coffee bar and ice cream parlour which is designed to provide alternative offer to the traditional public houses in the area and sit more closely with the community and those persons frequenting the premises for beauty treatments. The significant reduction in size of the premises and the new layout does not lend itself to the undertaking of large scale events, it is anticipated that the new occupancy level will be approximately 250 person, furthermore unlike in the past there is no formal stage or performance area and this space will only facilitate the provision of entertainment by smaller groups duos or solo artists. Regulated entertainment has been applied for but is not the principal focus of the operation of the venue.

The Licensing Objectives

- 9. Central to the statutory regime are the four licensing objectives which are the only relevant areas for consideration and licensing objectives. They are as follows
 - Prevention of crime and disorder.
 - Public safety
 - Prevention of public nuisance.
 - Protection of children from harm.

- 10. The new proposed licensed premises has been designed to provide a pleasant environment for those attending but also protect the amenity of third parties. Points have been raised in relation to the area to the front of the premises. This is limited in space and it is to be noted that the historic roof terrace will not be used. The front area will not operate beyond 23:00 and is covered by 4 CCTV cameras along with direct supervision from the coffee bar servery. When in use, will also have the benefit of frequent glass collectors.
- 11. Within the design of the premises, the amenity of those persons residing approximate to the property being existing residents or those at the converted residential accommodation have been prioritised with acoustic insulation being installed within the building to the satisfaction of the Planning Department, item 6 in the Bundle and closing of windows to the side of the premises from which noise breakout may take place. Please see Bundle photo 2 e. The operating statement contains a number of robust conditions agreed with the Licensing Authority prior to submission.

The Guidance

- 12. Under Section 182, the Secretary of State is required to issue Guidance to Licensing Authorities on the discharge of their functions under the Act. Section 4(3) requires Licensing Authorities to have regard to the Guidance.
- 13. So whilst the requirement to have regard to the Guidance is binding on Licensing Authorities, paragraph 1.9 of the Guidance recognises that :

"This Guidance cannot anticipate every possible scenario such as circumstances that may arise and, as long as Licensing Authorities have properly understood this Guidance, they may depart from it if they have good reason to do so and can provide full reasons.

Departure from this Guidance could give rise to an Appeal or Judicial Review and the reasons given will then be a key consideration for the Courts when considering the lawfulness and merits of any decision taken".

The Application Process

14. Section 17 sets out the procedure for applying for a new Premises Licence Application.

The Role of the Police, Licensing and EHO

- 15. At paragraph 9.12 of the Guidance it is stated that in their role as a Responsible Authorities, the EHO and Police are experts in their fields and will be the licensing authorities main source of advice. The Licensing Authority must determine on an evidential basis and justified on the evidence before it and not take into account the evidence that is not before it.
- 16. The Licensing Team and Police by pre-consultation are content with the proposed application. A representation was received from Alan Pogorzelec, the Licensing Manager, in discussions with the Manager the principal concern were as to the monitoring of the external area and problems which arose when the premises was operated previously but in a fundamentally different way. Conditions have been proposed to the Licensing Officer which I will set out at page 3 of the Bundle and that representation is now expected to be withdrawn.
- 17. The Applicant has endeavoured to speak with the Environmental Health Officer with regard to the content of the representation and particularly how it conflicts with that put forward by the same department in relation to the Planning Application please see Bundle item 6. The nearest noise receptors will be the residents within the converted part of the premises and it is considered that there is no potential risk to them. Additional sound insulation has been provided to the premises in the form of double glazed windows, well fitting doors and a removal of windows adjacent to residential accommodation. It is considered that the nature of the premises, the level of attenuation, conditions already tendered sufficiently promote the licensing objective over the prevention of public nuisance.

Representations

- 18. A significant number of representations have been received from residents and two Councillors. In respect of those representations, the Applicant would respectfully submit to the Licensing Authority the following points.
 - The current application should not be compared to the operation of the former WMC or public house, the Applicant being different, the licensed space being materially reduced and the basis of the overall operation completely different.
 - Public Nuisance the potential for noise nuisance from large numbers of persons dispersing from the premises simultaneously is significantly reduced by virtue of the fact that the premises will not be undertaking "turns" nor attracting the same volume of persons.

- Litter the premises has already committed to and undertaken responsibility for litter in the area. The complaints indicate the existence of prior to opening of the premises and thus, the premises cannot be responsible for that.
- Proximity to patio and children the premises itself and outside area will be
 well monitored and managed. The premises is designed to be family friendly
 and welcoming particularly to females and families with young children. There
 is no evidence to support the allegation that the presence of the property with
 a licence will generate aggressive behaviour or abusive language. Suitable
 barriers have been ordered so as to delineate the extent of the external area.
- Operation of beauty treatments there is strict licensing around the undertaking of various treatments and these will be required to be complied with.
- Parking is a matter in respect of which Planning is a principal input.
- Security- high quality CCTV system and security system installed.

Determination of the Application

- 19. The Applicant requests the Licensing Sub Committee to consider the quality of the evidence raised in opposition to the new licence. The Licensing Sub Committee is also referred to photos of work and nature of the layout.
- 20. The Applicant respectfully submit that the Licensing Authority must take note of the Guidance issued under Section 181 of the Licensing Act.
- 21. Relevant extracts from the guidance are as follows:
- a) All licensing determined should be considered on a case by case basis (9.42).
- b) The Authorities determination should be evidence based justified as being appropriate for the promotion of the licensing objectives and proportionate to what it is intended to achieve (9.43).
- c) Para 9.12 continues to confirm the Licensing Authority should accept all reasonable and proportionate representations made by the Police unless the Authority has evidence that to do so would not be appropriate for the promotion of the licensing objectives. However, it remains incumbent on the Police to ensure that their representations can withstand the scrutiny to which they would be subject at a hearing. This equal applies to representations raised by third parties.

- d) Para.9.44 Determination of whether an action or step is appropriate for the promotion of the licensing objectives requires an assessment of what action or step would be suitable to achieve that end. While this does not therefore require a licensing authority to decide that no lesser step will achieve the aim, the authority should aim to consider the potential burden that the condition would impose on the premises licence holder (such as the financial burden due to restrictions on licensable activities) as well as the potential benefit in terms of the promotion of the licensing objectives.
- e) Para 10.10 The 2003 Act requires that licensing conditions should be tailored to the size, type, location and characteristics and activities taking place at the premises concerned. Conditions should be determined on a case-by-case basis and standardised conditions which ignore these individual aspects should be avoided.
- 22. The Licensing Authority should therefore ensure that any conditions they impose are only those which are appropriate for the promotion of the licensing objectives, the Applicant contends that the conditions in the Application Bundle at item 3 promote the licensing objectives.
- 23. It is the Applicant's submission that the Licensing Committee should they consider not granting the application question as to whether this is on the basis of real evidence or speculation and whether the decision falls within the criteria set out in the case of Daniel Thwaites (2008 EWHC 838).





I write with reference to the above application to which I received consultation papers on 31 July 2025, and would report as follows:

i) Consideration

I have examined the planning application and associated documentation. This is for the consolidation of the existing social club into a smaller facility, but with the addition of beauty treatment rooms and sun bed pods (Use Class Sui Generis), 2No. self-contained flats and 3No. bedsits (Use Class C3 Dwellinghouses). This also includes external alterations to the building including replacement of the external staircase and screening to the existing outdoor seating area at 33 South Street, Rawmarsh. The site is located within a residential area. Having previously visited the site and looked at the plans it is evident that there is adequate seperation between the habitable rooms of the residential accommodation and the club/treatment rooms. Further to this, all habitable rooms are located away from the main club/treatment rooms.

ii) Conclusion

Given that the club is existing and will have a Premises Licence issued by the Licensing Authority, then I do not foresee any issues with the proposal.

In relation to the bedsits, there is specific legislation and requirements which must be complied with as it may be fall into the category of being a Houses in Multiple Occupation (HMO). It is also possible that a HMO licence may need to be obtained from the Local Housing Authority.

iii) Recommendations

In light of the above, I would ask that if planning permission is granted in relation to this application that the applicant is directed to the Housing Licensing Team, Community Protection Unit as detailed below:



I've had the chance to speak with the owners on a few occasions while walking past, and they've always been happy to explain what they're doing, listen to feedback, and answer questions from locals. I am a local workman who works on South Street on a regular basis and also drops my daughter off at the school there, so I see the traffic situation first-hand on a daily basis.

From my own experience, I honestly cannot understand how anyone can say this proposal will have a negative impact on traffic. Outside of school drop-off and pick-up times, the street is incredibly quiet — you are lucky if you see five cars drive up or down it. The only busy periods are during the school runs, and even then, the traffic lasts for no more than 15–20 minutes twice a day. If I'm being honest, those short bursts of school-related traffic are a far bigger contributor to congestion than anything this proposal would cause.

My family have run pubs all my life, and I know first-hand that this is a dying trade because everything seems to be against them. Landlords have to move with the times to keep trade and business going, and this proposal is a perfect example of doing just that. It's about adapting, diversifying, and creating something that can survive in today's climate.

For those reasons, I fully support this application. It will bring life back to an underused building, create jobs, provide services for the community, and keep a local business alive — all without causing the issues some have claimed.

- 1. Subject to condition 2, no person shall be admitted to the premises after 23:00hrs.
- 2. Condition 1 will not apply to persons that were present in the premises at any point between 22:45hrs and 23:00hrs
- 3. The DPS or premise licence holder will risk assess the need for door supervisors to be employed at the premises. If such a risk assessment indicates that door supervision is required, then a minimum of two SIA door supervisors are to be employed at the premises at any particular time (as determined by the risk assessment).
- 4. Unless a risk assessment indicates otherwise, on days when higher risk activities are taking place at or in the vicinity of the premises then at least two SIA door supervisors are to be employed at the premises during the hours that the higher risk activities are taking place. A higher risk activity would be one that could reasonably be expected to result in a significant increase in the number of people attending the venue and / or a change in the nature or behaviour of the people that attend the venue when compared with what would be expected had the activity not been taking place (for example a major sporting event).
- 5. When carrying out a risk assessment regarding the provision of door supervisors, the licence holder and / or DPS should have regard to any information provided to the licence holder by the Licensing Authority, South Yorkshire Police or any other reliable source of information.
- 6. All door supervisors when working shall wear a uniform which clearly identifies them to the public as door supervisors, wearing high visibility jackets or vests.
- 7. A register shall be maintained for persons engaged as door supervisors to include the name and SIA number of the staff. SIA to be briefed as to details of any events and to record the time and dates of deployment including start and finish time. The register is to be retained onsite for a period of at least 12 months.

- 8. A written copy of any risk assessment referred to in these conditions must be retained for a period of at least 12 months and available for inspection at the premises by any authorised officer.
- 9. In addition to being monitored by the CCTV system, the external areas to which patrons have access whilst using the premises will be directly monitored via the coffee bar servery window and the use of glass collectors for both internal and external areas.

Consequential removal from application form of:

- It is considered that, for the nature of the operation of the premises, door supervisors will not be ordinarily required. However, the use of door supervisors shall be risk assessed on an event-by-event basis. A written record of this risk assessment shall be kept on the premises, for a minimum of 6 month, and made available to the Police or an Officer of the Licensing Authority upon request.
- Where engaged, door staff shall be licensed by the SIA

Other Person 1

As for anyone in rawmarch having a say in this, surely someone from more than 2 streets away should t have a say, as it won't effect them in anyway. Seems to me that the mention on social media got anyone from Rawmarsh to support it. That is clearly wrong.

If this is allowed to be open until stupid hours, can the council please offer to buy my house at full market value, pay for moving as it will make our lives unbearable, especially living with social and mental issues. Not that the council will care as they dont live across from it.

They shouldn't be allowed anything past 10pm full stop.

Also most of the people who have voted in favour of the establishment don't live on South street and have just come from what they have seen online. They haven't ensured the issues what a drinking establishment brought on to south street.

Us, that have objected to it have physically witnessed the uproar it will bring as we formally had to ensure issues when it was previously a drinking establishment.

Other Person 4

My original application still is relevant however please see my personal response to the bundle to support continued concerns a request for changes made to the license:

The Applicant has raised concerns about similarities in residents' representations. Any queries can be confirmed directly with the Licensing Authority, which holds the original submissions and can verify their authenticity.

The Applicant distinguishes this application from the former Working Men's Club by citing reduced capacity (approx. 250). However, the previous operation failed due to insufficient footfall. Residents recall that attendance rarely exceeded 250, yet police were frequently called for crime, disorder, and nuisance. A reduction in capacity does not safeguard against such issues (Licensing Act 2003, s.4).

The Applicant claims to offer a "family-friendly" environment, but a request to sell alcohol until 1am contradicts this. Government Guidance (s.182 Licensing Act 2003, paras. 2.22–2.26) stresses that protecting children from harm requires earlier terminal hours. Late alcohol sales increase risks of nuisance, disorder, and harm to children.

Noise concerns are not limited to residents in newly converted properties. Objections have also come from surrounding homes, which were previously affected. This resident recalls regular disturbance from noise inside and outside the premises, often requiring police intervention. Preventing public nuisance is a key licensing objective (s.4(2)(c)).

Litter issues cannot be dismissed. Since conversions began, there has been increased litter, and for a time, the Applicants failed to provide proper waste facilities, causing nuisance and rodents. Rotherham council should be able to supply information regarding this through freedom of information if the applicant so wishes.

Unlike previous proprietors, the Applicants propose outdoor seating, heightening risks of children encountering intoxicated patrons. The type of barrier to separate the area remains undefined, leaving risks inadequately mitigated (s.182 Guidance, paras. 2.21–2.29).

The Applicant's photographs do not accurately show the proximity of nearby housing. The Licensing Committee should give limited weight to images that fail to reflect the real residential impact (Hope & Glory [2011] EWCA Civ 31).

The Applicant seeks to sell alcohol until 12:30am with closing at 1am. Such hours are unsuitable for a quiet residential street. Licensing authorities must promote the objectives of preventing public nuisance and protecting children from harm (Licensing Act 2003, s.4). Government Guidance (s.182, paras. 14.51–14.64) supports earlier terminal hours in residential areas.

Case law confirms this approach:

- Hope & Glory [2011] EWCA Civ 31 Licensing Authorities may give decisive weight to resident impact.
- Thwaites v Wirral [2008] EWHC 838 Refusal upheld on public nuisance grounds.
- East Lindsey DC v Hanif [2016] EWHC 1265 Restricting hours justified to prevent nuisance.

Local precedent also supports refusal. Nearby venues such as Rawmarsh Tap operate with 11pm terminal hours. Granting later hours would encourage anti social behaviour and disturbance.

Even with a condition barring new entrants after 11pm, serving alcohol until 12:30am and closing at 1am remains disproportionate and incompatible with this residential location. Licensing Authorities must prevent nuisance before it arises. Case studies, including Claire's Kitchen in Sheffield, show significant disturbance from later hours. The Applicant has proposed no robust noise management.

This application risks undermining all four licensing objectives. It fails to demonstrate how these will be upheld. In light of statutory duties (s.4 Licensing Act 2003) and case law (Hope & Glory, Thwaites), granting hours beyond 11pm would be inappropriate and disproportionate.

The Sub-Committee is respectfully invited to refuse the application, or at minimum, restrict alcohol sales to 11pm with strict security, outdoor and waste management conditions.

Other Person 5

It is also noted that in the solicitors letter it is claimed that the original club could hold 1000 people. This is totally wrong as the club was small and the main room could not accommodate more than 200 people.

- 1. Subject to condition 2, no person shall be admitted to the premises after 23:00hrs.
- 2. Condition 1 will not apply to persons that were present in the premises at any point between 22:45hrs and 23:00hrs
- 3. The CCTV system installed at the premises, shall:
 - a. be maintained fully operational and in use at all times that the
 - b. premises are open;
 - c. make and retain clear images;
 - d. show an accurate date and time that the images were made; and
 - e. cover the inside the premises and the externa front patio.
- 4. CCTV systems installed after 2021 should be a full digital systems with wide dynamic range IP cameras (WDR).
- 5. All CCTV images shall be retained for a period of not less than 31 days.
- 6. The CCTV footage shall be controlled and kept in a secure environment to prevent tampering or unauthorised viewing. A record will be kept of any person who accesses the system, the reason why and when.
- 7. A member of staff who is trained to operate the CCTV system, review images and supply footage will be present at the premises at all times when licensable activities are taking place.
- 8. CCTV images shall be immediately made available for review upon request of the Police or an authorised officer of the Licensing Authority for purposes in connection with the prevention and detection of crime and disorder, in line with GDPR guidance.
- 9. A copy of a CCTV image shall be provided within 24 hours upon request of the Police or an authorised officer of the Licensing Authority.
- 10. Suitable signage informing customers that CCTV is in operation shall be displayed in prominent positions inside and outside of the premises.
- 11. A record shall be kept of each member of staff who is authorised to sell alcohol and shall include the staff members full name, address, and date of birth. This record shall be retained on the premises and made available for viewing on request of the Police or an authorised officer of the Licensing Authority.
- 12. A Challenge 25 Policy shall be in operated. This Policy shall require that any person who appears to be under the age of 25 must provide ID prior to being served alcohol. Acceptable forms of ID are a:
 - a. passport;
 - b. UK photo driving licence; or
 - c. military ID card.

- 13. All refusals made under the Challenge 25 Policy shall be logged in a bound book. This log must show:
 - 14. date of refusal made;
 - 15. member of staff who made the refusal; and
 - 16. if refused, whether fake ID was seized.
 - 17. Signs notifying customers of the operation of the Challenge 25 scheme shall be displayed at the entrance to the premises and at each point of sale.
- 18. A bound incident book shall be maintained, in which the following shall be recorded:
 - a. incidents of crime and disorder occurring at the premises (both inside & outside), which shall include the date and time of the incident; and
 - b. any action taken, including if the police were called.
- 19. The Challenge 25 log and the incident book shall be kept on the premises and shall be available for inspection upon request of the Police or an authorised officer of the Licensing Authority.
- 20. The DPS, or their nominated deputy, shall check the Challenge 25 log and the incident book at least once a week, and sign and date each check.
- 21. There shall be a zero-drug tolerance policy in operation at the premises, which shall include the requirement that regular checks are carried out by management to prevent the use of drugs by patrons; and that such checks are recorded.
- 22. A copy of the premises drugs policy, and associated records, shall kept at the premises and made available to the Police or an authorised officer of the Licensing Authority upon request.
- 23. The premises shall operate in accordance with the "ask Angela scheme" and notices to this effect shall be displayed.
- 24. The DPS or premise licence holder will risk assess the need for door supervisors to be employed at the premises. If such a risk assessment indicates that door supervision is required, then a minimum of two SIA door supervisors are to be employed at the premises at any particular time (as determined by the risk assessment).

Unless a risk assessment indicates otherwise, on days when higher risk activities are taking place at or in the vicinity of the premises then at least two SIA door supervisors are to be employed at the premises during the hours that the higher risk activities are taking place. - 33. Customers shall not be permitted to use the roof top terrace or the area to rear of the premises (car park) for the outdoor consumption of alcohol, food and non-alcoholic drinks at any time, nor will they be permitted to smoke in these areas.
- 34. Children 12 years and under must accompanied and supervised by a responsible adult at all times, both inside & outside of the premises.

- 35. No children, that is any person under 18 years of age, will be permitted to remain on the premises (both inside or outside) after 22:30 hours unless accompanied and supervised by a responsible adult and attending a pre booked family function or similar event.
- 36. The premises will display a proxy notice in a prominent position explaining that it is an offence for adults to purchase alcohol and then supply it to persons under 18.
- 37. No signage or advertising for any special treatment provided in the adjoining treatment/therapy rooms shall be on display within the licensed area of the premises.
- 38. No adult entertainment or services shall be provided at the premises.
- 39. The DPS shall routinely attend meetings of the local Pubwatch scheme.
