ROTHERHAM BOROUGH COUNCIL - REPORT TO MEMBERS

- **1. Meeting:** Cabinet Member and Advisers, Education Culture & Leisure Services.
- **2. Date:** 6th July 2004.
- 3. Subject: Annual Library Position Statement
- **4. Originating Officer:** Guy Kilminster, Libraries, Museums & Arts Manager (Extension 3623)
- **5. Issue:** To inform Members of the requirements of this year's Annual Library Position statement and progress against Public Library Standards.
- **Summary:** The Department of Culture, Media and Sport requires all Public Library Authorities to submit a Position Statement. The assessment of the Statement will contribute to the CPA/RPA scores for the Council.
- 7. Clearance/Consultation: The report has been approved by the Acting Executive Director of Education, Culture and Leisure and the Strategic Leader, Culture, Leisure and Lifelong Learning.
- **8. Timing:** The Position Statement has to be submitted to the Department of Culture, Media and Sport by the end of September 2004.
- **9. Background:** 'Framework for the Future...' published in 2003, set the Government's vision for the public library service, and identified the key elements of transformational change necessary to ensure libraries were fit for the 21st Century. The introduction of Public Library Standards in 2001 set the agenda, identifying the minimum standards expected of a public library service.

The Council's investment in the Library and Information service has led to the Service now meeting 19 of the 26 Standards (compared to 5 three years ago), with significantly improved performance in another three. The graphs in appendix 1 illustrate the improvements achieved.

In addition users satisfaction with the Service has improved. The BVPI 118 returns for 2003/04 were:

- a. Found a book to borrow 79.3% (target 65%)
- b. Found the information they were looking for 75.6% (target 75%)
- c. Were satisfied with the library overall 93.9% (target 75%)

The BVPI 117 (also a Public Library Standard) is a measure of visitors to the libraries over the last 12 months and this has risen by 20% (based on the CIPFA Plus survey) to 4945 usages per 1000 population. Despite the increase, there is still more to be done as the BVPI top quartile is 6295 and the target to meet Standard is 6000 (although the Government has indicated that this may be reviewed as it has been set at an artificially high level).

- **10. Argument:** The additional investment by the Council has made a significant difference to the Service. The key contributors to the improved usage and satisfaction ratings that will be reported in the Position Statement are:
 - A book and materials fund that is ten times what it was in 2000 and has allowed the renewal and increase in range of stock on the library shelves.
 - Extensions to opening hours
 - The successful installation of the Peoples Network offering free access to the internet
 - Completion by all library staff of the European Computer Driving Licence to improve service to computer users
 - The appointment of a Children's Champion to drive improvements in library services for children for example the new children's area at Maltby Community Library.
 - Increased focus on activities and partnerships to highlight the role of libraries as community venues and information centres.
 - A range of marketing and promotional activity to promote the improvements (for example distributing an invitation to join the library to 27,000 school children).

There are, however, key areas of further improvement required to ensure the Service achieves the usage targets set. In some instances these are resource problems, in others a lack of recognition of the role of libraries as tools that all RMBC Programme areas can make use of to improve service to customers. The Position Statement will identify the following areas as priorities for action for 2005/06:

- The exterior appearance of most community libraries is very poor with repairs and decoration required. This can act as a deterrent to potential users. Signposting to find the library within the community is largely absent.
- Similarly many library interiors are in need of new carpets, lighting and shelving.
- Although 1200 extra opening hours are in place, further extensions are required to meet the Public Library Standard. This is obviously an additional staff cost.
- A significant marketing campaign (similar to the launch of Streetpride) needs to be planned, resourced and undertaken.
- The promotion and usage of libraries by other Programme Areas as a place that customers can use to e-mail the Council for free, or access any other web-based facility that we can bookmark or direct customers to.

- The promotion of library services to other groups, bodies, agencies and individuals that other Programme Areas have contact with.
- The use of libraries as venues in many communities for promotions, surgeries, drop-ins to increase levels of awareness and participation in other Council activities
- The use of non-building based library services that reach other excluded groups (elderly, disabled, ethnic communities, etc.) to raise awareness, inform and seek feedback about other Council services.

As part of the Planning process the Service would like to brief Members at a Member's seminar before the end of September and involve nominated Members in a Planning workshop in July. These events have in the past proved invaluable in defining and reefing the services we have on offer.

11. Risks and Uncertainties: The national trends for usage of libraries and particularly the number of books issued, has not been encouraging over the recent past. This has been reflected in the drive, led by the Department of Culture, Media and Sport, to improve performance across a range of activities within libraries.

Although usage in Rotherham has increased this year, book issues are down (however, the rate of decline has been substantially reduced). Clearly the Service is determined to drive up book issues and reverse this trend. The investment, improvements to the Service and marketing and promotion need to be sustained and grown with regular impact reports produced to ensure that book issues do increase. The increased usage referred to above is a combination of users accessing the Peoples Network or attending events and activities in the libraries. One of the challenges is to convert these users into active borrowers as well.

12. Finance: During financial year 2000/01 it was determined that investment of £800,000 in Rotherham's Library Services was required in order to meet Library Standards. A large proportion of this investment (£725,000) was made between 2001/02 and 2003/04. However, withdrawal of Neighbourhood Renewal Funding of £50,000 from 2002/03 to 2003/04 from the mobile library service has resulted in a total deficit against this required investment of £125,000. This £125,000 funding shortfall means that additional opening hours to the public cannot be provided and improvements against the eight stock related Standards will be slower than anticipated.

It is envisaged that additional investment will be required from April 2005 when the new Library Standards are published and this is reflected in the Medium Term Financial Strategy (£100,000 in 2005/06 and £100,000 in 2006/07).


In order to make the Service more attractive to users and potential users, significant capital investment in Library buildings is required. The Service does however maximise opportunities to invest in the Library Service when they arise. For example, through planning gain and a partnership with the Primary Care trust at Brinsworth.



Further increases are required to meet the Public Library Standard for usage and plans are in place to sustain and improve the usage over the next two years. Some additional resources primarily for capital investment and recognition of the Service as a corporate resource would speed up the rate of increase.


