5. Summary

The Council advertised three vacant posts for Independent Members of the Standards Committee. The applications were considered and applicants interviewed by an Independent Panel comprising Mr. Don Latham, Independent Chairman, The Reverend Canon Jane Sinclair, the Vicar of Rotherham and Mr. George Trow, Principal of Rotherham College of Arts and Technology. The Panel recommended that the three vacant posts be filled.

6. Recommendations

- 1. That Mrs. A. Bingham and Messrs. I. Daines and J. Maric be appointed as an Independent Members of the Standards Committee for a term of four years.**
- 2. That the Council extends its thanks to Messrs. M. Shelton and A. Stanley as retiring Independent Members of the Committee, for their time and valuable contributions whilst acting as Chairman and Vice-Chairman of the Committee.**

7. Proposals and Details

The Council's Standards Committee comprises six Independent Members, four elected members of the Council and one Parish Council representative.

The appointment of Independent Members must be approved by a majority of the Council. The posts must be advertised in at least one newspaper and be of persons who submitted an application to the Council, have not within the previous five years been a Member or Officer of the Council, and who are not relatives or close friends of Members or Officers.

The retiring Chairman and Vice-Chairman of the Committee were appointed for a term of office which expired in August 2006. There is also a casual vacancy for a third Member. Following an unsuccessful attempt to recruit last Summer, the Council agreed to extend the terms of the Chairman and Vice-Chairman until 31st December 2006. The three vacancies were advertised again in the Autumn.

Applications have now been considered by Members of the Council's Independent Remuneration Panel, as previously, and interviews were held on 6th December 2006 and 8th January 2007.

The Panel has recommended the appointment of Mrs. A. Bingham and Messrs. I. Daines and J. Maric. Brief details of the three Independent Members proposed are attached as an appendix to this report.

It is recommended that the proposed new Independent Members be appointed for a term of four years. The remaining three Independent Members are due to retire during 2008, when their posts will be advertised. This enables the Council to continue to seek expressions of interest in performing the role on a fairly regular basis.

8. Finance

The Independent Members will be eligible for travel and subsistence in accordance with the Council's scheme.

9. Risks and Uncertainties

The appointment of Independent Members is a statutory requirement.

Training will be provided for those Independent Members sitting on the Committee for the first time, to cover the Committee's roles and responsibilities.

10. Policy and Performance Agenda Implications

The advertisement specified that the Independent Members should broadly represent the local community in terms of gender, race and age. It stated that applications from women and members of the ethnic minority communities were particularly welcome.

The inclusion of Independent Members on the Committee increases public participation in the Council's affairs. It supports democracy by upholding the high standards of conduct that the public expects from the Council.

Mrs. A. Bingham

Mrs. Bingham currently works as a self-employed research/management consultant and is a former higher executive officer at the Telephone Managers Office in Sheffield. He was formerly a Parent Governor of his local school, Secretary of Thorpe Salvin Village in Bloom Group and Chair of Great Britain Police Life Saving Committee.

Mr. Maric is Corporate Development Manager with the Music Factory Entertainment Group. He has a background in commercial and human resources management. He sits on the Representation Council of Rotherham Chamber of Commerce and on various working groups of the Chamber. He works closely with several schools and is Chair of a forum to raise additional funds for Macmillan Cancer Relief within the South Yorkshire Coalfields area.
