CORPORATE IMPROVEMENT BOARD 8th September, 2008

12. MINUTES OF THE PREVIOUS MEETING HELD ON 7TH JULY, 2008

13. NATIONAL INDICATOR SET

Matt Gladstone, Assistant Chief Executive, presented the submitted report outlining the new national indicator set containing 198 indicators introduced in April, 2008.

At this stage it was not possible to report on the vast majority of the new measures. The submitted paperwork identified the ownership of each measure, who would report on each measure, and where possible whether or not mechanisms were in place to facilitate such report, when the data and mechanisms would be available and whether the measure was included in the Corporate Plan and under what theme. Work was ongoing to provide the missing information, particularly with regard to when the performance data would be available.

Discussion and a question and answer session ensued and the following issues were covered:-

- monitoring/reporting arrangements
- need for baseline information
- assessment of new indicators later in the year
- identification of indicators by directorate, cabinet member and scrutiny panel
- aligning of the indicators to the Medium Term Financial Strategy and service planning

Resolved:- (1) That the information be noted.

(2) That the indicators be broken down and highlighted in respect of the responsible directorate, cabinet member and scrutiny panel.

14. CONSULTATION PAPER - JOINT CONSULTATION COMPREHENSIVE

AREA ASSESSMENT

Matt Gladstone, Assistant Chief Executive, presented the submitted report indicating that, following on from earlier consultation on the general principles and approach to Comprehensive Area Assessment (CAA), inspectorates had now published their second joint consultation paper setting out more detailed proposals for CAA. CAA would be introduced with effect from April, 2009 with the first public reports published in November, 2009.

The report summarised the key elements of the consultation on CAA, including proposals on what the assessments would look like, how evidence would be gathered and how the CAA would be delivered. It also highlighted the questions the Audit Commission was requesting responses to from local authorities. The deadline for consultation responses was 20th October, 2008.

The report covered:-

- changes made in response to feedback on previous consultation
- how CAA would be undertaken
- the Area Assessment
- the Organisational Assessment
- reporting CAA
- inspections and improvement planning
- CAA timescales
- next steps
- responding to the consultation
- initial views on issues arising from the consultation

Discussion and a question and answer session ensued and the following issues were covered:-

- CAA would evolve and would not be finalised when going live in 2009
- CAA would be less inspection and more self-assessment based
- focus would be on LAA, new 198 national indicator set, Corporate Plan, resources and delivery

CAA would be more forward than backward looking

Resolved:- (1) That the information be noted.

- (2) That the summarised proposals contained within the CAA consultation document and the timescales for responding were noted.
- (3) That a progress report be submitted to the next meeting identifying corporate areas to be considered, including use of resources.

15. CPA DIRECTION OF TRAVEL (DOT) STATEMENT 2008

Lorna Kelly, Corporate Improvement Manager, presented the submitted report relating to the above. The DOT Assessment was part of the Comprehensive Performance Assessment (CPA) framework. DOT provided assurances each year about whether arrangements were being made to secure continuous improvement.

5. Summary

In October 2007 as part of the Comprehensive Spending Review (CSR) Government published a consultation document outlining a new single set of 198 national indicators for English local authorities and local authority partners. The measures came into effect from 1st April 2008 and will be used as part of Government's new performance assessment framework, Comprehensive Area Assessment.

This report sets out the progress that has been made to date with introducing the national indicators and highlights any issues and problems identified in relation to collection and reporting of the measures.

6. Recommendations

Corporate Improvement Board note the issues and problems identified in relation to the national indicator set.

7. Proposals and Details

a) Introduction

The new national set of 198 indicators has been designed to give a single set of information to be used to judge the performance of all partner organisations within a locality. The national indicators came into effect on 1st April 2008. Performance against each measure will be published annually by the Audit Commission as part of the Comprehensive Area Assessment (CAA).

b) Progress to date

Definitions – The handbook of definitions as published by CLG in May 2008 which provided the final detailed definitions for 185 of the National Indicators. A consultation document on the remaining 13 indicators to be introduced in 2009/10 has subsequently been published.

CLG has already deleted 3 indicators from the set:

- NI 24 Satisfaction with the way the police and local council dealt with antisocial behaviour
- NI 25 Satisfaction of different groups with the way police and local council dealt with anti-social behaviour
- NI 31 Re-offending by registered sex offenders

And have added one new indicator:

NI 199 – Children and young people's satisfaction with parks and play areas

Implementation – A report submitted to CMT on 7th July 2008 reported the progress made in reporting mechanisms for the new national indicator set. At this point in time it was identified that there were a large proportion of indicators that were either not reportable or had no manager assigned to them.

Corporate Management Team and Cabinet requested a stronger focus on the national indicators and requested more detailed information analysing and highlighting any issues or risk with any of the measures.

Officers from the Chief Executive's Policy and Performance team and directorates have established a central database holding information on each of the national indicators and have been working closely with each directorate to discuss each national indicator in detail to identify:

- Which Directorate will report on each of the NI's
- The NI Manager
- Whether the measure is included in the Corporate Plan or Local Area Agreement
- Whether the NI measure is currently reportable or not (if not, by when)
- Whether the definition of the measure is final
- Which partner organisation has the lead for the measure
- Whether we have baseline data and targets for the measure
- Whether the measure is survey based

On obtaining this information it has been possible to identify areas or potential risk. The findings from each Directorate are to be reported to and discussed at individual Directorate Management Teams.

c) <u>Findings</u>

Of the National Indicators we have identified that:

There are only 3 National Indicators that currently have no PI Manager assigned. This is due to requiring clarity on ownership of the measure (Appendix A)

There are 37 National Indicators that we can not currently report on due to definition or data collection issues:

- 16 of the measures are still awaiting for the definition to be finalised or have been deferred for introduction in 2009/10 (Appendix B1)
- There are 21 National Indicators where we are experiencing problems collating the data (Appendix B2)

There are 38 National Indicators that we can not currently report on but we are confident they are reportable by the 2008/09 year end.

- There are 24 survey based indicators which can not currently be reported (Appendix C1)
- There are 14 National Indicators where we have reporting and collection mechanisms in place and have an anticipated date for reporting (Appendix C2)

Based on the information obtained through our analysis it is anticipated that the profile of reporting against the national indicator set will be as follows:

d) Next Steps

Directorates – All directorates are to provide an update to Chief Executive's Policy and Performance team on the issues identified as part of the work conducted with Directorates and information reported to Directorate Management Teams.

Identification of Key Indicators – It is important that the council does not only report on national indicators as part of its quarterly reporting regime. The feedback from directorates is that they need to collate and report on other performance indicators which are of key operational and local importance (e.g. ex BVPIs, PAF, corporate health indicators).

Directorates are therefore requested to inform CEX Performance and Quality Team which indicators they intend to continue reporting on, and which of them should be included in the corporate quarterly performance reports.

Working with other authorities – As part of the South Yorkshire Improvement Group (Performance strand), one of the original milestone was around 'peer review/peer assist'. It has been decided by the group that this will take the form of arranging NI Networking Groups within South Yorkshire. These groups will bring together NI owners within the sub-region, and other relevant people, to look at particular NI's or performance theme areas to share best practice, highlight concerns, benchmarking activity, consultation etc.

8. Finance

No financial implications have been identified in relation to the National Indicator set however; additional costs may also be incurred by the council and partners in relation to the performance management arrangements relating to CAA and the underlying national indicator set and benchmarking arrangements.

The specific indicator for value for money is NI 179. Directorate leads will need to work with corporate finance to ensure that this is monitored and collated on a quarterly basis.

9. Risks and Uncertainties

No firm arrangements have yet been published in relation to CAA. However it is very clear that although we already have a strong LSP and partnership management arrangements in place. Additionally the council are currently working with the Improvement and Development Association (IDeA) in piloting the CAA Self Evaluation tool to obtain an overall assessment on the existing arrangements, capacity and to assess the outcomes the Rotherham LSP has delivered. However, improved joint working is required to ensure coherence of specific working practices to meet the requirements of CAA.

Additionally the national indicators are a vital part of the CAA judgement in 2009 and the 2008/09 outturn data for these will contribute to both the Area Assessment. Therefore, it is essential that we are confident that we can report accurately on as many of the national indicators as possible.

There is a risk that the incorporation of the new national indicators into the council's and partners performance reporting arrangements may not give sufficient coverage in terms of the operational performance management. Therefore, the approach should be to build a balanced set of key indicators that that focuses on the outcomes achieved against the local priorities for Rotherham.

10. Policy and Performance Agenda Implications

CAA will provide the first holistic independent assessment of the prospects for local areas and the quality of life for people living there. The proposals for CAA will have an impact upon the council's policy and performance agenda.

The focus on outcomes requires CAA to look across all organisations responsible for local public services which are expected to work in partnership to tackle the challenges facing communities. CAA will specifically recognise the importance of effective local partnership working and the enhanced role of the Sustainable Community Strategies and Local Area Agreements.

Joint working across partners to ensure robust arrangements for performance managing the proposed national indicator set is required. The performance management arrangements of the SRP and reporting to the Safe theme board are seen as best practice locally and should be used as the model for further improve the reporting of performance via theme boards.

In order to progress this a training event has been set up by the Rotherham Partnership to cover commissioning, improvement planning and performance reporting. Directorates have also requested that a workshop be held for Service Directors focusing on how to approach the CAA.

The introduction of the national indicator set was part of the aim by central government to reduce the burden of performance reporting. In practice this hasn't really impacted on the level of external reporting of performance (the feeling form the council directorates and partners is this has actually increased). Individual inspectorates are still requiring information on the previous indicators and are using them to inform their judgements.

This is being compounded locally by the amount of internal performance reporting and assessments that are covering very similar operational areas. Rotherham has made dramatic improvements in performance management, but further work needs to be done to ensure that these reports and assessments inform each other without revisiting the same ground. An example being the base budget review; which has become an onerous process that takes place when directorates are under pressure to deliver against internal and external performance assessments and judgements.
