1. Arrival

Forum members were welcomed by Park Inn staff and were shown to the area serving light refreshments.

2. Tour of The Park Inn Hotel

Forum members were invited on a tour of the Park Inn led by the staff. Staff from the Park Inn were on hand to answer any questions.

3. Welcome and Introductions

Joanne Edley, Tourism and Marketing Manager introduced Jon Broadhurst, Manager of the Park Inn who welcomed Forum members to the Park Inn and said the hotel had been open for 2 weeks and outlined the Rezidor group's background.

4. Tourism And Marketing Update

Joanne Edley, Tourism and Marketing Manager, gave a short presentation about accommodation developments in Rotherham:-

- Park Inn Hotel Opened
- 3 Self Catering establishment start up enquiries
- 2 existing serviced accommodation providers properties given advice on being assessed
- 1 Guest Accommodation Start Up enquiry
- Planning Application for extension to existing Hotel Accommodation
- Rural Grant available if under £25,000 can apply through Business Link, between £25,000 and £150,000 apply through the business engagement executives Caroline Wilson at Yorkshire South Tourism and information from Joanne Edley Tourism and Marketing Manager Rotherham, over £150,000 apply via Yorkshire Forward.

Work continued on developments at attractions which included:-

- Rother Valley Country Park land train facility recently installed. Planning applications will be submitted in 2010.
- South Yorkshire Transport Museum expansion has doubled floor space
- Clifton Park Developments Phase 1 completed. Phase 2 will start when a contractor has been appointed
- Boston Castle Heritage Lottery Bid funding from Heritage Lottery Fund will be known in the New Year
- Thrybergh Country Park Green Flag Award
- Flood Lighting of the Minster lighting installed last week with launch ceremony
- Brown Signage enquiries quite a few enquiries received from accommodation and attractions.

5. Yorkshire South Tourism - Update

Caroline Wilson, Membership Manager

Regional Visitors Survey 08

First time the survey has been done in the region

Interview locations in Rotherham: Magna, Tropical Butterfly House and Rother Valley Country Park

Key Themes:

- What type of visitors Day visitors 87%
 Overnight stays 2%
- Staying visitor origin 97% of all visitors were of UK origin
 3% visitors from overseas
- South Yorkshire previous visits 67% repeat visitors to Rotherham
- Age profile high proportion were children
- Pre-arrival influences leaflets score better than in other areas

Other results:

- 50% via booking accommodation website
- 80% stayed in Rotherham in 50+ rooms
- 72% visiting cultural attractions (interviewees sampled at cultural attractions)
- 93% of visitors likely to recommend
- 83% of visitors will return
- 98% of expenditure spent on travel and transport

Caroline Wilson emphasised the need to attract more first-time family visitors and young professionals. Other areas for exploration are how we can get more people to spend on eating after 5pm.

Caroline Wilson suggested placing high satisfaction figures at the bottom of e-mails.

Caroline Wilson welcomed the announcement for Easyjet to begin 21 weekly flight destinations from Robin Hood Doncaster-Sheffield airport, providing an opportunity to encourage more visitors into the area.

Caroline Wilson highlighted that Magna had been working on their website and their online booking facility. However a number of hotels have not updated their availability so Caroline Wilson encouraged hotels to update their details on the website.

Caroline Wilson updated that Doncaster Racecourse will facilitate promoting accommodation free of charge. Also the York Pass is to become the Yorkshire Pass, which will encourage people to visit South Yorkshire attractions and they will have a campaign to market this, for example, 2 for 1 restaurant discount vouchers and using local suppliers and food providers etc...

6. The Green Heart Sustainable Tourism Project, Dearne Valley

Stuart Jenkinson, Environment Agency gave a short presentation about The Green Heart a 5 year project:

- a cleaner, green heart to the valley
- access for all
- rediscovery of the river and countryside
- enhance wildlife
- support regeneration of the Valley

The river Dearne has vastly improved water quality which is increased insects/animals/mammals attracting green tourism.

The Green Network of cycle routes will link into the Trans Pennine Trail and be developed using old railway lines and industrial land. The first phase is due to be open next year.

7. The British Canoe Union facility at Wath-Upon-Dearne

Chris Hawkesworth, Planning and Facilities Manager Canoe Union gave a short presentation and provided further information on:

His presentation drew particular attention to:

- Express Park own the land at Manvers Lake and had an obligation to produce a boathouse.
- The lake is strategically well situated close to River Dearne, Trans Pennine Trail, M1 & A1M
- Canoe England have 30,000 members
- 480,000 affiliated clubs & 30,000 additional members
- 2,200 people paddle at least once each year
- 2 Canoe Olympic disciplines

5. Summary

To inform Cabinet Member of a proposal to implement a series of bus & general traffic improvement measures at the A629 Upper Wortley Road / London Way junction.

6. Recommendations

It is recommended Cabinet Member resolve that:

- i) a joint Passenger Transport Executive (PTE) / Rotherham Metropolitan Borough Council (RMBC) consultation exercise be undertaken regarding the proposed scheme;
- ii) subject to no objections being received the proposal be designed in detail and constructed.

7. Proposals and Details

As part of a Bus Key Route Corridor study from Rotherham Town Centre to Chapeltown, it was identified by the South Yorkshire Passenger Transport Executive (SYPTE) that buses are finding it difficult to turn right from London Way onto the A629 Upper Wortley Road. The delay adversely affects the journey time reliability of services within this area.

A scheme has been proposed by Rotherham Metropolitan Borough Council (RMBC) in conjunction with the SYPTE that aims to help bus transit through the area whilst also improving bus accessibility and general road safety.

Plan 126/17/TT49-16A (Appendix A) shows the proposed junction alterations.

It is proposed that:

- The existing two lane carriageway is reduced to a single lane in each direction.
- Traffic signs and road markings (in the form of hatching) are used to reduce the Rotherham bound carriageway from 2 lanes to 1 shortly after the exit from the M1 roundabout. Observations show the off side traffic lane at this point is very rarely used. Also by using hatching a left turn deceleration lane into London Way can be introduced. By reducing the carriageway to one lane through the junction, buses are able to cross into the central waiting area of the A629 more quickly. The width of the central waiting area is sufficient to accommodate a bus waiting to complete a right turn.
- The central island is widened on the motorway bound carriageway by infilling the existing right turn lane; this initially reduces the carriageway width to two lanes. Dedicating the offside lane as the new right turn lane by the use of hatching allows the A629 to be a one lane carriageway until past the London Way Junction. This is therefore safer for buses as drivers are giving way to one traffic lane instead of two.
- Bus lay-bys on both sides of the A629 are installed with raised 155mm tactile boarding kerbs. New footpath links and associated dropped kerbs will also be provided to improve accessibility to these bus stops.
- High Friction Surfacing (HFS) is placed on the approach to the M1 junction 35 roundabout, approximately 70m in length.
- As a secondary measure this scheme allows sheltered parking to be implemented where parking currently takes place for the local school.

8. Finance

The proposed scheme is expected to cost £160,000 and funding is available from the Local Transport Plan Integrated Transport Capital Programme for 2009/2010 and 2010/2011.

The HFS shall be financed from the Local Safety Scheme programme for 2010/2011.

9. Risks and Uncertainties

The estimated cost is dependant upon the need to divert Statutory Undertakers apparatus; this is expected to be minimal.

10. Policy and Performance Agenda Implications

The proposed scheme:



5. Summary

To make Cabinet Member aware of the aims and objectives of the Rotherham to Thrybergh Smart Route and to seek approval to undertake the detailed design and implementation of a proposal to widen the approach to St. Ann's roundabout when travelling south westerly on the A630 Fitzwilliam Road.

6. Recommendations

It is recommended Cabinet Member resolve that:

- i) the proposal, as shown on the attached drawing no.126/17/TT87, be an approved scheme;
- ii) the proposal be designed in detail and constructed; and
- iii) a further report be brought to Cabinet Member outlining the other congestion, road safety and accessibility improvements proposed on the A630 Smart Route.

7. Proposals and Details

For the purposes of Local Transport Plan (LTP) 2 the route between Sheffield City centre and Doncaster town centre has been designated as a 'Smart Route' with 3 distinct sections. One section being Rotherham to Thrybergh; the A630 Rotherham – Thrybergh Smart Route begins at College Road Roundabout in Rotherham town centre and progresses along Centenary Way to St. Ann's Roundabout. The corridor continues along Fitzwilliam Road in Eastwood, joining Doncaster Road at Mushroom Roundabout and continuing through Dalton and Thrybergh.

The development of this Smart Route builds upon a previous work along the route when it was jointly promoted as a Quality Bus Corridor (QBC) project by Rotherham Borough Council and South Yorkshire Passenger Transport Executive (SYPTE). Under the auspices of the QBC it aimed to improve access to public transport and improve bus journey time reliability by the introduction of measures such as the bus lanes at Doncaster Road Dalton and Fitzwilliam Road Eastwood.

The A630 is also identified as one of Rotherham's Key Congestion Routes within South Yorkshire's Congestion Delivery Plan (CDP). The CDP sets out potential improvements that can be implemented to reduce congestion such as the signalisation of St Ann's roundabout, implemented as part of the South Yorkshire Intelligent Transport System (SYITS) project and the proposed widening of the westbound approach to St Ann's roundabout.

The development of this corridor as a Smart Route aims to improve travel for all road users whether they travel by car, bus, bicycle or on foot. During the summer of 2009 RMBC and SYPTE jointly commissioned a public consultation exercise which identified four key locations that could benefit from improvement to further enhance the corridor. The locations identified are College Road roundabout. Fitzwilliam Road, Mushroom roundabout and Whinney Hill at Thrybergh. This initial phase of consultation asked the public about whether they agree with improving the key locations and also what aspects of their journey they felt required improvement. The consultation methodology involved leaflets delivered to just under 11,000 properties along the route and made available at 30 Community Access Points as well as on the X78 bus service. A consultation website together with an information phone line was also available, and finally a half page consultation advert was placed in the Rotherham Advertiser. A briefing pack was distributed to elected Members outlining the background, aims and objectives of the Smart Route and a copy of the briefing pack will be available at Cabinet meeting.

The consultation respondents were supportive of the aims of the Smart Route concept and strongly supported the objectives of reducing congestion and improving traffic flow along the corridor. Preliminary design work has commenced on investigating measures to meet the objectives of the Smart Route at the locations previously identified and further reports will be submitted to Cabinet Member outlining these proposals.

One area that currently contributes towards congestion at peak times is the limited width of the approach to St. Ann's roundabout from Fitzwilliam Road. The current road layout is not wide enough to allow two vehicles to queue side by side at the stop line of the traffic lights; particularly if one or more of these vehicles are a large vehicle such as a bus. This adversely affects the length of the traffic queue on this approach to the roundabout leading to increased traffic congestion which affects bus journey times and journey time reliability.

It is proposed to widen the approach such that two vehicles can wait side by side at the stop line and for a distance of 50m back from the stop line without encroaching upon the opposing traffic lane. This measure will improve driver confidence to create two full lanes of traffic for use by all vehicles, which the traffic modelling that has been undertaken indicates will improve general traffic flow through the junction as well as contributing towards improved bus journey times. Previously, the option of designating the nearside lane on the approach to St Ann's roundabout a bus lane has been considered. However, the modelling undertaken indicates that at this time additional bus priority measures would not be required, although the proposed widening does not preclude this being introduced in the future.

8. Finance

The proposed scheme is expected to cost £395,000 a significant proportion of which is made up of costs associated with diverting statutory undertakers' equipment. Funding is available from the Local Transport Plan Integrated Transport Strategic Capital Programme for 2009/2010 and 2010/2011.

9. Risks and Uncertainties

Costs may increase due to unforeseen difficulties associated with diverting statutory undertakers' equipment.

10. Policy and Performance Agenda Implications

The proposed scheme:


