# 8. SCHOOL ADMISSIONS CONSULTATION FOR ENTRY IN THE 2012/2013 ACADEMIC YEAR

Further to Minute No. 4 of the meeting of the Local Admissions Forum held on 1<sup>st</sup> July, 2010 and to Minute No. 37 of the meeting of the Cabinet Member and Advisers for Children and Young People's Services held on 21<sup>st</sup> July, 2010, consideration was given to a report presented by the School Organisation Planning and Development Manager concerning the admission arrangements (ie: criteria and admission number) which would apply for school admission in the 2012/2013 academic year.

The report made reference to the admission criteria and numbers for both community and controlled schools and for voluntary aided schools. The Local Admissions Forum noted that there were no proposed changes to the admission criteria for 2012/2013.

Included within the report were details of each community and controlled school's proposed admission number for 2012/2013 (appendix two of the report submitted).

The Borough Council currently co-ordinates admission arrangements during the normal admission round. The Department for Children, Schools and Families' 'Admission Code of Practice' required this to be extended to cover in-year admissions for all year groups with effect from 2011/12 and the Council's scheme had been modified last year to take this into account.

The Local Admissions Forum noted the following intentions of the admission authority:-

- (i) to revert to maintaining waiting lists for reception/foundation 2 places at primary schools only until 31 December, rather than for a whole academic year (reference the Local Admissions Forum meeting held on 19<sup>th</sup> March 2009); it was noted that waiting lists for Year 7 places at secondary school were maintained only until 31 December; and
- (ii) to issue to parents a summary of the information contained in the admissions booklet (the whole booklet is available upon request and also via the Borough Council's Internet web site).

During discussion of this item, reference was made to the possible establishment of schools in the region which would not be subject to local authority control:-

- a school for pupils aged 11 to 18 years, possibly using the former University of Sheffield premises near to Dearne Valley College;
- publicity about a 'free' school being established at premises within the Rotherham town centre;
- possible interest in establishing a school in the Catcliffe/Waverley area on the boundary between Rotherham and Sheffield.

It was also noted that Brinsworth Comprehensive School and Wales High School had gained Academy status with effect from 1<sup>st</sup> October, 2010.

Agreed:- (1) That the report be received and its contents noted.

- (2) That a further report be submitted to the next meeting of the Local Admissions Forum detailing the outcome of the consultation process about the school admission arrangements for the 2012/13 academic year.
- (3) That the admission authority's intention to maintain waiting lists for reception/foundation 2 places at primary schools only until 31 December, with effect from the beginning of the 2011/12 school year, be noted.

#### 9. ROTHERHAM LOCAL ADMISSIONS FORUM ANNUAL REPORT 2010

Consideration was given to a draft of the 2010 annual report for the Rotherham Local Admissions Forum, prepared in accordance with the provisions of Section 85A(1A) of the School Standards and Framework Act 1998 (as inserted by Section 41(3) of the Education and Inspections Act 2006).

During consideration of the draft annual report, a number of issues were discussed:-

- surplus places in schools:
- waiting lists for admissions to schools;
- falling rolls in secondary schools during most of the next decade;
- applications submitted on-line, for admission to Rotherham schools:
- school admission appeals and the '30 limit' qualifying measures appeals;
- school admission appeal decisions which had referred to the Local Government Ombudsman;
- the number of casual/in year transfers of schools:
- increasing numbers of children arriving from overseas and joining Rotherham schools:
- the fair access protocol;
- Looked After Children and pupils with Special Educational Needs.

Agreed:- (1) That the draft annual report be received and the document be approved as the Rotherham Local Admissions Forum Annual Report 2010.

(2) That the Annual Report 2010 be submitted to the Local Authority (Borough Council), its schools and to the Schools Commissioner at the Department for Education and a copy also be published on the Borough Council's Internet web site.

# 10. OFFICE OF THE SCHOOLS ADJUDICATOR - ANNUAL REPORT SEPTEMBER 2009 TO AUGUST 2010

Members of the Local Admissions Forum received copies of the booklet for admission to primary school 2011/2012. The booklet is available to view on the Council's Internet web site and paper copies will be sent to parents upon request.

The Local Admissions Forum also noted that the number of applications submitted online by parents for 2011/12 admissions had reduced as a result of the application form, instead of the full booklet, being posted directly to parents. However, the number of parents not applying for a place has reduced. The members of the Local Admissions Forum welcomed the increase in the proportion of parents who have submitted applications for admission of their children to school.

# CONSULTATION ON ADMISSION ARRANGEMENTS FOR THE ADMISSION YEAR 2012/13

# i) Admission Numbers and Admissions Criteria

This item gives governors the opportunity to consider the admission arrangements (criteria and admission number), which will apply for admission in 2012/13. The Local Admission Forum has previously considered the requirements for consultation and has agreed that the LA should facilitate this, as far as possible, by use of the Authority's Internet site.

The timetable for the year is:-

Autumn Term 2010 Governing bodies consider the arrangements

which will apply.

By 10th December 2010 All relevant details to be forwarded to the LA.

4th January – 1<sup>st</sup> March 2011 Period of consultation via the LA's website.

By end of March LA and the Local Admission Forum consider any

changes and forward any comments to

appropriate Admission Authority(ies).

By 15<sup>th</sup> April 2011 All admission authorities to determine their

arrangements and notify those consulted.

### **Community and Controlled Schools**

For these schools, the LA is the admission authority. The admissions criteria for 2011/12 are shown at Appendix 1.

There are no proposed changes to the admission criteria and they will apply for 2012/13.

Each school's proposed admission number is shown at Appendix 2.

*Action*: The Governing Body is requested to complete and return the pro-forma to David Hill, 1<sup>st</sup> Floor, Norfolk House, as soon as possible and no later than 10<sup>th</sup> December 2010.

## **Voluntary Aided Schools/Academies**

The governing body is the admission authority. Full consultation is required.

If there are any proposed changes at Church of England schools, Governing Bodies should consult their Diocesan Board before consulting anyone else.

Action: Governing Bodies to consider both the admissions criteria and the admission number appropriate for the school. Full details of the admissions criteria and admissions number to be forwarded to the LA by 10<sup>th</sup> December 2010 to enable

the full consultation with all the appropriate consultees to be carried out via the Internet. This should be done by e-mail to david-education.hill@rotherham.gov.uk

Pro-forma to be completed and returned as for community and controlled schools.

#### **Further General Points**

All admission numbers should be set by reference to the indicated admission number (IAN) deriving from the net capacity calculation.

An admission number higher than the IAN can be set, subject to the necessary consultation, feedback and determination.

An admission number lower then the IAN can be set, subject to the above, but would also require the publication of a notice with provision for objection to the Adjudicator.

All infant, J&I, Primary schools need to continue to be mindful of the need to maintain classes from FS2 to Y2 at 30 or less.

# ii) <u>Co-ordinated Admission Arrangements</u>

The Authority currently co-ordinates admission arrangements during the normal admission round. The DCSF 'Admission Code of Practice' required this to be extended to cover in-year admissions for all year groups with effect from 2011/12 and our scheme was modified last year to take this into account. There are no proposed changes for 2012/13.

# Action: No action required

# iii) Waiting List

The Authority currently maintains waiting lists for pupils applying during the normal admission round. The new Admissions Code of Practice required that waiting lists are in place from September 2009 and continue for at least the first term of the academic year. Our consultation document last year proposed one term for secondary schools and a full year for Primary schools and this was approved. The new policy has operated since September 2009. It has worked successfully for Secondary Schools. For Primary Schools the change has been less successfully. The extension for a full year has lead to unforeseen problems. This has occurred where pupils, who have been settled in school, have been offered a school transfer. The original intention was to use the waiting list to prioritise new applications but unless parents formally withdraw their child's name from the waiting list their original application still stands and has to be reconsidered (as a place becomes available it has to be offered to the highest name on the waiting list). Some of these pupils offered a transfer have been in school for over a term and in some cases two terms. Parents have been faced with a difficult decision which could unsettle their child. The change has not created a fairer allocation of places and has further delayed the admission process. The LA now wishes to maintain the Primary Waiting List for one term up to the 31st December to be in line with the Secondary list.

Action: Primary schools only.

We wish to keep the waiting list open for the Statutory one term. Governor's views are sought on the proposed change.

# iv) Local Authority 'Admission to School' Booklets.

The local Authority has previously supplied a hard copy of the 'Admission to School' booklet to every parent applying for 'Admission to Primary School' and for 'Admission to Secondary School'. The information contained in the booklets is freely available on the Local Authority Website along with details on how to make an on-line-application. The Authority is currently able to satisfy 95% first preferences for primary and 97% first preferences for secondary school. Much of the information in the booklet is surplus to most parents' applications (most booklets are discarded once the application has been submitted). Where parents are unsuccessful with their application separate guidance is available on the appeal procedures. Many other neighbouring authorities now produce only a summary of the information which is sent to all parents with detailed information available on request or via the website. The Rotherham Authority has had to make a decision, prompted by the current financial position to adopt a similar policy and booklets will now only be provided upon request. All parents will still receive a short summary explaining how to apply for a school place, a copy of the Common Application Form and information on how to access the on-line system.

Action: Governing Bodies to note the decision to only send a summary of the information contained in the admissions booklet to parents with full copies available on request and/or via the rotherham.gov.uk website.

Appendix 1

The admission criteria for community and controlled schools for 2012/13 is shown below and is unchanged from the current criteria.

## **Primary Reception**

## Places will be allocated in the following order of priority:

Those who on the closing date are:

- i) Relevant looked after children (see note 2 below).
- ii) Children who have a specific medical reason confirmed by a medical practitioner which the Authority is satisfied makes attendance at that particular school essential.
- iii) Children with a compelling social reason which the Authority is satisfied makes attendance at that particular school essential. The kinds of overriding social reasons which could be accepted are where there is evidence that the pupil's education would be seriously impaired if he or she did not attend the preferred school. Parents should ensure that they attach full supporting information to the Common Application Form.
- iv) Children who on the closing date live in the catchment area of the school as defined by the Authority who will also have an older brother or sister on the roll of the preferred school or its associated junior school at the time of their admission. Parents should ensure that they attach full supporting information to the Common Application Form.
- v) Children who on the closing date live in the catchment area of the school as defined by the Authority.
- vi) Children who on the closing date live outside the catchment area of the school as defined by the Authority whose older brother or sister will be on the roll of the preferred school or its associated junior school at the time of their admission.
- vii) Children who on the closing date live nearest to the school measured in a straight line on a horizontal plane (as the crow flies).

## Year 3

# Places in Year 3 at a Junior School will be allocated in the following order of priority:-

Those who on the closing date are:

- i) Relevant looked after children (see note 2 below).
- ii) Children in attendance at Y2 in the associated Infant School.
- iii) Children who have a specific medical reason confirmed by a medical practitioner which the Authority is satisfied makes attendance at that particular school

**essential.** Parents should ensure that they attach full supporting information to the Common Application Form.

- iv) Children with a compelling social reason which the Authority is satisfied makes attendance at that particular school essential. The kinds of overriding social reasons which could be accepted are where there is evidence that the pupil's education would be seriously impaired if he or she did not attend the preferred school. Parents should ensure that they attach full supporting information to the Common Application Form.
- v) Children who on the closing date live in the catchment area of the school as defined by the Authority who will also have an older brother or sister on the roll of the preferred school at the time of their admission.
- vi) Children who on the closing date live in the catchment area of the school as defined by the Authority.
- vii) Children who on the closing date live outside the catchment area of the school as defined by the Authority whose older brother or sister will be on the roll of the preferred school at the time of their admission.
- viii) Children who on the closing date live nearest to the school measured in a straight line on a horizontal plane (as the crow flies).

# **Secondary Year 7**

# Places will be allocated in the following order of priority:-

Those who on the closing date are:

- i) Relevant looked after children (see note 2 below).
- ii) Children who on the closing date have a specific medical reason confirmed by a medical practitioner which the Authority is satisfied makes attendance **at that particular** school essential. Parents should ensure that they attach full supporting information to the Common Application Form.
- iii) Children who on the closing date have a compelling social reason which the Authority is satisfied make attendance at that particular school essential. The kind of overriding social reasons which could be accepted are where there is evidence that the pupil's education would be seriously impaired if he or she did not attend the preferred school. Parents should ensure that they attach full supporting information to the Common Application Form.
- iv) Children who on the closing date live in the catchment area of the school as defined by the Authority whose older brother or sister will be on the roll of the preferred school in Years 8-11 at the start of the academic year 2012.
- v) Children who on the closing date live in the catchment area of the school as defined by the Authority.

- vii) Children who on the closing date live have an older brother or sister on the roll of the preferred school in Years 8-11at the start of the academic year 2012.
- vi) Children who on the closing date are on the roll of one of the associated Primary/ Junior/Junior and Infant schools as identified by the Authority.
- vii) Children who on the closing date live nearest to the school measured by a straight line on a horizontal plane, (commonly known as measurement, "as the crow flies").

#### **Notes**

- Where the admission number for any school is likely to be reached mid category, places will be prioritised within that category by reference to the distance between the home address and the school. Highest priority will be given to those living closest to the school measured in a straight line on a horizontal plane (commonly known as measurement, "as the crow flies").
- 2. Where any final place at a school is available and two or more pupils are judged to be living equidistant from the school (e.g. in flats), the final place will be allocated by the drawing of lots by officers of the authority.
- 3. A 'relevant looked after child' is a child that is looked after by a local authority in accordance with Section 22 of the Children Act 1989 at the time an application for admission to a school is made, and who the local authority has confirmed will still be looked after at the time when he/she is admitted to the school.
- 4. Places will be allocated in accordance with the LA's co-ordinated admissions schemes for Primary and Secondary schools. In assessing preferences, the LA will operate an 'equal preference' system, which means that no priority will be given according to the ranking of the preference, <a href="except">except</a> where a potential offer can be made in respect of more than one school. In that situation, the final offer of a place will be made at the highest ranked of the potential offer schools.
- 5. Children issued with a statement of Special Educational Needs will gain a place at the school named in the statement as part of that process.

# 1) Feedback from the annual admissions consultation

# A Community and Controlled Schools

## i) Admission numbers

The following matters have been raised:-

## **Thurcroft Junior School**

The school has requested an admission number of 65 (rather than the proposed 70). The reason given is that this is more in line with the Infant School which has an admissions number of 60. However, Thurcroft Junior School's net capacity calculation gives an admission number of 90 and the recommended admission number of 70 is already a reduction on this. The LA already has to publish a statutory notice as the school is substantially below the admission number derived from the net capacity. (The school does have larger classrooms which do influence the capacity). There is also substantial new housing proposed in the Thurcroft area close to the school and around 300 dwellings are likely to be built in the near future. The LA needs to retain as much space as it can in both the Infant and Junior schools and would not want the capacity to be reduced. It is proposed that the admission limit remain at 70 in order that the school can continue to accommodate all the pupils who may wish for a place in their local school.

Maltby Redwood Primary Redscope J&I Rockingham J&I Roughwood Primary

These schools were asked to give consideration to an alternative numbers. Feedback from the governing bodies is that the following numbers were the preferred option:

Maltby Redwood Primary – 34 Redscope J&I - 60 Rockingham J&I - 56 Roughwood Primary - 56

These numbers should be approved.

# ii) Admissions criteria

The only change proposed to the admission criteria related to a change to the 'Waiting List'. A change to the waiting list for Primary Schools was proposed and this was to reduce it to one term up to the end of the Autumn Term. (The waiting list for Secondary Schools operates until the end of the Autumn Term) Only 3 (of the 99) Primary Schools expressed concern. Sitwell Infant School and St Mary's Herringthorpe proposed that it continue to the end of the year (but gave no reasons). Maltby Manor Primary School also proposed the end of the year as they consider it would be fairer to everybody, however Maltby Manor School has never been oversubscribed and the LA has never had to keep a waiting list for the school. The operation of the waiting list to the end of the year has previously resulted

in pupils, settled in school, being offered a transfer which has lead to an upset to their education and has not resulted in a fairer allocation of places. Given that the vast majority of schools have supported the change it is proposed to operate the Primary 'Waiting list' for the Statutory one term.

# **B** Voluntary Aided Schools

## i) Admission numbers

There were no proposed changes to those admission numbers already applying to 2011/12.

# ii) Admissions criteria

There are no proposed major changes to any school's admissions criteria. A number of schools have previously made minor changes which have been necessary following the admission arrangements compliance exercise undertaken by the Office of the Schools Adjudicator. For most schools this related to ensuring that certain definitions (siblings/distance measuring etc) are fully explained within the admissions policy. These have been agreed with the schools concerned and the dioceses.

# **C** Academies

# 1) Admissions Numbers

There were no proposed changes to those admission numbers that applied previously in 2011/12. (In the case of Wales Academy and Brinsworth Academy they have both adopted the admission number which previously applied when the were Community Secondary schools.)

## ii) Admissions Criteria

The three academies; Brinsworth, Maltby and Wales have all adopted the Admission Policy approved by the Local Authority for the Community Secondary Schools.

# D Public Consultation

The Admission consultation has been available on the RMBC Website for the Statutory 8 weeks along with a copy of each Voluntary Aided School admission's policy. A public notice advising of the consultation was placed in local newspapers. No response to the public consultation had been received by the closing date of the 1<sup>st</sup> March 2011.

# 2. <u>Required publication where an admission number is less than that indicated by the current net capacity calculation for the school</u>

There remains a requirement for a notice to be published should any admission authority wish to have an admission number, which is lower than that indicated by the current net capacity calculation. For 2011/12, this would apply to the following schools:-

## 5. Summary:

There are currently two proposals for Free Schools within the Rotherham Authority.

# **Three Valleys Academy**

The Department for Education has recently received a proposal to set up a new school in Rotherham from the Nationwide Independent College of Higher Education (NICHE). The proposal is for an 850 place school for pupils aged 11-18 years in Wath-Upon-Dearne.

The proposal has now been fully assessed by the Department for Education, and the Secretary of State has given approval for it to proceed to the business case stage. **The Authority has until the 11<sup>th</sup> March to submit views to the DfE.** 

#### **Rotherham Central Free School**

Mrs Blencowe, Principal Designate, is proposing to establish the 'Rotherham Central Free School'. The School will be located in Rotherham (most probably in central Rotherham) and will provide education for 500 Secondary age pupils. The school will have an open admissions policy and will have a catchment area of around three miles from centre of Rotherham.

We have not yet received any information from the Department of Education on the progress of this proposal.

#### 6. Recommendation:

That the Authority responds to the Department for Education objecting to the Free School proposals and giving full reasons for the impact that 'The Three Valleys Academy' and 'Rotherham Central Free School' will have on the current Secondary School provision and educational standards within the Rotherham Authority.

## 7. Proposals and Details:

## **Three Valleys Academy**

# Background

The Department for Education has recently received a proposal to set up a new school in Rotherham from the Nationwide Independent College of Higher Education (NICHE). The proposal is for an 850 place school for pupils aged 11-18 years in Wath-Upon-Dearne. The school will have an admission limit of 120 pupils and a 6<sup>th</sup> Form of 250 pupils.

The proposal has now been fully assessed by the Department, and the Secretary of State has given approval for it to proceed to the business case stage. The Secretary of State also has a duty to consider carefully the impact that any new school will have on the surrounding community and existing schools and has written to the Authority requesting views on the proposed school. The establishment of a new school in the Dearne will severely impact on our existing schools and educational standards. The Authority has until the 11<sup>th</sup> March to submit views to the DfE.

#### Issues:

- 1. Catchment Area. The Three Valleys Academy will be located in the former Nursing School in Manvers. It will draw pupils from Rotherham, Doncaster and Barnsley. The Free School has published an indicative catchment area which includes (in Rotherham) Wath, Swinton, Rawmarsh, Kilnhurst and Parkgate. This will impact on four Rotherham Secondary Schools Wath, St Pius, Rawmarsh and Swinton. The nearest school is Swinton which is about 1.25 miles away and Wath which is less than 1.5 miles away.
- 2. **Expressions of Interest:** The free school claims to already have had support from over 500 people with expressions of interest in letters and emails.
- 3. **Timing:** The free school is proposed to open in September 2012. It is already asking for expressions of interest and will take, in September 2012, pupils into both Year 7 and Year 8 and also admissions into the 6<sup>th</sup> Form.
- 4. **Educational Standards:** All Rotherham Secondary Schools are improving with rising educational standards. The introduction of a new free school could severely impact upon educational standards of Rotherham pupils.

### Implications for Rotherham Secondary Schools:

- 1. St Pius X: This school has always been oversubscribed with nearly all pupils being of the Catholic Faith or attending a feeder Catholic Primary School. Many pupils travel from the Doncaster and Barnsley Authorities. Pupils are unlikely to be attracted away from this school.
- 2. Wath Comprehensive, a Language College: This school has always been oversubscribed (typically each year 15-50 pupils are unsuccessful in gaining a place). Some pupils who live in Wath and who would have gained a place may be attracted to the Three Valleys Academy, however given the demand for places at Wath, particularly from areas of Barnsley and Doncaster the school will fill up with

these pupils. The mix of pupils in the school may change but numbers are unlikely to change. (the issue here is that Barnsley, particularly with the under popularity of Wombwell School, and Doncaster will be hit with pupils going to both the Three Valleys Academy and taking up more places at Wath Comprehensive). More pupils from Rawmarsh (and possibly Swinton) may also gain places at Wath.

- 3. Rawmarsh Comprehensive: The numbers entering Rawmarsh are falling (due to the falling Secondary birth rate). The school is furthest away from the area and some pupils may be attracted to the school. Any loss will impact on numbers at the school. It is impossible to predict how many pupils will go. (There is a slight drift in numbers to Wath.) The LA has produced pupil forecast for the school based on the loss of 20 pupils per year from 2012 onwards. A 20 pupil loss would reduce numbers on roll to 741 by 2015/16. (A 40 pupil loss would reduce numbers on roll to 641 by 2015/16). This also has financial implications for the school budget. A loss of 20 pupils equates to a funding loss of around £100,000. If this continued through all year groups after five years the budget could be reduced by around £500,000. A loss of 40 pupils per year group would threaten the whole viability of the school.
- **4. Swinton Comprehensive:** Swinton is likely to be hit the hardest. It is closest to the Three Valleys. Any loss would impact on numbers at the school. It is impossible to predict how many pupils may be attracted to the school. The LA has produced pupil forecast for the school based on the loss of 20 pupils per year from 2012 onwards. A 20 pupil loss would reduce numbers on roll to 723 by 2015/16. (A 40 pupil loss would reduce numbers on roll to 623 by 2015/16. The 623 assumes no loss to the 6<sup>th</sup> Form. The numbers, excluding 6<sup>th</sup> Form, would only be 480 with just 109 in Y11 which would probably be too small to run a 6<sup>TH</sup> Form dire consequences for the school.). This also has financial implications for the school budget. A loss of 20 pupils equates to a funding loss of around £100,000. If this continued through all year groups after five years the budget could be reduced by around £500,000. The loss of 40 pupils per year group would lead to the definite closure of the school 6<sup>th</sup> form and threaten the whole viability of the school.

### **Summary:**

The falling birth rate and the numbers on roll indicates that there is sufficient capacity in all current Secondary Schools and no expansion of school places is required in the Dearne Valley area. To provide a new school would impact severely on Swinton Comprehensive to such an extent that the viability of the school is compromised. There is likely to be an impact on Rawmarsh which is less but again compromises numbers at the school. There is no doubt that educational standards would fall due to the loss of pupils. Teaching staff and other school staff will have to be made redundant.

## **Rotherham Central Free School**

#### **Background**

Mrs Blencowe, Principal Designate, is proposing to establish the Rotherham Central Free School. The School will be located in Rotherham (most probably in central Rotherham) and will provide education for 500 Secondary age pupils. The school will have an open admissions policy and will have a catchment area of around three miles from centre of Rotherham.

# **Progress**

We have had no formal notification from Mrs Blencowe (a requirement of the first stage of the completion of the Free School proposal form). The DFE will advise the Local Authority once approval to move to business case is given and we will then be given the opportunity to submit concerns. Mrs Blencowe is currently seeking support for her proposals and her supporters have been lobbying parents outside a number of local primary schools.

## **Implications for Rotherham Central Schools**

- 1. A new central school will Impact on Brinsworth Academy, Clifton, Oakwood, Rawmarsh, Thrybergh, Wingfield and Winterhill Secondary Schools.
- 2. If the Rotherham Central Free School were to open in Sept 2012 and it was fully subscribed 100 pupils would be lost from the above Rotherham Schools. It is difficult to judge where the pupils will come from and some schools may lose more than others.
- 3. This represents a loss of approximately £500,000 to Rotherham Schools in just the first year of operation.
- **4.** If the school were to fill up each year for the following 4 years around 500 pupils would have been lost and this equates to **an Annual Loss of around £2.5 Million** from Rotherham schools.
- 5. The loss of 500 school places tied in with the falling secondary school rolls (due to the falling birth rate) jeopardises the future of at least one central Rotherham School.
- 6. The loss of numbers will impact not only on the school budget but will also impact on school standards. Schools will find it increasingly more difficult to provide a balanced curriculum and the inevitable effect of a school with falling numbers is reduced educational attainment.
- 7. Teaching Staff and other school based staff will have to be made redundant.

## **Summary**

The proposal to open the Rotherham Central Free School should be opposed as it will have a dramatic impact on current Rotherham schools reflected in: falling rolls, loss of school funding, teacher and other staff redundancies and falling educational standards.

# 8. Finance:

The local authority will receive reduced funding as any pupil who attends a Free School will withdraw the allocation of funding the LA receives to give to schools under the dedicated schools grant.

### 9. Risks and Uncertainties:

The Authority will have an increasing number of surplus places and the viability of a number of Secondary schools will be jeopardised along with a detrimental impact on educational standards.

# 10. Background Papers and Consultation:

The LA has provided to NICHE copies of our pupils projections which show the extent of surplus places in the area. The LA has also written to the Local MP to express concern and also provided information for the local press and also a briefing note to Headteachers and the Cabinet Member for Safeguarding and Developing Learning Opportunities.

# Timeline of Key Dates:

- Free School Notifies the Secretary of State of its intention to put forward a proposal to set up a free school.
- Free school completes proposal form obtains support from parents/other supporters and notifies the LA of its proposal
- The Department for Education approved the 'Three Valleys Academy' proposal on the 14<sup>th</sup> January 2011.
- The Department for Education notifies the LA of its decision to move the proposal to Business Case. Formal letter sent to the Local Authority advising of the decision and asking for the LA's views on the proposal.
- The dead line for reply is the 11<sup>th</sup> March 2011.
- The meeting held on the 17<sup>th</sup> February 2011 with Cllr Paul Lakin and the Chair of Governors and Head teachers of relevant schools resolved to oppose the request for the 'Three Valleys Proposal' and supported the Authority in its opposition. The opposition would be based on:
- 1. Sufficient capacity currently exists in all schools for all pupils in the area.
- 2. Educational Standards are high and rising in all schools.
- 3. 97% of parents get their first choice secondary school.
- 4. The loss of pupils to 'The Three Valleys' would jeopardise the future of at least two of the Secondary Schools with the 6<sup>th</sup> Form at Swinton particularly at risk.
- 5. 'The Three Valleys' has not provided any information on curriculum, educational standards, quality of staff, suitable accommodation, sports facilities or financial viability.
- 6. All Secondary Schools would work with their feeder primary schools to provide clear guidance both to the schools and parents on the opportunities available within the current secondary schools.
- Following examination results there will be a co-ordinated media campaign promoting Rotherham Schools to parents and the wider community. August 2011.
- 8. Continued support will be sought from local MPs to oppose the proposal.

In terms of secondary schools, most of the pressure from admission appeals is centred upon the Wales Academy, Wath Comprehensive School and Wickersley School and Sports College – with the Saint Bernard's Catholic High School and Oakwood Technology College next in line. This pattern seems set to continue for the foreseeable future.

There continues to be pressure upon places at Rotherham town centre primary schools, especially Ferham and St. Anns – and Thornhill to a slightly lesser extent. Recently, there have been many appeals for both Broom Valley and the Sitwell primary schools. The increasing birth rates affecting demand for primary school places in the Wickersley & Flanderwell area have not yet resulted in an increased number of appeals for primary school places in that part of Rotherham.
