Review of Special Responsibility Allowances Status

1. Recommendations

- 1.1 That the decision of the Commissioners in May 2015 to pay fifty percent of the SRA in respect of the Leader, Deputy Leader and Advisory Cabinet members be noted.
- 1.2 That the decision of the Commissioners in relation to the Chair and Vice Chair of Licensing Board, to take effect from 1st September 2015, be noted.

2. Background

- 2.1 As part of the Directions to the Council on 26th February 2015 the Secretary of State announced that the authority was required to cease to pay the special responsibility allowances (SRA) to members of its executive whilst they have no functions to exercise.
- 2.2 The Commissioners were appointed in February 2015 and agreed following the local elections in May 2015 that fifty percent of the SRA would begin to be paid to the Leader, Deputy Leader and Advisory Cabinet Members.
- 2.3 Following a review of the SRAs for the Chair and Vice Chair of Licensing board Commissioner Ney has recommended that these members also be awarded fifty per cent of the SRA applicable to the position.
- 2.4 The decision is based on the contribution made by the members in relation to the serious issues surrounding the licensing function of the authority.

3. Key Issues

- 3.1 To note the Commissioners' decision regarding the reinstatement of a proportion of the Special responsibility allowance to certain office holders.

4. Options considered and recommended proposal

- 4.1 To pay fifty percent of the SRA to the Leader, Deputy Leader and Advisory Cabinet members from May 2015 and in relation to the Chair and Vice Chair of Licensing Board to pay fifty percent of the allowance from 1st September 2015.

5. Consultation

5.1 This is a Commissioner decision in accordance with the Directions of the Secretary of State.

6. Timetable and Accountability for Implementing this Decision

6.1 The payments of the SRA for the Leader, Deputy Leader and Advisory Cabinet members commenced in May 2015.

6.2 The payments for the Chair and Vice Chair of Licensing Board will commence with effect from 1st September 2015.

7. Financial and Procurement Implications

7.1 The Commissioners were appointed in February 2015 and agreed following the local elections in May 2015 that fifty percent of the SRA would begin to be paid to the Leader, Deputy Leader and Advisory Cabinet Members.

7.2 Following a review of the SRAs for the Chair and Vice Chair of Licensing board Commissioner Ney has recommended that these members also be awarded fifty per cent of the SRA applicable to the position.

7.3 The decision re the Chair / Vice Chair is based on the contribution made by the members in relation to the serious issues surrounding the licensing function of the authority.
