Disclosure and Barring Service Checks on Councillors

1. Recommendations

1.1 That the report be noted.

2. Background

- 2.1 In response to the findings of the Casey Review of corporate governance within Rotherham MBC, the Commissioners identified that all councillors should be required to be subject to a Disclosure and Barring Services check as part of rebuilding trust and confidence in the leadership of the authority. This requirement was also enshrined within recommendations in an Internal Audit report on Elected Member Conduct.
- 2.2 The approach adopted in administering DBS checks was to require any councillor without an existing DBS certificate dated after May 2015 to undertake a standard check through the Disclosure and Barring Service. A number of specific post-holders were required to undertake an enhanced check, as detailed in the table below:
