House to House Collections Act 1939
House to House Collections Regulations 1947 (as amended)

Use this form to apply for a house to house promoters collection permit. The licence will allow you to authorise collectors to collect from door to door for charitable purposes only. No collection for a charitable purpose may be made in the locality unless the applicant is an appropriately licensed promoter by this authority, or holds an exemption granted by the Secretary of State from obtaining a licence from this authority.

The attention of applicants for licences under the House to House Collections Act 1939 is drawn to Paragraph 4 of the House to House Collections Regulations 1947 (as amended) made by the Secretary of State on the 12 December 1947. This paragraph provides that ordinarily an application for licence shall be made not later than the first day of the month preceding that in which it is proposed to commence the collection.

COMMERCIAL PARTNERSHIP AGREEMENT BETWEEN RECYCLING & MANAGEMENT SERVICES Ltd. - R&MS & YORKSHIRE CANCER RESEARCH - YCR 2016/2017

This Agreement is written with reference to The Charities Act (1992) and is designed to protect the Partner (Yorkshire Cancer Research - YCR) from inappropriate use of their name, identity and logo, as well as ensuring that revenue raised is donated appropriately according to the wishes of the Partner.

1 Preamble

- 1.1 Yorkshire Cancer Research YCR Registered Charity No. 516898 and Recycling & Management Services Ltd. R&MS agree to work together to support the activities of Yorkshire Cancer Research YCR.
- 1.2. This Agreement is for a period of one year from 01/07/2016 to 30/06/2017.
- 1.3 Should both parties agree, the Agreement is renewable for a further year not more than six months prior to expiry of this Agreement.
- 1.4 Either party can opt out of the Agreement with six month's written notice (email will suffice).

2 Procedural & Financial Considerations

- 2.1 Recycling & Management Services Ltd. R&MS will apply to city, county, county borough and metropolitan borough councils in Yorkshire for licences for house-to-house clothing collections.
- 2.2 Recycling & Management Services Ltd. R&MS will collect clothing donations and other items on behalf of Yorkshire Cancer Research YCR.
- 2.3 All charitable donations will be weighed at the end of each collection using commercial weighing apparatus and Recycling & Management Services Ltd. R&MS will accurately record amounts collected in metric tonnes on tally sheets.
- 2.4 Donations will be made by Recycling & Management Services Ltd. R&MS to Yorkshire Cancer Research YCR on the basis of £100.00 per metric tonne derived from the sale of collected items.
- 2.5 Recycling & Management Services Ltd. R&MS will donate a minimum of £2,500.00 per month to Yorkshire Cancer Research YCR during the period of the Agreement.
- 2.6 Donations will be paid by Recycling & Management Services Ltd. R&MS to Yorkshire Cancer Research YCR monthly by BACS transfer, by the end of the first week of the month following the month in which collections were carried out.

3 Legitimacy, Transparency, Accountability

- 3.1 Recycling & Management Services Ltd. R&MS will, on request from Yorkshire Cancer Research YCR, produce tally information about metric tonnage collected.
- 3.2 Recycling & Management Services Ltd. R&MS will, on request from Yorkshire Cancer Research YCR, provide information, including receipts, relating to expenses incurred.
- 3.3 Recycling & Management Services Ltd. R&MS will, by 31/07/17, i.e. within three months of Recycling & Management Services Ltd. R&MS financial year-end, produce

on request, certified accounts including balance sheet, detailed profit and loss account and other available financial information.

4 Publicity & Advertising

- 4.1 The wording of all publicity and advertising which Recycling & Management Services Ltd. R&MS and Yorkshire Cancer Research YCR use will be agreed between the two parties before production of any materials.
- 4.2 Final copy must be sanctioned by Yorkshire Cancer Research YCR in writing (email will suffice).
- 4.3 Neither party must use the other party's name, logo or identity without prior written agreement.

5 Legal & Other Considerations

- 5.1 This Agreement shall be governed by the laws of England and Wales.
- 5.2 This Agreement is entered into to comply with the 1992 and 2006 Charities Acts and the Charitable Institutions (Fund-raising) Regulations 1994.
- Yorkshire Cancer Research YCR grants to Recycling & Management Services Ltd. R&MS a non-exclusive licence for the term of this Agreement to use the name and logo of Yorkshire Cancer Research YCR in any materials relating to the promotion. The name and logo may not be used for any purpose other than the promotion and may not be transferred or assigned to anyone else. The name and logo may only be used within Yorkshire. This licence will end immediately on termination of this Agreement.
- 5.4 Recycling & Management Services Ltd. R&MS will ensure that their services and products are of a good quality, fit for purpose and comply with all relevant statutory and safety requirements.
- Recycling & Management Services Ltd. R&MS will indemnify Yorkshire Cancer Research YCR against all liabilities arising from the distribution/use of collection bags and carry adequate (£5,000,000.00) insurance for any such claims arising.
- 5.6 Yorkshire Cancer Research YCR will not interfere with the Promotion unless required to do so by law or external authorities or in order to preserve the interest of Yorkshire Cancer Research YCR.
- 5.7 The benefits of this Agreement may not be handed over or passed on to anyone other than the parties named in this Agreement.

6 Complaints

- 6.1 House-to-house collections necessarily involve members of the general public and generate complaints. These are always a small percentage of the overall volume of collections. New collections with a charity have a teething period. It is our experience that after the first three to six months any volume of complaints decreases.
- 6.2 Recycling & Management Services Ltd. R&MS will do everything it can to keep complaints to a minimum and will investigate every complaint promptly, thoroughly and diligently.
- 6.3 Where a complaint, after due investigation, is judged to be valid, Recycling & Management Services Ltd. R&MS commits to apologising, and making full financial, and other, restitution to the complainant.
- 6.4 Both Recycling & Management Services Ltd. R&MS and Yorkshire Cancer Research YCR will report complaints received to the other party on a monthly basis.

7 Cancellation

- 7.1 This Agreement may be cancelled by either of the parties with six month's written notice (email will suffice).
- 7.2 Either party may terminate this agreement immediately by written notice to the other in the event that the other party:
- (a) Has committed a material breach of this agreement and where such breach is capable of remedy, has failed to remedy the same within 28 days of receipt of a notice from the notifying party requiring the breach to be remedied.
- (b) Makes any composition or arrangement with its creditors, becomes subject to voluntary or compulsory liquidation, or subject to any receivership or administration order in respect of all or part of its business, or ceases, or threatens to cease, its business.
- (c) Has been deemed responsible for a serious incident that results in or may reasonably be held to be likely to damage the other party's reputation, or bring them into disrepute.
- (d) Engages in fraudulent and/or illegal behaviour as defined by the laws of England and wales or in behaviour defined as serious misconduct and/or gross negligence.
- 7.3 Yorkshire Cancer Research may terminate this Agreement immediately by written notice if Recycling & Management Services Ltd R&MS or any of its employees, officers, partners, contractors or other agents does anything which in the reasonable opinion of Yorkshire Cancer Research brings the name or reputation of Yorkshire Cancer Research into disrepute in any way or which is inimical to the charitable objects of Yorkshire Cancer Research.
- 7.4 Recycling & Management Services Ltd R&MS may terminate this Agreement immediately by written notice if Yorkshire Cancer Research or any of its employees, officers, partners, contractors or other agents does anything which in the reasonable opinion of Recycling & Management Services Ltd R&MS brings the name or reputation of Recycling & Management Services Ltd R&MS into disrepute in any way.

7.5 The termination of this Agreement, howsoever arising, is without prejudice to the rights, duties and liability of either Recycling & Management Services Ltd or Yorkshire Cancer Research accrued prior to termination
