1. Application is made for a review of the premises licence under S51 Licensing Act 2003 in respect of premises known as Kimberworth Late Shopper, 202 Kimberworth Road, Rotherham. The application relates to three of the four licensing objectives, namely;

The prevention and detection of crime Public safety Protection of children from harm

- 2. The premise is a medium sized off licence situated within a mainly residential area. The current premises licence licence permits the sale by retail of alcohol for consumption off the premises from 0700hrs to 2200hrs daily.
- 3. The recorded Premises Licence Holder is Frantisek Hudy. The recorded Designated Premises Supervisor is Saima Hussain.
- 4. On Tuesday 7<sup>th</sup> November 2017, following information received, a warrant issued by Sheffield Magistrates was executed at the premises in a joint operation between trading Standards and the Environmental Health Department at Rotherham Council. As a result, a quantity of cigarettes and rolling tobacco were seized from the premises. The seized items were identified as illicit. Enquiries are still on going in respect of this matter
- 5. The premises were visited later the same day by Rotherham Council Licensing Officers. It was established Mr.Basharat Rafiq was the person in charge of the premises and the business.
- 6. Mr. Rafiq was contacted and arrived at the premises about an hour later. He confirmed he was the owner of the business having taken over about 9 months previously. He stated that he leased the property from a male called Mr.Gahni. He stated that Mr Ashraf Hussain owned the business. He showed the officers a number of text messages he had received from a male called Ashraf Hussain with regard to the business. He

stated that Ashraf had been in Pakistan for at least 4 - 5 months so he had not seen him. He believed that Mr Hussain was also the DPS, and believed a female called Saima was his sister, but he did not know her, he had never met her and did not have a telephone number for her. Mr. Rafiq was unable to produce the premises licence and no summary was on display. He stated he had seen neither the summary nor the premises licence. Additionally there was no age verification policy in place and no evidence of any staff training to address this. Mr. Rafiq confirmed he did not hold a personal alcohol licence.

- 7. Mr. Rafiq was advised there appeared to be no authority in place to sell alcohol and as a result he was advised to remove all alcohol from the shelves which he duly did.
- 8. On Thursday 9<sup>th</sup> November 2017, Mr Rafiq attended at Riverside House where he was interviewed under caution in respect of the premises. A full transcript of the interview will be disclosed in due course, but in interview he stated he was the owner of the business which he bought from a Mr. Hussain nine months ago. He believed Mr. Hussain was still the business owner and DPS. He was still in the process of paying off the instalments for the business. He confirmed he had never seen a copy of the premises licence, nor was he aware that Saima was the DPS. He confirmed he did not have any contact details for either Hudy or Saima.
- 9. Additional enquiries have been made to locate the recorded premises licence holder and the DPS. The premises Licence Holder, Mr. Hudy, cannot be located. He no longer resides at the address listed on the premises licence and cannot be contacted on the mobile telephone number recorded despite several calls and answer machine messages.
- 10. In respect of the DPS, Saima Hussain, she initially stated she has never been connected in any way with the premises, but she subsequently stated she recalled being the DPS for about 12 months, but left in November 2015. She confirmed she has had no further contact with the premises since that date, and accepted she failed to notify the Licensing Authority of this.

- 11. There are serious concerns over the manner in which the premises have been conducting business. Since Mr. Rafiq took over the business some 9 months ago, there has been no transfer of premises licence or DPS. It is strongly believed there is no longer in place any Premises Licence Holder or DPS responsible for the management of the premises. The premises have effectively operated without any authority to sell alcohol in contravention of condition 1 of the mandatory conditions, and consequently every sale of alcohol over the last 9 months has constituted an offence under \$136 Licensing Act 2003.
- 12. Additionally, counterfeit cigarettes have been seized from the premises and will form part of a separate investigation.
- 13. The most recent Home Office Guidance issued under S.182 of The Licensing Act 2003 states;
- 11.27 There is certain criminal activity that may arise in connection with licensed premises which should be treated particularly seriously. These are the use of the licensed premises: (full list not included)
- for the sale or storage of smuggled tobacco and alcohol.
- 11.28 It is envisaged that licensing authorities, the police, the Home Office (Immigration Enforcement) and other law enforcement agencies, which are responsible authorities, will use the review procedures effectively to deter such activities and crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that revocation of the licence even in the first instance should be seriously considered.
- 14. There are serious concerns that the activity being conducted at the premises is undermining the Licensing objectives. Unlawful activity is being conducted, but additionally, customers, particularly children are being put at risk of harm through unlawful sales of alcohol and tobacco.
- 14. Application is therefore made for a review of the premises licence under \$51 Licensing Act 2003. The application is for a revocation of the Licence, however other options are also available to the Licensing Committee.

- 2. This statement is an overview statement in respect of review proceedings under S 51 Licensing Act 2003 relating to premises known as Kimberworth Late Shopper.
- 3. The full details of the premises are Kimberworth Late Shopper, 202
  Kimberworth Road, Rotherham, S61 1HH, premises licence number P08304. The
  current premises licence permits the sale alcohol for consumption off the
  premises from 0700-2200hrs daily. A copy of the premises licence is attached at
  Appendix A of the bundle.
- 4. The premises licence holder recorded on the licence is Mr. Frantisek HUDY.

  The Designated Premises Supervisor recorded on the licence is Mrs. Saima

  Hussain. The person currently claiming to be the business owner is Mr. Basharat

  RAFIQ. Evidence in respect of his claim to own the business is attached at

  Appendix B of the bundle.

- 5. On <u>Tuesday 7th November 2017</u>, following information received, a warrant issued by Sheffield Magistrates Court was executed at the premises in a joint operation between Trading Standards Officers and the Environmental Health Department at Rotherham Metropolitan Borough Council. As a result of the operation, a quantity of cigarettes and rolling tobacco were seized from the premises. The seized items were identified as illicit. Enquiries are still continuing in respect of this matter. A copy of the warrant is attached at Appendix C of the bundle.
- 6. Later the same day, at approximately 3.55pm I visited the premises in company with Fiona GEE, the Licensing Enforcement Officer. I there spoke with a Mr. Bartosz KUKLINSKI who identified himself as the person currently in charge of the premises. No other person was working at the premises at this time. KUKLINSKI advised me that he was working for a man called Mr. RAFIQ. I asked him to make contact with RAFIQ, which he did by telephone.

7. I subsequently spoke with Mr. RAFIQ on the telephone and asked him who the premises licence holder and DPS of the premises were. He explained he was the owner of the premises and had been the owner for about 9 months. He was unable to give the name of the Premises Licence Holder and Designated Premises Supervisor as shown on the premises licence. He stated a Mr. Hussain had been the owner of the business, but he was in Pakistan and had been there for several months. As a result of this he was requested to attend at the premises.

8. Whilst waiting for RAFIQ to attend. I conducted an inspection of the premises. I noted there was no premises licence summary on display, no premises licence available for inspection and no Challenge 25 posters displayed. I noted that a significant amount of alcohol was on display. It was displayed in two in two fridges to the right hand side of the till area, and adjacent to this I noted floor to ceiling shelves containing beers and ciders. A significant quantity of spirits were also on display behind the till area and on shelving to the side. I established from KUKLINSKI that there were no till prompts in place. I also

established that there was no refusals register and KULLINSKI pointed out that ages were routinely checked as a high percentage of the footfall of the premises was children and young persons. KUKLINSKI also informed me that the biggest selling products at the premises were beer, vodka, and cigarettes. Photographs of the premises have been produced and are attached at Appendix D of the bundle submitted in disclosure.

- 9. As a result of my findings and also my suspicions I advised KUKLINSKI that I had reason to believe there was no authorisation in place to sell alcohol. I advised him that the alcohol should be removed forthwith to prevent any further offences of unauthorised sales of alcohol under S136 Licensing Act 2003 or the unlawful exposure of alcohol under S137 Licensing Act 2003. KUKLINSKI began to remove the alcoholic products from the premises.
- 10. RAFIQ finally arrived at 1750hrs the same day. I briefly spoke with him to explain my suspicions. He confirmed he owned the business, having taken over from a male called Ashraf HUSSAIN approximately 9 months previously. He

showed us some text messages from a male who identified himself as HUSSAIN. The texts were very vague, and related to the business, annual fees and the licence for the shop. I asked RAFIQ if he knew who Saima HUSSAIN was. He stated he believed her to be the sister of Ashraf Hussain but he had never met her or spoken to her, and had no contact details for her. He also confirmed he had never seen the premises licence or the premises licence summary.

- 11. As a result, once all the alcohol had been removed from the premises, an appointment was made for RAFIQ to attend at Riverside House where he could be interviewed in respect of the matter.
- 12. On <u>Friday 10<sup>th</sup> November 2017</u> at approximately 11am, as a result of other related enquiries being made, I received a telephone call from Saima HUSSAIN, the named DPS at the premises. HUSSAIN is listed as the DPS and Premises Licence Holder at another Off Licence in Rotherham (Brampton Local Shop). I took the opportunity to ask her about the Kimberworth Late Shopper. She stated she had never been connected to the premises, nor did she have any

knowledge of HUDY, the listed Premises Licence Holder. She was invited to attend at Riverside House on Monday 13<sup>th</sup> November when further clarification could be obtained.

- 13. At 10.35am on Monday 13<sup>th</sup> November 2017, I attended at the premises and confirmed that no alcohol was being sold, and that all alcohol had in fact been removed from the store. I then subsequently attended at 186 Psalter Lane, Rotherham S61 1 HS, the home address of the Premises Licence Holder Frantisek HUDY. I spoke with the occupant of the property, James Vanstone, who stated he was the tenant of the property and had been there for about 3 months. He stated his landlord was a male called Dave, and he believed the building owner was a Mr. A. Ahmed who he believed lived locally and travelled frequently. He confirmed that some post for HUDY had arrived in the past but he had always returned it to sender as he had no address for him.
- 14. At about 1200hrs the same day, I spoke on the telephone with Saima Hussain, the person listed on the Premises licence as the DPS. She stated she

was unable to attend at Riverside House as agreed. She asked if she could assist over the telephone. I asked her again about her connection with the premises and she then stated she had been the DPS at the premises and she did in fact know Mr Hudy. She then confirmed that she had left the premises in November 2015 as they wanted her to work full time but because she had 2 children, and she only wanted to work part time.

- 15. She was asked if she knew who had taken over at the premises but she was unable to assist. As it was difficult to hear her, she was asked to attend the offices on Monday 20th November at 1pm which she agreed to do.
- 16. At 1545hrs on <u>Thursday 9<sup>th</sup> November 2017</u>, RAFIQ was interviewed under caution at Riverside House, Rotherham by the Senior Enforcement Officer Keeley LADLOW and enforcement Officer Fiona GEE. He was happy to be interviewed without a Solicitor.

17. In interview he confirmed that it was his business which he had bought from Mr Hussain and was paying for it in instalments. He thought that Mr Hussain was both the licence holder and the designated premises supervisor. He explained that he tended to contact Mr Hussain by text message, but that he kept on changing his phone number so he would have to wait for a WHATSAPP message to get his new numbers. He explained that he had asked him about taking over the licence in his own name but was still waiting on Mr Hussain and this was the reason why the licence was not in his name.

18. He was shown a copy of the premises licence summary and asked if he had seen a copy of the premises licence before. He confirmed that whilst he had asked Mr Hussain for a copy of the licence he had never actually received one. He was asked if he recognised the name of the premises licence holder a Mr Frantisek HUDY. He confirmed that he had never heard of him and thought Mr Hussain was the licence holder. When asked about the DPS, he confirmed that he knew her name as she was Mr Hussain's sister but that he had never met her and did not know how to contact her. He said that Mr Hussain frequently travelled, and he gave details during the interview of several countries that he

thought he had been in He believed Saima Hussain was currently in Pakistan and had been there for several months.

- 19. When asked if Mr Hussain owned the premises, Mr Rafiq confirmed that the buildings were owned by a Mr Gahni and that he was in the process of sorting out a lease with him.
- 20. Mr Rafiq was asked if he had ever received any training in the Licensing Act and if he held a personal licence. He confirmed that whilst he did not have a personal licence he had worked in both a Spar and in his Father's licensed Shop in Rotherham.

21. He was asked if he worked in his shop and how many people he employed. He admitted to employing several people and when asked if he had sold alcohol in the shop, he confirmed that he had worked in both his shop and his father's and he had sold alcohol.

- 22. He was asked if the alcohol was still off the shelves at the Kimberworth Late Shopper and he confirmed that it was and that it was all still in the backroom.
- 23. The interview was concluded at 1608hrs having been conducted in accordance with PACE and the Codes of Practice. A transcript of the interview has been produced and is exhibited 1222/1. It is produced at Appendix E of the bundle submitted in disclosure.
- 24. At 12.45pm on <u>Tuesday 21st November</u> I spoke with Saima Hussain in company with Enforcement Officer Fiona Gee at Riverside House. I confirmed that the premise licence was currently being reviewed. She stated she had left the premises in 2016. She was reminded that in the telephone conversation she had said November 2015 and she confirmed that she had left last year and she must not have understood what she was being asked. She confirmed that HUDY had been the premises licence holder when she was the DPS and that he was still there when she left in 2016. I asked if she had been in the store since leaving as DPS. She stated she had been in just once to buy some alcohol when

she had spoken to a Polish lady to ask her how things were going there as she had worked there previously. She confirmed that she had not authorised any staff to sell alcohol at the premises after she had left. I asked her to explain her understanding of a designated premises supervisor. She stated that it was the person with the personal licence to sell alcohol at the store. I asked if she knew what the process was if she were to leave as DPS, She confirmed that she knew she had to tell the Council, but admitted that she had failed to do this. When asked whether she had informed HUDY she was leaving, she said she had done this verbally. I explained that she should have completed a form to notify the Council and that she should also have notified the Premises Licence Holder, Mr Hudy in writing, so he could then submit the premises licence to the Council.

- 25. She was offered a copy of the review paperwork for the premises as she was still named as the DPS but she declined.
- 26. All enquiries made to date have failed to locate the named premises licence Holder Frantisek HUDY. There has been no DPS in place at the premises for well

over a year, and the premises have continued to operate as a licensed premise throughout this time. The person claiming to be in charge of the business, Mr. Basharat Rafiq does not hold a personal alcohol licence.

27. Additionally, illicit cigarettes and tobacco have been seized from the premises in a planned intelligence led operation by Trading Standards. This matter is still subject to legal proceedings, and only a limited amount of information is available at this time.

- 28. The Home Office guidance issued under S182 Licensing Act 2003 makes specific reference to unauthorised sales of tobacco at S.11.27:
- 11.27 There is certain criminal activity that may arise in connection with licensed premises which should be treated particularly seriously. These are the use of the licensed premises:
- for the sale and distribution of drugs controlled under the Misuse of Drugs Act 1971 and the laundering of the proceeds of drugs crime;
- for the sale and distribution of illegal firearms; for the evasion of copyright in respect of pirated or unlicensed films and music, which does considerable damage to the industries affected;

- for the illegal purchase and consumption of alcohol by minors which impacts on the health,
   educational attainment, employment prospects and propensity for crime of young people;
- for prostitution or the sale of unlawful pornography;
- · by organised groups of paedophiles to groom children;
- as the base for the organisation of criminal activity, particularly by gangs;
- for the organisation of racist activity or the promotion of racist attacks; for employing a person who is disqualified from that work by reason of their immigration status in the UK;
- for unlawful gambling; and for the sale or storage of smuggled tobacco and alcohol.

Further guidance is offered at S. 11.28

11.28 It is envisaged that licensing authorities, the police, the Home Office (Immigration Enforcement) and other law enforcement agencies, which are responsible authorities, will use the review procedures effectively to deter such activities and crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that revocation of the licence – even in the first instance – should be seriously considered.

29. Representations have also been received from the Immigration Enforcement team at the Home Office in respect of an illegal worker located at the premises.

On 21/07/2013 at 16:15 an Enforcement Visit was conducted to the target premises and consent was obtained from the only male employee. Target was not encountered and whereabouts not known. Subsequent checks revealed that the male was a student with no conditions to work he was arrested as a WIB. A Notice Of Potential Liability was served to the counter as the manager was in Manchester and unable to come to the premises. The premises were made secured including alarmed up by the arrested employee. He gave the managers name as Ashfaq Ahmed.

30. Enquiries are still continuing into this matter and the Home Office have been asked to provide further information to assist. New Home Office powers came into force in April 2017. A copy of the Home Office factsheet is attached at Appendix F, but in summary it sets out the following powers:

Under the measures, brought in as part of the Immigration Act 2016, immigration checks will be part of the process for applying for a licence. From today, a premises or personal licence will not be issued to anyone who does not have permission to be or work in the UK. Being granted a licence and continuing to hold it will also be reliant on complying with the UK's immigration laws.

Additionally, the Home Office will be consulted in the same way as the police before a licence is granted. If a business has any immigration offences and civil penalties, these will be considered as part of the licence application, and as a ground for making a formal request to a licensing authority for a licence to be reviewed.

31. The application today is for a full revocation of the premises licence.

Rotherham Council take the view that, having regard for all the circumstances set out in this overview statement, it is clear that the premises are not promoting the licensing Objectives as set out in the Licensing Act 2003. There is no Premises Licence Holder or Designated Premises Supervisor in place, nor any delegated authority to sell alcohol. In addition to the sales of illicit tobacco and cigarettes and the evidence of an unlawful worker employed at the premises, the sales of alcohol over the period of time Basharat RAFIQ has been assuming ownership, are all offences under S136 Licensing Act 2003, a matter which is also being considered.

32. For the reasons set out above, application is made for a full revocation of the premises licence.







## New powers to tackle illegal working in licensed premises

New powers to prevent illegal working in premises that sell alcohol or provide late night refreshment have come into force in England and Wales today.



Under the measures, brought in as part of the Immigration Act 2016, immigration checks will be part of the process for applying for a licence. From today, a premises or personal licence will not be issued to anyone who does not have permission to be or work in the UK. Being granted a licence and continuing to hold it will also be reliant on complying with the UK's immigration laws.

Additionally, the Home Office will be consulted in the same way as the police before a licence is granted. If a business has any immigration offences and civil penalties, these will be considered as part of the licence application, and as a ground for making a formal request to a licensing authority for a licence to be reviewed.

Immigration officers will also receive the same powers as licensing enforcement officers and the police to enter a premises being used to sell alcohol or late night refreshment, in order to investigate immigration offences. This will enable joint enforcement operations with licensing enforcement officers, and allow immigration officers to

enter licensed premises without a warrant where there is intelligence of illegal working taking place.

Immigration Minister Robert Goodwill said:

"Illegal working cheats the taxpayer, has a negative impact on the wages of lawful workers and allows rogue employers to undercut legitimate businesses.

"These new measures will allow us to work more effectively with licensing authorities and the police to prevent illegal working in a high risk sector and take the action needed against businesses flouting immigration laws."

Today's licensed premises provisions form part of a wider package of measures in the Immigration Act 2016 to tackle illegal working, which is a key driver of illegal migration to the UK, and often leads to exploitation. They follow similar changes to the licensing regime for private hire vehicles and taxis which were introduced in December.

About 60% of all civil penalties for illegal working served in the UK in the year to February 2017 were issued in the retail, hotel, restaurant and leisure industry sectors, many of which hold licences.

The Home Office continues to work with the hospitality sector, amongst others, to provide support and guidance on how to carry out right to work checks and to raise awareness of the risks of illegal working.

The new measures which come into force in England and Wales today will be followed later this year in Northern Ireland and Scotland.
