

**DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER
WILDLIFE AND COUNTRYSIDE ACT 1981**

**ROTHERHAM BOROUGH COUNCIL
PUBLIC FOOTPATH NO.S 12, 13, 14, 15 AND 16 IN THE PARISH OF
WICKERSLEY**

DEFINITIVE MAP MODIFICATION ORDER 2019

This Order is also made under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("The 1981 Act") because it appears to the Council that the Wickersley Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(iii) of the 1981 Act, namely, (as authorised by this order) a new right of way has been created over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path. The Creation of Public Footpath No.'s 12, 13, 14, 15 and 16 in the Parish of Wickersley.

The Council has agreed to pay any legal fees which become payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

BY THIS ORDER:

1. The public rights of way over the land situate at Wickersley and shown by bold broken lines on the map contained in this Order ("The Map") and described in Part 1 of the Schedule below shall be created after 42 days from the date of confirmation of this Order, and thereupon the Wickersley definitive map shall be modified by adding to it those public rights of way.
2. "The Public" shall have the following rights over the land referred to in paragraph 1, namely, a public right of way on foot.
3. The Wickersley definitive statement shall be modified as described in part 3 of the Schedule below.
5. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in part 2 of the Schedule below.

Description of site of new path or way

Wickersley Public Footpath No 12

Footpath commencing from its junction with Wickersley Footpath No 1 at Grid Reference SK 4666 9130 and shown as point A on the Order Map, and proceeding in a southerly direction for a distance of 155 metres then in an easterly direction for a distance of 143 metres, then continuing in a generally north easterly direction for a distance of 901 metres to its junction with Wickersley Footpath No 5 at Grid Reference SK 4735 9153 and shown as point C on the Order Map.

Wickersley Footpath No 13

Footpath commencing from its junction with Wickersley Footpath No 12 at Grid Reference SK 4679 9115 and shown as point B on the Order Map and proceeding in a north easterly direction for a distance of 208 metres to its junction with Wickersley Footpath No 1 at Grid Reference SK 4687 9133 and shown as point D on the Order Map.

Wickersley Footpath No 14

Footpath commencing from its junction with Gillott Lane at Grid Reference SK 4748 9091 and shown as point E on the Order Map and proceeding in a southerly direction for a distance of 120 metres then in a south westerly direction for a distance of 233 metres, then in a generally north westerly direction for a distance of 648 metres to its junction with Wickersley Footpath No 12 at Grid Reference SK 4690 9115 and shown as point G on the Order Map.

Wickersley Footpath No 15

Footpath commencing from its junction with Wickersley Footpath No 14 at Grid Reference SK 4726 9069 and shown as point H on the Order Map and proceeding in a generally northerly direction for a distance of 657 metres to its junction with Wickersley Footpath No 12 at Grid Reference SK 4721 9131 and shown as point J on the Order Map.

Wickersley Footpath No 16

Footpath commencing from its junction with Wickersley Footpath No 15 at Grid Reference SK 4721 9128 and shown as point I on the Order Map and proceeding in a south westerly direction for a distance of 269 metres to its junction with Wickersley Footpath No 14 at Grid Reference SK 4704 9109 and shown as point F on the Order Map.

Wickersley Footpath No 13

Footpath commencing from its junction with Wickersley Footpath No 12 and proceeding in a north easterly direction to its junction with Wickersley Footpath No 1.

Wickersley Footpath No 14

Footpath commencing from its junction with Gillott Lane and proceeding in a southerly direction then in a south westerly direction, then in a generally north westerly direction to its junction with Wickersley Footpath No 12.

Wickersley Footpath No 15

Footpath commencing from its junction with Wickersley Footpath No 14 and proceeding in a generally northerly direction to its junction with Wickersley Footpath No 12.

Wickersley Footpath No 16

Footpath commencing from its junction with Wickersley Footpath No 15 and proceeding in a south westerly direction to its junction with Wickersley Footpath No 14.
