# Flag Protocol – Flying of Royal Air Forces Standard at Rotherham Town Hall

#### 1. Background

- 1.1 The Council adopted a flag protocol in May 2017 which established two principles governing the decision making process for the flying of flags at Riverside House and Rotherham Town Hall:
  - (a) That the Council will follow the advice of the relevant Government department in respect of the dates upon and the manner in which flags are to be flown.
  - (b) That the requests for support for a cause or campaign, which by implication will include the flying of a flag, will require a decision by Members at a meeting of the Council.

# 2. Key Issues

- 2.1 A request has been received from the Rotherham and District Royal Air Forces Association to fly the RAF Standard from Rotherham Town Hall from Monday 9 September to Monday 16 September 2019. The request has been made to commemorate the Battle of Britain in 1940.
- 2.2 The request falls outside of the agreed Flag Protocol adopted by the authority in May 2017. The Chief Executive has delegated authority to determine such requests, in consultation with the Leader of the Council.

# 3. Options considered and recommended proposal

3.1 It is recommended that the RAF Standard be flown from Rotherham Town Hall from Monday 9 September to Monday 16 September 2019, Battle of Britain Week.
