15/20	<p>Matters Arising from the Minutes of the last meeting held on the 28th February 2020</p> <p>The minutes were accepted as a true record.</p>	
16/20	<p>Central Government Town Deal Update</p> <p>Many people working on the towns fund for BEIS and MHCLG, have been pulled into the Covid19 rapid response work. This means that it’s likely that the publication of guidance will slip to at least the end of April.</p> <p>Coherent “recovery” plans are being developed which will be put in place following the current response phase. We might now want to see Towns Fund in that context too – but perhaps not exclusively so. The feeling is that Ministers still want to see Town Deals as a means of sustaining a strategic focus on the needs of places in the longer term – but there might now be different things that emerge in the coming weeks that Towns will want to address over the next 6 months to a year, , to tackle the impact of the pandemic Therefore, an understanding of how Covid is already changing perspectives and possible priorities when the lockdown ends needs to feed into the work on the Investment Plan.</p>
