Disabled people can continue to park on the no waiting at any time restrictions and within residents' only parking zones up to a maximum stay of 3 hours if they display a valid blue badge.

Traffic Regulation Orders are made pursuant to the Road Traffic Regulation Act 1984. A statutory procedure is followed which includes advertising the proposal in the local newspaper, on street notices and writing a consultation letter to affected residents. This gives residents including affected groups the opportunity to make comment or object to the proposal.
