Proposed implementation of Waiting Restrictions – Munsbrough Rise and St. Mary's View, Greasbrough, Rotherham

I write to inform you that the Council as Highway Authority proposes to promote 'No Waiting At Any Time' restrictions (double yellow lines), on Munsbrough Rise and St. Mary's View to address inappropriate parking in the area. Additionally, a No Waiting restriction (single yellow line) operating Monday to Friday between the hours of 7.30pm and 5.00pm is also proposed on Munsbrough Rise between St. Mary's View and the existing Zebra crossing zig-zag markings, opposite the Wagon Road junction.

The scheme has been developed following a suggestion made by your local Councillors to the Councils Local Neighbourhood Road Safety Scheme Fund which has been set up in Rotherham to address community concerns. In this case the road, particularly at school times, are frequently subject to indiscriminate parking which when coupled with the sweeping bend has resulted in several damage only collisions and potential obstruction to emergency vehicles. Parking displaced from Munsbrough Rise because of this proposal is likely to migrate to St. Mary's View, therefore, to keep the junction clear and assist in visibility for emerging traffic waiting restrictions are also included here.

The proposed waiting restrictions are shown on the attached Drawing Number No: 122/21637/HT/6

The Traffic Regulation Order for these restrictions will be advertised by Notice in the local press and on site. Objections to the proposed Order and other representations relating to it can be sent to the undersigned (quoting reference NF/TBC) at the address shown below and must be received by the undersigned no later than the DATE HERE. All objections and other representations must be made in writing and all objections must specify the grounds on which they are made.
