Yes - The report details a scheme to extend waiting restrictions on Munsbrough Rise & St Marys View, Greasbrough. This requires consultations through the standard Traffic Regulation Order procedures. The introduction of this proposal is likely to provide improved safety conditions for all when traffic travels along the road without obstruction. This will have a positive benefit for pedestrian users and those with mobility issues will still be able to park for limited periods by displaying a blue badge. The consultation will ensure that the scheme will be designed to meet the individual requirements of different people and different communities, considering barriers in relation to protected characteristics.
