By promoting people's independence and helping people to remain at home for as long as possible, the Rothercare service will have an unknown impact on some sources of greenhouse gas emissions. For example, if more people stay healthy and well at home, then there may be increased greenhouse gas emissions from transport and domestic energy use, across the Borough of Rotherham: with a corresponding decrease in greenhouse gas emissions, from energy use from care home provision. There will be some unavoidable short-term emissions associated with the replacement programme including emissions associated with transport, materials used to create the new devices and waste. Contractors will be managed through the contract management process to ensure these emissions are minimised where feasible.
