Revocation of Air Quality Management Area (Wortley Road and Fitzwilliam Road Hourly Mean Only) because air quality has improved and national air quality objectives have not been exceeded for over three years. A legal process to revoke the legal orders will take place in accordance with Section 83(2) of the Environment

Act 1995 which provides that whereupon review of any designated area, it appears that the air quality standards or objectives are being met and it is anticipated that compliance will be maintained, the Council is able to revoke the order making the designation.
