Summary

A decision exercising a function delegated to the Assistant Director, Community Safety and Street Scene is sought in respect of the approval of the Council's Parking Service commencing:

- The clamping and impounding of vehicles that are not registered with the DVLA after a vehicle has received its third penalty charge notice (PCN).
- The clamping and impounding of foreign vehicles after a vehicle has received its third penalty charge notice (PCN).

Recommendations

That the Council's Parking Service takes appropriate action when either foreign or unregistered vehicles are served with a third PCN. This would represent a change in policy as the current policy is for all vehicles to be subject to clamping and impounding after a fourth PCN has been issued.

1. Recommendation

1.1 That the Council's Parking Service takes appropriate action when either foreign or unregistered vehicles are served with a third PCN. This would represent a change in policy as the current policy is for all vehicles to be subject to clamping and impounding after a fourth PCN has been issued.

2. Background

- 2.1 Vehicles belonging to persistent evaders have been subject to clamping / impounding by Rotherham Council since 2016.
- 2.2 The current policy is for vehicles to be clamped then impounded after a fourth unpaid / unchallenged PCN has been issued.
- 2.3 PCNs issued to foreign vehicles are routinely written off as they cannot be registered at the DVLA therefore there is no pint in the Council incurring the cost of an enquiry to the DVLA for the details of the registered keeper.
- 2.4 Enquiries to the DVLA for the registered keepers of some vehicles result in responses indicating that the vehicle has no registered keeper.

3. Key Issues

- 3.1 The Council is currently issuing four PCNs to each of the above category of vehicle prior to clamping and impounding.
- 3.2 This is an additional cost to the Council and an increase in debt to the owner of the vehicle if the vehicle is released after full payment of the outstanding debt.
- 3.3 By reducing the threshold for clamping and impounding vehicles from 4 PCNs to 3, the Council will still be complying with the requirements of the Traffic Management Act 2004.

4. Options considered and recommended proposal

4.1 Do nothing

This would result in the existing parking enforcement activities continuing thereby wasting resources.

4.2 **RECOMMENDED PROPOSAL** Reduce the threshold for clamping and impounding vehicles from 4 PCNs to 3

This would result in unregistered and foreign vehicles being clamped and impounded earlier thereby reducing the required resources and reducing the debt owed by the owner of the vehicle if payment is made for its release.

5.1 The Cabinet Member for Jobs and the Local Economy has been consulted and supports the proposal.

6. Timetable and Accountability for Implementing this Decision

- 6.1 The new procedure can be implemented immediately upon approval.
- 6.2 The Parking Services Manager will be accountable for implementing the policy.
