Yes - The report details a scheme to introduce a lower 20mph speed limit in Maltby Model Village including traffic calming on Morrell Street. Consultations have been carried in the area with the speed limit reduction being done through the standard TRO procedure. The introduction of a lower speed limit, associated traffic calming is likely to provide improved safety conditions for all when traffic travels through the scheme area at a lower speed.
