Addition of three new Regionally Important Geological Sites (RIGS) to the series of RIGS in the borough following site assessment against published criteria and endorsement from the Local Geological Sites Panel. RIGS are a local planning designation that recognises the geological interest of a site.

Rotherham's Local Geological Sites System form part of Rotherham's 'Local Site system' and are included in the Non-Statutorily Protected Sites designation shown on the Local Plan Policies Map (adopted June 2018). Rotherham's Local Geological Sites including RIGS identifies sites of geological interest. Regionally Important Geological Sites have been protected for many years from the Unitary Development Plan to the current adopted Rotherham Local Plan.

The Local Sites system is intended to be comprehensive and allows for the inclusion of new sites and changes to existing sites throughout the plan period. As a result of evidence and analysis, new information has become available prompting an update to the existing series. During 2023 and 2024, three new sites were proposed by the Local Geological Sites Panel as candidate RIGS. The data for each site was then assessed against the published local RIGS selection criteria (see

https://www.rotherham.gov.uk/downloads/file/402/regionally-important-geological-site-methodology-selection-and-boundary-update-2010-document).

The assessment confirmed that the sites demonstrated substantive geological interest by meeting at least one of the selection criteria and the Local Geological Sites Panel has endorsed the sites' selection which is based upon the agreed, published criteria. It is now proposed that the three sites are added to the existing RIGS series. Designation of sites would be taken in accordance with the Delegation Scheme as set out in the Council's Constitution.

The landowners have been contacted as regards this proposed designation, with the only

comments being received from Network Rail. Their comments have been reflected in the report and they did not object to the designation.
