Discussion Items

56/09/24 Public & Patient Questions

There were no questions from members of the public.

57/09/24 Rotherham Place Estates Update

Tim Hartley gave and update on the progress and challenges for the strategic estates group including:

- Focused discussion around town centre regeneration accommodation, strategies, data sharing and member requirements
- Chamber of Commerce have joined the group, adding a further dynamic and links will also be made with the fire service going forward
- Meetings take place six times per year with varying levels of attendance, due to changes in personnel/vacancies.

CE encouraged all partners to attend the group to realise the benefits of opportunities often identified there.

TH went on to highlight progress made by each of the six workstreams ie, Collaboration, Olive Lane, SYMCA Land & Assets, Voluntary Sector, Badsley Moor Lane and Climate Change.

Noting that the new medical centre at Olive Lane, Waverley is due for completion late 2024 with occupation expected from March 2025. GL/JW will consider communications for the official opening for partners and public messaging and also contact Broom Lane Medical Centre about an official opening.

TH outlined the need for a Rotherham wide Health Strategy that will allow for service and estates planning to be aligned and proactive with roles and ways of working for key partners to ensure effective delivery and implementation of the strategy. He highlighted that the establishment of a capital pipeline for Place will be essential for development as well as a move away from organisational decision making to a partnership model so that mitigation of actions and decision is more effective.

Following discussion it was agreed that a proposal for an approach to developing a joined up Rotherham estates strategy is brought to the confidential session of Place Board in October.

As well as developing the strategy, TH outlined other key asks for partners. To ensure appropriate representation and take account of personnel changes, members were asked to reconfirm their representatives for the estates group to TH.

JBR expressed an interest in joining the group and TH agreed to invite her.

CE thanked TH for the update after which TH exited the meeting.

58/09/24 Rotherham Place Mental Health Workstream Update

CS outlined recent positive developments:

• The launch of two new services for people with severe and enduring mental health, namely mental health peer support and community connectors service

- Mobilisation of the new Rotherham safe space service as a crisis alternative now offered five evenings per week
- Completion of the crisis pathway specification, now awaiting formal sign off
- 'Transformed' community mental health services criteria has been met
- Mapping of the dementia pathway is on track to complete in Quarter 3
- Good progress is being made on the actions relating to the prevention concordat for mental health and the loneliness action plan.

There are a number of challenges and risks to delivery of the priorities including:

- System challenges to be worked through prior to sign off of the mental health needs analysis
- Eating disorder provision and resolving the medical monitoring risk,
- reducing out of area placements caused by system pressures,
- procuring a service provider for the attempted suicide prevention pilot
- providing support for smaller voluntary sector organisation to manage NHS data and meet reporting requirements.

CS advised that the majority of metrics in the long term plan were being achieved but there are challenges around the demand for talking therapies and reducing the number of out of area bed days with significant work required.

CS outlined a number of actions being taken for improvement around CMHT pathways, the dementia pathway and crisis.

CS will provide a contact for JBR about obtaining updates on eating disorder services.

Following a query from SS around whether the demographics were examined to check if those from an ethnic diverse backgrounds are accessing talking therapies and linked with suicide prevention services, BA advised that all suicides are tracked and it is found that some haven't had any contact with mental health services but have social issues.

JT advised that RDaSH has been undertaking work from a health inequalities perspective and looking at demographics to reach out better and make services more accessible.

Members agreed that, with the suicide prevention symposium in December, it would be a good time to relaunch the 'Be the One Campaign' as part of developing the action plan.

59/09/24 Rotherham Place and Wider South Yorkshire Communications and Engagement Update

GL explained that the communications and engagement group has been working on:

- The Say Yes campaign, particularly work on cancer with the community and voluntary sector
- Winter around GP and dental access, stay well and the vaccines communication plan for South Yorkshire
- The national changes to eligibility criteria on non-emergency transport
- Redevelopment of the SEND local offer website
- Updating and promoting the healthier together website
- The kindness and zero tolerance campaign following the recent riots

He highlighted that resource and capacity, both operational and strategic across place plan deliverables has been challenging due to changes in the group's membership and this has slowed momentum slightly. However, the group is now ready to reinvigorate transformation communications with new colleagues.

National media around waiting times and performance, particularly GP access and dentistry has affected public focus and perception of health services and has proved challenging to assuage.

Going forward the group will look to agree 4-5 deliverable priorities aligned with health inequalities priorities to be more targeted, whilst also continuing messages relating to system pressures and GP collective action. Due to the changing communications leads and structures across partners, the group will also undertake a review of its membership to ensure full representation.

SS enquired what assurance we are giving colleagues as a priority following the recent riots. It was noted that the zero tolerance campaign undertaken by the ICB communications team is mainly aimed at primary care colleagues across South Yorkshire. Local trusts carry out public facing communications and messaging to staff is addressed through their own host organisation.

CE thanked GL for the update. As there will be several priorities for communications and engagement colleagues to focus on across Place in the next three months including vaccinations work, winter messages and proactive care, it was agreed to schedule a discussion about the longer term comms and engagement plan for January/February 2025.
