This report sets out the calculation of the Council Tax Base for the 2025/26 financial year.

The Council Tax Base is a key part of the Council's budget setting process and is central in determining the amount of Council Tax income that will be raised, which represents a significant proportion of the Council's revenue resources for the coming financial year. The tax base is one of the elements within the MTFS. The calculation takes into account several factors including The Council's own Local Council Tax Support Scheme (CTSS), which operates as a discount on claimants'

Council Tax bills. The current scheme, applicable from the 2018/19 financial year, was approved by Council on 24th January 2018 and consultation is ongoing for proposed changes to the scheme from 2025/26
