The report presents the renewal applications for the awards of Business Rates Discretionary Relief for the 2025/26 financial year which have been considered in line with the policy agreed by Cabinet on 12 December 2016.

The policy criteria includes consideration of organisations who actively encourage membership from particular groups in the community which include, young people, women, persons with a disability and ethnic minorities.
