- 2. The Revocation Order comes into operation on the 1<sup>st</sup> day of June 2025 and the effect of the Order is to revoke the Air Quality Management Area described in the Schedule hereto with respect to the [nitrogen dioxide (annual mean)] objective as specified in the Air Quality Regulations 2010 in exercise of the powers conferred upon the Council by Section 83 of the Environment Act 1995.

## 4. THE SCHEDULE

"Rotherham Borough Council Air Quality Management Area— Wortley Road" is that area of land situate within the following boundary:

From the roundabout at the junction of Wortley Road and Wilton Gardens, follow Wilton Gardens in a southerly direction to the junction with Church Street. Follow Church Street in a generally westerly direction to the junction with High Street. Follow High Street in a north westerly direction to the junction with Old Wortley Road. Follow Old Wortley Road in a general northerly

direction to Wortley Road. Follow Great Park Road in a north easterly direction to the junction with Eilam Road. Follow Eilam Road and Eilam Close, then follow Watson Road in a south easterly direction to Bradgate Road. Follow Bradgate Road to the roundabout of Wortley Road (A629) and Wilton Gardens.
