Variation to the contract to provide accommodation and support to single homeless people to increase the provision. This service forms part of the Housing Related Support Pathway, agreed by cabinet on October 2022 and subsequently awarded to Target Housing following a competitive tender (commencing June 2024). This contract variation will allow for further units to be added.
