Public Spaces Protection Orders (PSPOs)

Consultation Plan

Introduction and Overview

PSPO's are intended to deal with a nuisance or problem in a specific area that is detrimental to the local community's quality of life, by imposing appropriate and proportionate conditions on the use of that area which apply to everyone.

The Order impacting Fitzwilliam Road and Eastwood, was renewed for 3 years in June 2022. In the consultation process leading to these renewals, support was seen in relation to varying the Orders in terms of variation of requirements and prohibitions. This consultation will look to further build on this with a view the new Order due in July 2025.

Current Fitzwilliam Road PSPO Prohibitions

- i. Consuming alcohol other than on licensed premises or at a licensed event
- ii. Behaving in such a way or using language that causes, or is likely to cause, harassment, alarm or distress to another person.
- iii. Causing noise that is likely to have a detrimental impact on a person(s) quality of life
- iv. Each relevant person must ensure that the wheelie bin(s) for their property or waste presented for collection in a manner specified for their property is not situated outside the boundary of their premises other than between 6pm on the day before collection is due, and 9pm on the day of collection unless the wheelie bin is in an identifiable bin storage area or yard for wheelie bins of their property.

- Each relevant person must ensure that the wheelie bin(s) for their property or waste presented for collection in a manner specified for their property is not situated outside the boundary of their premises other than between 6pm on the day before collection is due, and 9pm on the day of collection unless the wheelie bin is in an identifiable bin storage area or yard for wheelie bins of their property.
- Continuing to consume alcohol when required to stop doing so by any authorised officer

 Any other matter arising from Consultees responses and corroborated by Crime and ASB data held by Agencies.

Consultation Period

The consultation period will run for 4 weeks, commencing on 22 April 2025 and end on 20 May 2025. This will allow submission of a further report and amended Order(s) for Cabinet in July 2025.
