The proposals will positively benefit the development of children within the communities where they are located. Although equipment is required to 'stretch' children to help them develop it is recognised that accessibility for all children is not the same and some equipment will be provided for those children with specific accessibility needs.

The adopted Green Space Strategy sets out that all homes should ideally be within 400m (a five minute walk) of an equipped play area. It is also incumbent that these play areas should be safe, inviting, with good play value and include equipment for children and young people of varying ages and abilities.

Consultation is planned with the local communities, Ward Members, Schools, and children with Special Educational Needs and Disabilities (SEND) of the sites to be improved, ensuring all voices are heard in relation to what they would like the play offer to be.

Key findings

Negative impact

To minimise the disruption to the Borough wide play offer, the schedule of playground redevelopment will ensure that the play areas are conducted in sequence so that only one play area is unavailable at any given time. Furthermore, the works will be conducted outside of planned school holidays.

Positive impact

Equipped play areas are generally seen as having a positive impact on the development of individuals but also the development of social skills and can promote co-operation and inclusion of other users.
