Successful applications for grant awards under the family learning programme include projects aligned with 'The World Beneath Our Feet', one of four themes of the Children's Capital of Culture festival year. Proposed workshop activities across a range of applications reference the environment and outdoors education. On another level, family learning may foster understanding between generations, increasing families' and communities' resilience to climate change.

Provide a summary of all impacts and mitigation/monitoring measures:

The Family Learning Grants programme does not provide a large impact in respect of carbon emissions. Activities are to be supported within existing venues creating minimal additional energy use. These activities are relatively small in scale and therefore their impact is considered to be low, however there may be opportunities to reduce emissions by highlighting lower-carbon travel options in any promotional communications and requesting that organisers to ensure that waste is minimised and recycled where possible.
