### 2. Please provide a brief description of what you are screening

The Council's Transportation Team is seeking approval to carry out a public and stakeholder consultation on the proposed A633 Broad Street Scheme, on the approach to Parkgate Roundabout, Rawmarsh.

This engagement is a key step in ensuring the final design is inclusive, evidence-based, and aligned with local needs and expectations. Consulting with affected communities, interest groups, and stakeholders is recognised as best practice and will help shape a more informed and responsive outcome.

Public consultation is planned to start in January 2026 with estimated timeframe for construction to start in mid-2026.

- **How have you considered equality and diversity?**

This report seeks approval to initiate public and stakeholder consultation on the Council's A633 Broad Street Scheme.

An in-depth review of those likely to be affected by these proposals has been undertaken to ensure the consultation reaches a wide audience. An offer will also be made for officers within the Council's Transportation Team to meet stakeholders in-person if they so require, to discuss the proposals and gather any feedback. All feedback on the scheme design will be taken into account to ensure that any negative impacts are mitigated appropriately and will be monitored throughout the project.

While initial consideration has been given to the potential equality impacts of the scheme and intended consultation process, specific effects will be more clearly understood following the engagement exercise.

In line with RMBC policy, an Equality Analysis (Part B) will be completed prior to construction approximately in May to reflect any additional equality or diversity issues identified during consultation.

- **Key findings**

The consultation aims to gather insights from individuals, community groups, and stakeholders who may experience barriers related to the proposed A633 Broad Street Scheme, particularly in relation to equality, diversity, and inclusion.

It will be designed to be fully accessible and inclusive, and promoted through a range of channels to ensure broad participation. These include drop-in events, direct communications (emails and letters), ward newsletters, and updates on the Council's website.

Both local and national data highlight existing inequalities in transport need to be considered during project development. These disparities may contribute to, or result from, current traffic and transport conditions.

The headline inequalities identified include

- Children, young people and the elderly are overrepresented amongst road traffic casualties relative to their population size;
- Wheelchair and mobility scooter users express notably worse satisfaction with provision of safe and level crossing points, and obstruction of footways, than others;
- Men are overrepresented amongst road traffic casualties relative to the average;
- Access to cars is lower amongst people of non-White ethnicity, and amongst lower income households;
- People without access to cars travel significantly less far despite spending similar (but slightly lesser) amounts of time travelling compared to the average. They are also more dependent on non-motorised travel, and especially buses, for their mobility.

In light of these headlines, the following initial findings are made:

- Introduction of a pedestrian crossing to replace the existing central traffic island can be expected to advance equality of opportunity for those amongst children and young people, the elderly, people with disabilities and those without access to cars.

- **Actions**

The consultation will be designed to include voices from individuals and groups with protected characteristics, as well as others who may be affected by the proposals. This inclusive approach aims to uncover and address any inequalities that may not yet be visible or well-documented, supporting a more informed and equitable decision-making process.

The process will be open and transparent, encouraging all participants to share their views freely and honestly.

To ensure accessibility and meaningful participation, the consultation will:

- Be inclusive of language needs, digital access limitations, and mobility challenges;
- Allow sufficient time for individuals and groups to respond;
- Present information clearly, using plain English and avoiding jargon;
- Use tailored methods to engage different groups, such as young people, minority communities, and individuals with visual impairments.
