Given the timeframe of the current review being undertaken by government, which is expected to conclude in Autumn 2026, as this may result in the enactment of the early 2027 break clause it may be a premature/ineffective use of resources to progress detailed work prior to this time. As such, OSMB members agreed that the interim approach would be to refer the matter to JHOSC in the first instance, to ask them consider progressing the issue at regional level if the government's decision is not to enact the early 2027 break clause. If the break clause is not enacted and JHOSC elect not to address the issue this through its formal work programme, OSMB members agreed that at this stage, the matter would be referred into HSC to scope and address accordingly. Resultantly, full scoping and scoring was not progressed at this time, as this would be for HSC to undertake at the relevant stage.
