# Q16. HACKNEY CARRIAGE/ PRIVATE HIRE DRIVERS' LICENCES - APPLICATIONS

The Board considered reports by the Director of Housing and Neighbourhood Services relating to applications for the grant of hackney carriage/ private hire drivers' licences from Messrs. S.A.Y., N.R., M.B.W., A.K., M.A.S.(2) and G.M.

Messrs. S.A.Y., N.R., M.B.W., A.K., M.A.S.(2) and G.M. attended the meeting and were interviewed by the Board.

Resolved:- (1) That the application from Mr. G.M. be refused.

(2) That Messrs. M.B.W and N.R. be granted a licence for a period of 12 months subject to the satisfactory completion of the Driving Standards Agency test and medical.

(3) That Mr. S.A.Y. be granted a licence for a period of three years subject to the satisfactory completion of the medical.

(4) That Messrs. A.K. and M.A.S.(2) be granted a licence for a period of three years subject to the satisfactory completion of the Driving Standards Agency test and medical.

Councillor Barron, Vice-Chair, assumed the Chair for this item.)
