## 5. Summary

On the 19<sup>th</sup> March 2012 the Cabinet Member Meeting approved the Council's Local Flood Risk Management Strategy Project Brief.

The Council's Draft Local Flood Risk Management Strategy for Rotherham has been prepared in accordance with the requirements of the Flood Risk Regulations 2009 and the Floods and Water Management Act 2010. The aim of the Strategy is to develop, maintain, apply, monitor and publish the Final Local Flood Risk Management Strategy.

It is also proposed that Rotherham's Final Local Flood Risk Management Strategy will be completed by the end of December 2013 where it will provide a framework to deliver a prioritised programme of works and initiatives to manage flood risk in the area.

#### 6. Recommendations

It is resolved that:

- 6.1 Cabinet Member approve the Draft Local Flood Risk Management Strategy for Rotherham (refer to Appendix A).
- 6.2 Cabinet Member approves the issue of the Draft Local Flood Risk Management Strategy for Rotherham to Partners, Stakeholders and Communities for consultation and later publishing for public information.
- 6.3 the contents of the Final Local Flood Risk Management Strategy for Rotherham be developed and reviewed by the end of February 2014.

### 7. Proposals and Details

The Flood Risk Regulations 2009 implement the requirements of the European Floods Directive, which aims to provide a consistent approach to managing flood risk across Europe. The regulations impose new duties on the Council as the Lead Local Flood Authority (LLFA) for Rotherham, including the responsibility for managing local flood risk in particular from ordinary watercourses, surface runoff and groundwater.

Under the requirements of the Flood Risk Regulations 2009 and the Floods and Water Management Act 2010, the Council's new roles and responsibilities are as follows:

- Duty to produce a local flood risk management strategy for the Rotherham area.
- Ability to work with other risk management authority regarding flood risk.
- Duty to exercise and carry out works in accordance with the national flood and coastal erosion risk management strategy and relevant local flood risk management strategies.
- Strategic leadership and partnership between lead local flood authorities and other risk management authorities.
- Duty to co-operate and provide information with other risk management authorities.
- Power to carry out works to manage flood risk from surface runoff or groundwater.
- Power to arrange for a flood risk management function to be transferred to another risk management authority.
- Power to request information from other key agencies and landowners in connection with its flood management functions.
- Duty to act as the co-ordinator for the investigation of flood incidents and publish the results on the Councils website.
- Duty to establish and maintain a register of drainage assets/ features and a register
  of structures/features which it considers are likely to have a significant effect on local
  flood risk.
- Power to designate features or structures that affect flood risk which places legal responsibilities on the owner of the asset to manage.
- Power to formally consent and/or approve works within Ordinary Watercourses which includes all temporary and permanent works.
- Duty to promote and manage Sustainable Drainage.
- Duty to establish a Sustainable Urban Drainage Approval Body (SAB), which will
  have the power to approve, supervise, adopt and maintain Sustainable Urban
  Drainage Systems, and how surface water is managed on new development sites.
- Duty to contribute towards the achievement of sustainable development.

The Flood and Water Management Act requires the Council to ensure that adequate scrutiny arrangements are put in place to review, scrutinise and approve the Council's Draft Local Flood Risk Management Strategy for Rotherham (Strategy). The Strategy was presented to the Council's Overview and Scrutiny Management Committee on the 8<sup>th</sup> February 2013 where it was recommended that the Strategy be forwarded onto the Cabinet Member for approval.

The Strategy will be reviewed and scrutinised on a six yearly cycle as a minimum. The Strategy will also be subject to a consultation process, which will be forwarded onto Partners, Stakeholders and various Communities for comment.

The Strategy is a 'living' document and it is a duty of the Council to update and amend the Strategy year on year, for example changes in legislation, actual data following a major flood event, new asset data, resource and funding opportunities etc.

#### 8. Finance

In January 2011 the Government's Environment Secretary Caroline Spelman, confirmed that in 2011/2012, grants for the sum of £21 million rising to £36 million for 2012/2013 and subsequent years, would be made available to help Councils protect and support their own community when managing flood risk. In addition the funding will fully support Lead Local Flood Authorities in developing local flood risk management strategies, surface water management plans, priority actions, mapping, and administering consents for private changes to ordinary watercourses.

Defra allocated £120.2K in 2011/2012 to Rotherham which enabled the Council to carry out its new duties under the Floods and Water Management Act 2010. A further £156.3K was allocated to the Council in 2012/2013 and Defra has indicated that further funding will be provided in 2013/2014 to enable the Council to continue its duties under the Act.

Defra has announced that the funding allocated to Lead Local Flood Authorities should be in addition to the funding provided by Defra through the Formula Grant funding or similar, for Flood and Coastal Erosion Risk Management within the Environmental, Protection and Cultural Services.

Please note any requirements for additional revenue funding are not reflected in the current medium term financial strategy.

#### 9. Risks and Uncertainties

Under the Flood and Water Management Act 2010, the Council as the Lead Local Flood Authority for Rotherham, is committed to carry out its new roles and duties for local flood risk management, including surface water overland flows throughout the Borough. It is likely that there will be additional pressures on the Council's resources to carry out it's duties as the Lead Local Flood Authority.

The Government funding provided is part of the £2.1 billion the Government expects to spend on flood and coastal erosion risk management by 2015. Local Authorities also receive funding under Formula Grants or similar arrangements administered by Communities and Local Government. The Government expects all Local Authorities to spend about £100million on flood and coastal erosion risk management. The grants provided by Defra for Rotherham will be required to fulfil the Council's duties under the Act.

There is some uncertainty that future funding will be provided by Defra after 2015, this could apply additional pressures on the Council to obtain future funding to fulfil its roles and responsibilities under the Act and to continue with its duties in keeping the Local Flood Risk Management Strategy updated.
