### **5. Summary**

This report provides the Health Select Commission with an update progress on the delivery to date, summarising achievements and changes that have taken place. It also reports on future agenda items and potential themes going forward into 2014/15.

## **7. Proposals and Details**

The work programme for 2013/14 was agreed at the OSMB meeting on the 28 June 2013. Two additional items were subsequently added to the original work programme during the year – Childhood Obesity and Support for Carers, with Mental Health deferred as a result. The work programme is attached at Appendix A, including a column on progress. This report provides Members with an update on the progress made to date.

In summary the results so far include:

- 7 out of the 9 items on the work programme have been completed.
- 1 out of the 9 items is at early stage
- 1 out of the 9 items was removed from the work programme
- Extra meeting held with single agenda item – update from Rotherham Foundation Trust on their plans
- The Select Commission has completed two full reviews this year, in line with its target set by OSMB at the beginning of the year, plus a mini-review.

The update reports requested by Members have been scheduled as above before the Summer recess and the scrutiny review of continence services should be completed by the recess. Members should consider further items which could be considered as part of the work programme for 2014/15.

By way of an update, the other Select Commissions are also looking at their forward planning for 2014/15. The Improving Places Select Commission are focusing predominantly on one theme for the year – the local economy following from their current review, and the Improving Lives Select Commission programme is likely to be focused around the theme of Safeguarding. It has also been suggested that the theme of DWP work and other programmes will be the focus for OSMB. Health Select Commission may well therefore wish to consider whether its work programme could be focused around such a theme and whether that should be Mental Health and Wellbeing in line with its main review.
