3.0 Technical

3.1 Bolton Road

The majority of the construction works is now substantially complete and Balfour Beatty have now handed over their principal contractor role to Border Environmental. The emphasis has changed from pure construction over to process equipment installation. Balfour Beatty are continuing with final fit and snagging of the various buildings and infrastructure.

A2A (formally Ecodeco)

A2A are now firmly established on site and the following works have been completed:

- Installation of 6 overhead cranes in the bio drying halls
- Construction and first fill of the bio filer and bio filter media
- Installation of bio drying fans and associated pipe-work
- Installation of shredder bridge, associated electrical work and infrastructure
- Installation of refinement feed conveyors, hoppers, trammels and further refinement processing equipment and conveyors

JCBE (Dry AD plant)

Work on the dry AD plant is progressing to plan; the following works have been completed:

- Installation of fermenter doors, pipe work and gas analysers
- Installation and dry commissioning of the CHP engine
- Installation of the gas bag above the fermenters
- Installation and fist fill with LECA of the bio filter
- Extraction equipment and associated pipe work and cleaning equipment.

The standby boiler has been commissioned and is in use slowly raising the temperature of the under floor and wall heating. Commissioning is planned for a November 2014 start.

Meetings have been held with both the EA and State vets with regard to future compliance, Shanks are reviewing documents following their input and providing quality and process maps to both.

Recruitment

AD plant and engineering recruitment nearing completion.

Event planned in Wath library for 17/09/14, which will comprise of an all day presence where individuals can come along and learn more about the project and type of roles available.

Recent and future publicity will be via:-

- Local job centres
- Adverts in Barnsley chronicle, Doncaster free press, Rotherham Advertiser and Sheffield star.
- Adverts placed with local large firms closing down e.g. Maltby and Knottingley collieries.
- Ex-service job boards, covering Army, Navy and RAF.

3.2 Ferrybridge

Progress on Site

The civils works are now nearing completion and cold commissioning is expected to begin in Q4 of 2014.

Recruitment

Financial Controller and Plant Chemist started in their roles as of June 2014. 10 more operational staff (including Shift and Day Team Leaders, Mechanical Engineer, EC&I Engineer and Planner) started on 1 September 2014.

Ferrybridge 2

Multifuel Energy Ltd is seeking permission to build a second Multifuel Power Station (known as FM2) on the Ferrybridge site. The Planning Application has now been submitted and the Planning Inspectorate (PINS) who are responsible for recommending a decision on the application, have now accepted it for examination

4.0 Legal

There have been changes in the Legal representation from both Barnsley and Rotherham, a briefing session is to be set up in October when all new Legal Officers are in place.

5.0 Financial

The Operational Management costs are predicted to be within budget for 2014/15.

6.0 Communications

A recruitment event is to be held on 17 September 2014 at Wath Library, relating to further more general roles at the new facility.

A bid has been submitted to WRAP for funding for a communication campaign to maintain or increase recycling. This will tie into the community liaison work undertaken by the Shanks CELO.

7.0 Resources

The review of the Joint Waste Team for the operational phase of the project is to be considered by Steering Committee.

9.0 Other

Work is underway to reschedule rounds across the three Council areas ready for delivery of commissioning waste to the plant early next year.

Incidents

During the last few weeks, there have been two external incidents worthy of note

- 1. A fire at Ferrybridge power station, which delayed the build of the new facility that BDR will be using by only half a day. The fire was in the current generating part of the facility and we await the feedback from SSE on the cause.
- A fire at Shanks ELWA MBT facility occurred in late August. Shanks are still investigating the root cause of the fire and it is still too early to speculate. Emergency plans worked well with no injuries to personnel being sustained.
