<u>Summary of Consultation on proposals to create additional capacity at Aston Academy</u>

Proposal to add additional capacity at Aston Academy

The Local Authority is proposing to add additional capacity to the school building to create new teaching and learning space for September 2021 onwards. The capacity at the school will increase from a total classroom space for 1,650 pupils to a total classroom space for 1,800 pupils. The extension of the building will support the Principal and Governing Body to accommodate the current and expected future pupil population at the school.

The school is currently oversubscribed and this trend is set to continue in future academic years. Following the expansions of two Primary phase feeder schools in the Aston learning community and the ongoing development of housing at Waverley, this will mean the increased capacity at the school will allow the Principal and Governing Body to plan for future years intakes of pupils with the assurance that there is sufficient space to deliver the schools' curriculum.

The proposal is subject to a successful planning application and should the proposal then move forward, Officers from the Council working with the Principal and Governing Body would outline to all stakeholders detailed plans for the school and the implications of the building work on site in relation to health and safety and how this would be managed during the development project.

This letter gives stakeholders an opportunity to comment on the proposals prior to any report being submitted to Council Cabinet.

With regards to the application for Aston Academy I would like to make a few points.

Before the extension is considered will the existing school be refurbished?

The school is in desperate need of refurbishing with tape over threadbare carpets, peeling and badly painted walls and doors and the whole school looking in a poor state of repair and condition.

The corridors and stairwells are too narrow for the current level of pupils causing bottlenecks at peak times and increasing the pupils will only further exasperate the situation.

Aston Academy also accepts applicants from several schools outside of their catchment area .If they are indeed oversubscribed then that should be down to other authorities to manage. Any available money should be used to upgrade the existing facility.
