#### **Attendance Dispensation under Section 85 of the Local Government Act** 1972

#### 1. Background

- 1.1 Section 85 (1) of the Local Government Act 1972 states that "if a member of a Local Authority fails, throughout a period of six consecutive months from the date of their last attendance, to attend any meeting of the Authority they will, unless the failure was due to some good reason approved by the Authority before the expiry of that period, cease to be a member of the Authority." Attendance can be at any committee or sub-committee, or any joint committee, joint board or other body where the functions of the Authority are discharged or who were appointed to advise the Authority on any matter relating to the discharge of their functions. This requirement can be waived and the time limit extended if any failure to attend was due to a reason approved by the Authority, in advance of the six month period expiring.
- 1.2 Councillor Lindsay Pitchley represents the Holderness ward and in addition to Council is a serving member of the Improving Lives Select Commission, Standards and Ethics Committee and Transportation Advisory Board. Due to illness and on-going recovery, Councillor Pitchley has been prevented from undertaking normal duties. Councillor Pitchley has not been able to attend any Council or committee meetings since the Improving Lives Select Commission on 6 November 2018.

#### 2. Key Issues

2.1 A formal request has therefore been made for a dispensation to be granted until the end of the calendar year on the grounds that Councillor Pitchley's non-attendance throughout the period has been due to ill-health and ongoing recovery. Council can only consider such a request where approval is given in relation to the reasons for non-attendance before the end of the relevant six month period, which will be on 6 May 2019, which is before the next Council meeting on 17 May 2019.

#### 3. Options considered and recommended proposal

- 3.1 Should any councillor lose office, through failure to attend for the six month period, the disqualification cannot be overcome by the councillor subsequently resuming attendance nor can retrospective approval of the Council be sought for an extension in time. If the Council decided not to approve an extension and as Councillor Pitchley would be unable to attend another meeting, a casual vacancy would arise.
- 3.2 Under the circumstances, it is requested that Council waive the attendance requirement Councillor Pitchley until the end of the calendar year. It also recommended that the Council's best wishes be conveyed to Councillor Pitchley for a speedy recovery.

#### 4. Timetable and Accountability for Implementing this Decision

4.1 If minded to approve the request the extension of time will be effective until the end of the calendar year from the date of this meeting. This would not of course prevent Councillor Pitchley from returning to meetings at any time if her health improves sufficiently.

#### 5. Financial and Procurement Advice and Implications

- 5.1 If the recommendations are approved, Councillor Pitchley will continue to receive the basic allowance which all councillors are entitled to receive. As this is budgeted for, there are no financial implications arising from the recommendations within this report.
