The main impact in terms of equality and diversity will be in terms of the employment of staff through TUPE processes and the identification and consideration of any potential adjustments that may need to be made.

Whilst there are limited public users of the service, e.g. taxi drivers for MOTs, the practical delivery of the service is not proposed to change significantly as part of this proposal. IT will result in the same staff (through TUPE) undertaking the same work, at the current location (Hellaby Depot). Only the means of delivery will change.
