2. Please provide a brief description of what you are screening

The Government announced two new funding packages during October designed to help households struggling to recover from the impacts of the COVID pandemic. The two funds are Household Support Grant, provided by the Department for Work and Pensions (DWP) and Funding for Vulnerable Renters, provided by the Department for Levelling up, Housing and Communities (DLUHC).

The funding must be used in the current financial year.

The report provides an overview of the funding and eligible uses, together with
recommendations for delivery of support to Rotherham residents.

• How have you considered equality and diversity?

Owing to the limited timescale between Government announcement of the of the funding streams, knowledge of tackling the COVID pandemic to date including support to low income households from earlier grants streams has been used to inform the proposed uses of the grant funding now available.

Key findings

The groups of some protected characteristics including BAME have been shown to be disproportionally affected by the impacts of COVID. National research suggests that the health impacts have been disproportional. It is also, at least anecdotally the case that those groups who are in the lowest income brackets have also been disproportionally affected by socio economic impacts.

Actions

Equalities data will be collected as part of delivering the proposed support packages. This will be monitored at review stages. An equality analysis will be completed on the basis of the data collected to inform delivery of the funding streams and at the end of the funding period. It is not possible to complete a full EA ahead of delivering the grant funded support
