Members welcomed the data as presented and the confidence this provided in the Enforcement Team.

The Planning Enforcement Manager in response to questions confirmed that the Service were reliant on complaints being made by the public, but explained the timeframe for enforcement action had, since the 25th April, 2024, been extended from four years to ten years.

Any issues where there were concerns about ongoing and delayed development could be referred to the Service for investigation.
